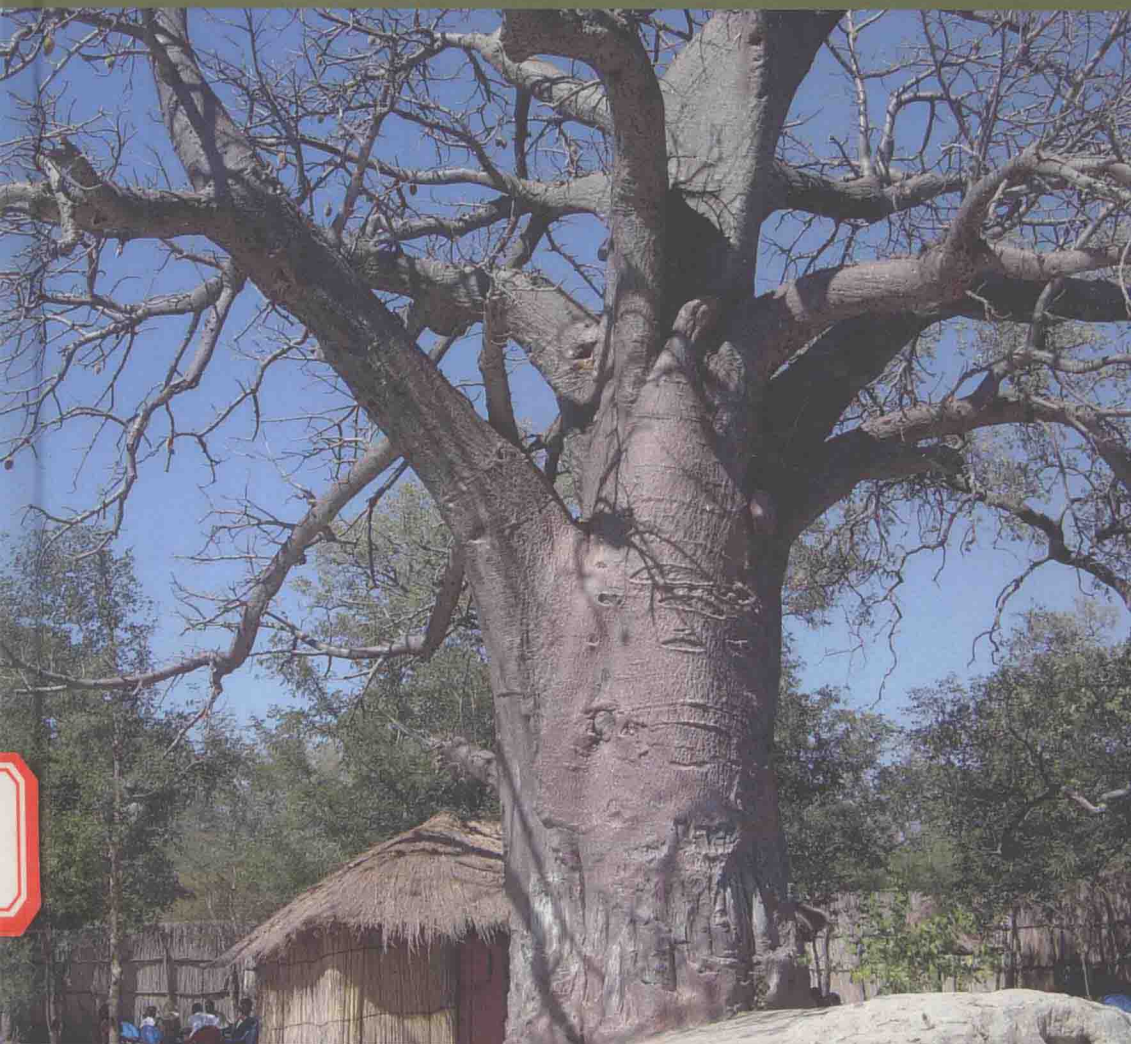

# Contributors

**Krister Andersson** is Associate Professor of Political Science at the University of Colorado at Boulder. He studies the politics of environmental governance in developing countries. Most of Andersson's recent work explores subnational variation in local governance outcomes in Latin America, including his latest book, *Local Governments and Rural Development* (University of Arizona Press, 2009), co-authored with Gustavo Gordillo and Frank van Laerhoven. The work is a comparative analysis of institutional conditions for public service performance in 390 local governments in the rural areas of Brazil, Chile, Mexico and Peru. Andersson obtained a PhD in Public Policy from Indiana University under Elinor Ostrom.

**Jennifer Arnold** is Program Director for the Puyallup Watershed Initiative in Washington, USA. With this long-term, place-based initiative, she facilitates collaborative problem-solving and capacity building among local leaders to support watershed restoration and stewardship. Previously, she has worked on sustainable ranching issues with diverse cultural groups in the US and Mexico. He has extensive experience in Central and South America, the Caribbean, southern Africa and has also worked in countries such as Albania and Moldova. Barnes has a PhD from the University of Wisconsin, Madison.

**Wendy-Lin Bartels** is Assistant Research Scientist with University of Florida's Department of Agricultural and Biological Engineering. An anthropologist, she contributes to a multi-disciplinary team of researchers within the Florida Climate Institute and the Southeast Climate Consortium. Her research examines climate-learning communities that convene multiple stakeholder groups to discuss climate change and identify adaptation options. Her work explores how participatory methods and interactive engagement processes facilitate knowledge exchange, dialogue and learning among these diverse stakeholder groups. Bartels has a PhD in interdisciplinary ecology with a concentration in tropical conservation and development, a MS in communication, and BS in botany and molecular genetics.

**Tyler A. Beeton** is a master's candidate in the Department of Anthropology at Colorado State University.
