## PREFACE

THE purpose of this book is to provide for practitioners a general review of the law of agricultural holdings in Scotland together with a collection of the principal statutory materials. I have tried to refer to all relevant authorities on problems which are commonly encountered in practice; but I have not attempted a comprehensive citation of authority on matters of general principle which are dealt with in the standard textbooks.

It is a pleasure to acknowledge my debt to my friend and former colleague Mr. A. G. M. Duncan, W.S., the well-known lecturer and writer on agricultural law, who first engaged my interest in the subject. Most of the views which I have to offer in this book derive from the advice which he has unstintingly given me over the years. Mr. Duncan read the entire manuscript and greatly improved it.

My thanks are due to Mr. J. Gordon Reid, advocate, who prepared the Index; to Mr. Mark Lawson, solicitor, who revised the proofs and to Miss Iris Stewart, the publishers' general manager, who directed the design and preparation of the book.

I have tried to state the law as at September 1, 1982, but only the briefest references could be added during the proof stage to a number of cases reported shortly before that date.
