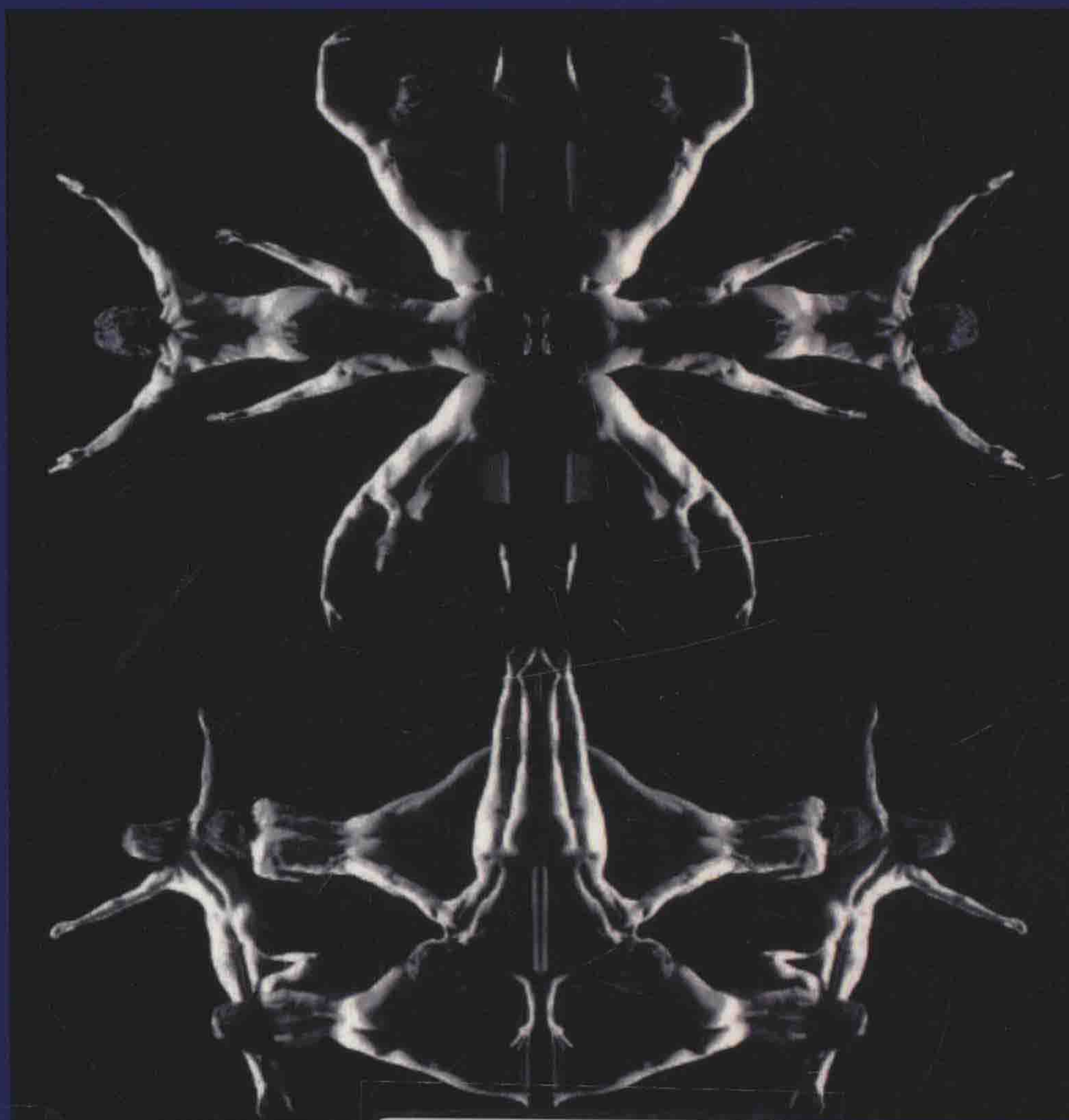

Contributors

John P. Bartkowski is Associate Professor of Sociology at Mississippi State University. Much of his research examines the relationship between religious involvement, social inequality, gender, and sexuality. His most recent published works include the book *Remaking the Godly Marriage: Gender Negotiation in Evangelical Families* (2001), along with articles in journals such as *Social Forces*, *Sociological Quarterly*, and *Gender & Society*.

Evelyn Blackwood is Associate Professor of Anthropology and Women's Studies at Purdue University. She is co-editor with Saskia E. Wieringa of *Female Desires: Same-Sex Relations and Transgender Practices Across Cultures* (1999) and editor of *The Many Faces of Homosexuality: Anthropology and Homosexual Behavior* (1986).

Lionel Cantú is an Assistant Professor of Sociology (with affiliations in Latin American and Latino Studies and Women's Studies) at the University of California, Santa Cruz. His research interests include international migration, HIV/AIDS, Latino/a Studies, Feminist Studies and Queer Theory. The essay in this volume is drawn from his dissertation research, *Border Crossings: Mexican Men and the Sexuality of Migration*, which examines how sexuality influences migratory processes among Mexican men in the United States and Mexico.

Wendy Chapkis is an Associate Professor of Women's Studies and Sociology at the University of Southern Maine. She is the author of many articles and two books on gender and sexuality, including "Power and Control in the Commercial Sex Trade," in *Sex For Sale* (2000), *Live Sex Acts: Women Performing Erotic Labor* (1997), and *Beauty*

Secrets: Women and the Politics of Appearance (1986).

Patricia Hill Collins is Charles Phelps Taft Professor and Head of the African American Studies department at the University of Cincinnati. She is the author of *Fighting Words: Black Women and the Search for Justice* (1998) and *Black Feminist Thought: Knowledge, Consciousness, and the Politics of Empowerment* (2000).

Julia O'Connell Davidson is Professor of Sociology at the University of Nottingham. She has been researching prostitution, sex tourism, and child sexual exploitation in various parts of the world since 1993. She is the author of *Prostitution Power and Freedom* (1998).

Dorothy Dinnerstein, now deceased, is the author of *The Mermaid and the Minotaur: Sexual Arrangements and Human Malaise* (1999).

Meenakshi Gigi Durham is an Associate Professor in the School of Journalism and Mass Communication at the University of Iowa. She has published widely in the area of feminist media studies, with a focus on representations of the female body in the media and issues of adolescent gender and sexuality. She is the co-editor, with Douglas M. Kellner, of the anthology *Media and Cultural Studies: KeyWorks* (2000).

Steven Epstein is an Associate Professor at the University of California, San Diego, where he teaches classes on the sociology of science, medical sociology, sexuality, LGBT studies, social movements, and social theory. His book, *Impure Science: AIDS, Activism, and the Politics of Knowledge*

(1996) analyzes the "politics of credibility" in scientific debates about AIDS and emphasizes the roles played by laypeople in these debates.

Susan Faludi is a Pulitzer Prize winning journalist. She is the author of *Backlash: The Undeclared War against American Women* (1992) and *Stiffed: The Betrayal of the American Man* (1999).

Anne Fausto-Sterling is Professor of Biology and Women's Studies at Brown University. She is the author of *Myths of Gender: Biological Theories About Women and Men* (1992) and *Sexing the Body: Gender Politics and the Construction of Sexuality* (2000).

John H. Gagnon is Distinguished Professor of Sociology Emeritus at the State University at Stony Brook. He is the author or co-author of several articles and books, including *The Social Organization of Sexuality* (1994) and *Sex in America* (1994). In addition he has been the co-editor of a number of books, most recently *Conceiving Sexuality* (1995) and *Encounters with AIDS: Gay Men and Lesbians Confront the AIDS Epidemic* (1997). He is now an Associate at the HIV Center for Behavioral and Clinical Research, Columbia University and the New York State Psychiatric Institute and lives in New York City.

Joshua Gamson is Associate Professor of Sociology at Yale University, author of *Freaks Talk Back: Tabloid Talk Shows and Sexual Nonconformity* (1998), *Claims to Fame: Celebrity in Contemporary America* (1994), and a participating author of *Ethnography Unbound: Power and Resistance in the Modern Metropolis* (1991). His work on social movements, media and culture, and sexuality has been published in *Social Problems*, *Gender & Society*, *Sexualities*, the *Journal of the History of Sexuality*, *Critical Studies in Mass Communication*, and elsewhere, and he has written about television, popular culture, and lesbian and gay

politics for *The Nation*, *The American Prospect*, *Tikkun*, *The Utne Reader*, and *The New Yorker*.

Anthony Giddens has been the Director of the London School of Economics and Political Science since 1997. Previously he was a Fellow and Professor of Sociology at King's College, Cambridge. He is the author of 35 books, published in 29 languages, and numerous articles and reviews. His most recent book is *The Global Third Way Debate* (2001).

Patti A. Giuffre is an Assistant Professor of Sociology at Southwest Texas State University. Her research interests include sexuality in organizations and sexual harassment. Her most recent publication in *Gender & Society* regarded sexuality in relationships between healthcare professionals and their patients.

Lynn Jamieson teaches sociology at Edinburgh University and is the author of *Intimacy: Personal Life and Social Change* (1998).

Elaine Bell Kaplan is Associate Professor of Sociology at the University of Southern California. Her book "Not Our Kind of Girl": *Unraveling the Myths of Black Teenage Motherhood* (1997) won the 2000 Distinguished Contribution to Scholarship Book Award from the Race, Gender and Class Section of the American Sociological Association. She has published various articles on adolescent issues using a gender, race, and class perspective, including "It's Going Good: Inner-City Black and Latino Adolescents' Perceptions About Achieving An Education" (1999) and "Using Food as a Metaphor for Care: Middle-School Kids Talk about Family, School, and Class Relationships" (2000).

Debra Renee Kaufman is the Director of Jewish Studies, a Matthews Distinguished Professor, and Professor of Sociology at

Northeastern University. She was the former coordinator and founder of the Women's Studies Program there as well. Her published articles and chapters range widely across feminist and gender issues both in the family and in the workplace. Her books and edited volumes include *Achievement and Women* (with Barbara Richardson, 1981), *Public/Private Spheres: Women Past and Present* (1989), and *Rachel's Daughters: Newly Orthodox Jewish Women* (1991).

Gina Kolata is a science reporter for *The New York Times* and the author of *Flu: The Story of the Great Influenza Pandemic of 1918 and the Search for the Virus that Caused It* (1999) and *Clone: The Road to Dolly, and the Path Ahead* (1999).

Roger N. Lancaster is Director of Cultural Studies at George Mason University. His previous books include *Life is Hard: Machismo, Danger, and the Intimacy of Power in Nicaragua* (1994), which won the C. Wright Mills Award and the Ruth Benedict Prize. He edited (with Micaela di Leonardo) *The Gender/Sexuality Reader: Culture, History, Political Economy* (1997).

Edward O. Laumann is the George Herbert Mead Distinguished Service Professor in the Department of Sociology and the College at the University of Chicago, Chairman of the Department of Sociology, and Director of the Ogburn Stouffer Center for Population and Social Organization. His research interests include social stratification, the sociology of the professions, occupations and formal organizations, social network analysis, the analysis of elite groups and national policy making, and the sociology of human sexuality. He has written twelve books and numerous articles. Three volumes on human sexuality were published in the fall of 1994: *The Social Organization of Sexuality*, *Sex in America*, and *Sex, Love and Health in America*.

Lauraine Leblanc is the author of *Pretty in Punk: Girls' Gender Resistance in a Boys' Subculture* (1999). In addition, she has published on the topics of media representations of deviance, women in cyberpunk fiction, and teaching research methods. She is the coordinator of the Quebec Public Interest Research Group at McGill University.

Meika Loe is a doctoral student in sociology and women's studies at the University of California, Santa Barbara. Her research exploring the intersections of gender, sexuality, culture, and consumption has been published in *Gender & Society*, *Sociological Inquiry*, and *Berkeley Journal of Sociology*.

Zella Luria is a Professor of Psychiatry at Tufts University. She is the author of *The Psychology of Human Sexuality* (1978).

Catharine A. MacKinnon is the author of *Feminism Unmodified: Discourses on Life and Law* (1988), *Toward a Feminist Theory of the State* (1989), and *Only Words* (1993).

Karin A. Martin is an Assistant Professor of Sociology and Women's Studies at the University of Michigan, Ann Arbor. Her research on gender, bodies, and sexuality has appeared in *Gender & Society* and the *American Sociological Review*.

Chet Meeks is a graduate student at the State University of New York, Albany. He is working on a dissertation on the sexual politics of normalization and antinormalization.

Fatima Mernissi is a Moroccan feminist writer and the author of *Beyond the Veil: Male-Female Dynamics in a Modern Muslim Society* (1987), *The Veil and the Male Elite: A Feminist Interpretation of Women's Rights in Islam* (1992), *Dreams of Trespass: Tales of a Harem Girlhood* (1995), and *Women and Islam* (1998).

Michael A. Messner is Associate Professor of Sociology and Gender Studies at the University of Southern California, where he teaches courses on sex and gender, men and masculinities, sexuality, and gender and sport. His most recent books are *Politics of Masculinities: Men in Movements* and *Masculinities, Gender Relations and Sport*.

Robert T. Michael is the Eliakim Hastings Moore Distinguished Service Professor in the Irving B. Harris Graduate School of Public Policy Studies at the University of Chicago. He is the co-author of *Sex in America: A Definitive Survey* (1994) and *The Social Organization of Sexuality* (1994).

clude *In the Name of the Family: Rethinking Family Values in the Postmodern Age* (1996) and *Brave New Families: Stories of Domestic Upheaval in Late Twentieth Century America* (1998). She is a founding board member of the Council on Contemporary Families, a group committed to public education about research on family diversity.

Jacqueline Sanchez Taylor is Lecturer in Sociology at the University of Warwick, UK. She has been involved in research on sex tourism for six years, and is particularly concerned with theoretical and empirical questions about sexual-economic exchanges between local men and tourist women in tourist resorts in the Caribbean.

Barrie Thorne is Professor of Sociology and Women's Studies at the University of California, Berkeley, where she is also Co-Director of the Center for Working Families. She is the author of *Gender Play: Girls and Boys in School* (1993) and co-editor of *Feminist Sociology: Life Histories of a Movement* (1997) and *Rethinking the Family: Some Feminist Questions* (1992).

Francie Traschen is a graduate student at the State University of New York, Albany. She is working in the area of social movements.

R. Stephen Warner is Professor of Sociology at the University of Illinois. His research centers on the significance of increasing religious diversity in the United States, including the religious institutions of post-1965 immigrants. He is co-editor, with Judith G. Wittner, of *Gatherings in Diaspora: Religious Communities and the New Immigration* (1998) and, with Ho-Youn Kwon and Kwang Chung Kim, of *Korean Americans and Their Religions: Pilgrims and Missionaries From a Different Shore* (2001). He currently directs the Youth and Religion project at the University of Illinois at Chicago.

Kath Weston is Director of Studies in Women's Studies at Harvard University and a member of the National Writers Union. A sociocultural anthropologist, she is the author of *Families We Choose* (1991), *Render Me, Gender Me* (1996), and *Long Slow Burn: Sexuality and Social Science* (1998). Her research focuses on political

economy, ideology, and kinship, with an emphasis on how gender and race articulate with sexuality and class under conditions of globalization.
