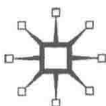

François Grin is Full Professor of Economics at the Faculty of Translation and Interpreting of the University of Geneva. His research focuses on language economics and language policy evaluation, with a strong interdisciplinary orientation. He is the author of numerous publications in these areas, including *The Economics of the Multilingual Workplace* (2010, with C. Sfreddo and F. Vaillancourt). He has worked as a consultant or advisor on language policy issues for national or regional authorities, as well as for international organizations. He has supervised several large-scale research projects on various aspects of language policy, and is currently the coordinator of the MIME (Mobility and Inclusion in Multilingual Europe) project financed by the European Commission.

Mark Leikin is a professor in the Departments of Special Education and Learning Disabilities at the University of Haifa. He is the Director of the Research Laboratory for Neurocognitive Examination of Giftedness and editor of the journal *Issues in Special Education and Inclusion*. Andrew D. M. Smith is Lecturer in Language Studies at the University of Stirling. He holds a PhD in language evolution from the University of Edinburgh. His main research interests are in evolutionary and cognitive linguistics, focusing in particular on grammaticalization, the inferential socio-cultural and cognitive bases of communication, metaphor, cultural evolution and word learning mechanisms. His most recent book is the edited collection *New Directions in Grammaticalization Research* (2015, with Graeme Trousdale and Richard Wälchli).

Selma K. Sonntag is a professor in the Department of Politics at Humboldt State University, California, and Chair of the Research Committee on the Politics of Language (RC50) of the International Political Science Association. Susanne Tietze is Professor of Management at Keele Management School, Keele University, UK. José-Ramón Uriarte is Professor of Economics at the University of the Basque Country. He is the Director of the Bilbao Laboratory of Experimental Analysis

(Bilbao LABEAN). His research interests are in minority language economics, modelling bounded rationality, experimental and behavioural economics. His work has appeared in *Advances in Complex Systems*, *Mathematical Social Sciences*, *Social Choice and Welfare*, *Journal of Risk and Uncertainty*, *Journal of Evolutionary Economics*, *JEBO*, *Review of Economic Design* and *Theory and Decisions*, among other journals.

Bruno van Pottelsberghe de la Potterie is Dean of the Solvay Brussels School of Economics and Management (SBS-EM) at the Université Libre de Bruxelles. He is Full Professor and, as holder of the Solvay S.A. Chair of Innovation, he teaches courses on the economics and management of innovation and intellectual property. He was Chief Economist of the European Patent Office (EPO) from 2005 to 2007. He has been advisor to the President and Rector of the ULB for technology transfer issues since 2004 and is a non-resident research fellow at Bruegel, a Brussels-based think tank, since 2007. His research focuses on patent systems, the valuation of patents and the role of IPRs. He served as the Chairman of the Department of Economics at SMU, the Research Director of CORE at the Catholic University of Louvain, Belgium, and the Academic Director of the International School of Economics, Tbilisi, Georgia. He served as a member of the Executive Committee of the Board of Directors of GDN (Global Development Network) and of the International Advisory Board of EERC (Economic Education Research Consortium). His interests focus on documentation, measurement and impact of societal diversity and social interactions in heterogeneous societies. He is the co-author of *How Many Languages Do We Need? Economics of Linguistic Diversity* (2011, with Victor Ginsburgh). He also co-edited *The Oxford Handbook of the Russian Economy* (2013, with Michael Alexeev).

Bengt-Arne Wickström was Professor of Public Economics at Universität zu Berlin from 1992 until his retirement in 2013. He holds a PhD from the State University of New York at Stony Brook and held positions at Northwestern University, the Norwegian School of Economics and Business Administration (NHH), the University of Bergen, and Johannes-Kepler-Universität Linz. Since his retirement he has been Herder Professor at Andrásy-Universität Budapest. He has published in the field of public economics with special reference to public-choice theory, welfare economics and economic theories of justice. Lately, his work has been concentrated on various aspects of language economics.

Sue Wright is a research professor in the Centre for European and International Studies Research at the University of Portsmouth. She is the author of several books on the political context of language spread, including *Community and Communication* (2000) and *Language Policy and Language Planning* (2004). She is co-editor (with Helen Kelly Holmes) of the Palgrave book series *Language and Globalisation* and co-editor (with Ulrich Ammon and Jeroen Darquennes) of the journal *Sociolinguistica*.
