PREFACE

This book is concerned with the relationship between two major areas of law: human rights and private international law. Private international lawyers, with some notable exceptions, have shown only a limited awareness of human rights and can be accused of often not taking human rights seriously. Human rights lawyers have also been remiss in failing to take seriously the private international law dimension in a case. The aim of the book has been to produce the first comprehensive account of this relationship from an English law perspective. The book is designed for practitioners and academics, both those with a background in private international law and those with a background in human rights, and our treatment of the subject reflects this.

The idea for the book came from an article by James Fawcett entitled ‘The Impact of Article 6 of the European Convention on Human Rights on Private International Law’, published in the *International and Comparative Law Quarterly* in 2007. It became apparent whilst working on this that other human rights have had an impact on private international law. There was also much more to be said about the right to a fair trial. Moreover, the concept of human rights needed to go beyond the ECHR. It was becoming increasingly apparent that fundamental rights under the EU Charter of Fundamental Rights were having an ever greater impact on private international law. This in turn raised complex questions on the relationship between human rights under the ECHR and those under the Charter. For the private international lawyer the question arose of when the rights under the Charter would apply.

One theme of the book then is the impact of human rights on private international law; not only what this impact of human rights has been but also what it should be. Human rights concerns need to be identified and solutions suggested. Equally important is the even more neglected question of the impact of private international law on human rights law. In recent years this question has become more pertinent as the European Court of Human Rights has had to wrestle with the relationship between human rights and private international law. We are still awaiting the judgment of the Grand Chamber in *Avotinš v Latvia*,¹ which will hopefully cast light on the extent to which human rights law should defer to private international law, at least where the source of the latter is EU legislation.

Each of us brought specific expertise to this book. Whilst each of us took primary responsibility for certain chapters, the book is very much a joint effort. James Fawcett took primary responsibility for chapters 4 to 10 and 16. Máire Ní Shúilleabháin took primary responsibility for chapters 11 to 15 and Sangeeta Shah for chapters 1 to 3. Sangeeta Shah also guided the drafting of the section in each chapter where the relevant human rights law is set out in detail. Chapters also contain a section examining the application of human rights law to private international law issues. This section, which was the most difficult aspect to write, was co-written by either James Fawcett or Máire Ní Shúilleabháin, paired with Sangeeta Shah, following extensive discussion. Sangeeta Shah was also heavily involved in

the discussion of the impact of private international law on human rights law. More generally, we read and commented upon each other's work. Each of us benefitted enormously from the suggestions of our co-authors.

Thanks are due to others.
