Carmelo V. Sison is a Professor of Law in the University of the Philippines College of Law and was Director of the Institute of Government and Law Reform of the University of the Philippines Law Center from December 1995 to November 2007. He graduated with a Bachelor of Laws degree from the University of the Philippines in 1963, passed the Bar in 1964, and obtained a Master of Laws from the University of Michigan in 1983.

He joined the University of the Philippines Law Center as Law Researcher in 1967 and was appointed to the faculty of the University of the Philippines College of Law in 1970. He retired upon reaching 65 years but was extended up to age 70. At present he is Professorial Lecturer teaching Torts and Damages and Legal Theory. While in the Law Center, he contributed to several projects namely: the Revised Administrative Code projects in 1973 and 1987; Constitutional Revision projects in 1969–1970; and in 1986; Criminal Law Reform project; Law and Population Project. He served for a period as Editor of *Philippine Permanent and General Statutes*.

His published works include a Survey of Philippine Law and Jurisprudence, Legal and Judicial Ethics (1967, 1972); Survey of Human Relations: Torts And Damages (1990–2008); 'Law on Public Officers' in the Philippine Law Journal; Law and Population (monograph); Philippine Political Law in two (2) volumes, co-authored with Professor Perfecto V. Fernandez ; Law and Population in the Philippines, published in the Fletcher School of Law and Diplomacy, Book Series No. 9 (1974); Vital Registration System of the Philippines; Philippine Law on Torts (1986); Handbook on the Philippine Law of Damages. He has also written articles for the Integrated Bar Of The Philippines Journal, and authored the Civil Code Reader (2002), primer on Consumer Law, and Essentials of the 1987 Constitution for the public-at-large.
