FOREWORD

The extraordinary success of the *Social Worker's Desk Reference*, edited by Albert R. Roberts and Gilbert J. Greene, as well as the enormity of contextual change and scientific advancement since its publication in 2001, speaks to the need for this much-anticipated second edition. The first edition was a major contribution to the profession of social work. Its breadth, purposeful focus on social work interventions, conciseness, readability, and overall usability have made it a favorite of social work practitioners, educators, and students as well as other professionals who form the core of interdisciplinary practice and research.

The *Social Worker's Desk Reference*, second edition, is a well calibrated and thoughtfully inclusive enhancement of the first edition. Its 171 chapters continue with utmost attention to detail the first edition's mission of disseminating straightforward and appropriately nuanced texts written by the foremost experts in the social work profession to capture the complexity of social work practice. It brings to the users the most recent conceptual knowledge and empirical evidence to aid their understanding of social work practice and to guide social work interventions in a vast array of settings from the individual clinical level to community-based empowerment and advocacy.

The articles in total focus on the compelling practice issues of the early twenty-first century. Social work today is driven by a long list of changes: the greater complexity and speed of global human interaction, the struggle of populations for scarce resources of food and energy, worldwide political and economic transactions, rapid advances in the social and behavioral sciences, the far-reaching effects of new discoveries in human biology and neuroscience, and technological advances in the diagnosis and treatment of disease. The enormity of these advances is compounded, and not always

positively, by our sometimes underdeveloped organizational structures and our need for an ever increasing level of knowledge and organizational sophistication as we meet the challenges of this century.

The *Social Worker's Desk Reference* is a fundamental tool that offers innumerable benefits to the profession of social work as we address the old and seemingly intractable, as well as the new and immensely complex issues of our day.

This edition of the *Social Worker's Desk Reference*, is not only a major contribution to the field, it also represents the vision and scholarly dedication of its editor-in-chief, the late Albert R. Roberts. Those of us who have had the honor and the privilege to know and work with him welcome this, his final work, as a tribute to his long-standing energy and vibrancy, his integrity, and his extraordinary commitment to social work. There are few among us for whom we have such respect and admiration. In many ways the publication of this book is a bittersweet acceptance of reality and stands as a monument to the courage and vision of Roberts.

With an acquaintance that spanned more than 25 years, Roberts and I shared many thoughtful conversations and some academic frustrations. We enjoyed sporadic communication about many professional issues until I worked abroad from 1993–2003. For the social work profession, Al's death leaves a gaping hole in our reality. His achievements, however, will speak to and for the profession for years to come. Each time the *Social Worker's Desk Reference* is taken off a shelf and opened, we will be reminded of Al and his compelling and fastidious attention to detail and substance. In what may have been Al's last e-mail, written on June 13, 2008, he wrote about another matter we had been discussing and said, "I did my best." Look-

ing back to that message, it was certainly prophetic and actually characterized everything that Al did and his approach to his work and life. Al, you will be missed. Thank you for this volume and your contributions.

EDITOR-IN-CHIEF

The late ALBERT R. ROBERTS, Ph.D., D.A.C.F.E., was Professor of Social Work and Criminal Justice, and Director of Faculty and Curriculum Development in the Faculty of Arts and Sciences at Rutgers, the State University of New Jersey in Piscataway. He was a college professor for 35 years. Dr. Roberts received an M.A. degree in Sociology from the Graduate Faculty of Long Island University in 1967, and a doctorate in social work from the School of Social Work and Community Planning at the University of Maryland in Baltimore in 1978. Dr. Roberts was the founding Editor-in-Chief of the Brief Treatment and Crisis Intervention journal and the Victims and Offenders journal. He was a member of The Board of Scientific and Professional Advisors and a Board-Certified Expert in Traumatic Stress for The American Academy of Experts in Traumatic Stress, and a Diplomate of the American College of Forensic Examiners. Dr. Roberts authored, co-authored, or edited approximately 250 scholarly publications, including numerous peer-reviewed journal articles and book chapters, and 38 books. A few of his books were the Handbook of Domestic Violence Intervention Strategies (Oxford University Press, 2002), Crisis Intervention Handbook: Assessment, Treatment and Research, 3rd edition (Oxford University Press 2005), Juvenile Justice Sourcebook (Oxford University Press, 2004), Evidence-Based Practice Manual: Research and Outcome Measures in Health and Human Services (co-edited with Kenneth R. Yeager, Oxford University Press, 2004), and Ending Intimate Abuse (co-authored with Beverly Schenkman Roberts, Oxford University Press, 2005). Dr. Roberts was also the editor of three book series: the Springer Series on Social Work, the Springer Series on Family Violence and the

Greenwood/Praeger Series on Social and Psychological Issues. Dr. Roberts was the recipient of many awards for his teaching and his scholarly publications.

Prior to his death in the summer of 2008, Dr. Roberts was in the midst of many projects, including his courses on Crisis Intervention, Domestic Violence, Introduction to Criminal Justice, Research Methods, Program Evaluation, Victimology and Victim Assistance, and Juvenile Justice at Rutgers University; training crisis intervention workers, crisis counselors, and clinical supervisors in crisis assessment and crisis intervention strategies; and training police officers and administrators in domestic violence policies and crisis intervention. He was a lifetime member of the Academy of Criminal Justice Sciences (ACJS), a fellow of the American Orthopsychiatric Association, a member of the Council on Social Work Education and the National Association of Social Workers (NASW) since 1974, and was listed in Who's Who in America from 1992 forward.

PAULA ALLEN-MEARES, PhD, is the Chancellor of the University of Illinois at Chicago. Previously she served as the Dean, Norma Radin Collegiate Professor of Social Work, and Professor of Education at the University of Michigan. Her research interests include the tasks and functions of social workers employed in educational settings; psychopathology in children, adolescents, and families; adolescent sexuality; premature parenthood; and various aspects of social work practice.
