## PREFACE

When in 1976 the problem of a second edition of Sykes and Glasbeek on Labour Law in Australia was considered, it was taken for granted that the two sections of the work would be published at the same time though not necessarily under the same cover. Unfortunately Professor Glasbeek took up a permanent position in a Canadian University and eventually was obliged to relinquish his part of the project. After some delay Professor D Yerbury of the Australian Graduate School of Management agreed to prepare the material for the second part of the work, viz that dealing with the collective aspects of labour law. Unfortunately her preparation has been delayed and the second part of the work cannot be produced at the moment. It is thought that the part contributed by Professor Sykes should be delayed no longer and it is now being published as a separate volume whilst Professor Yerbury's part will appear as soon as possible. The short title of the work will be "Sykes and Yerbury, *Labour Law in Australia*", with Professor Sykes contributing Volume I on the individual aspects of the Australian system and Professor Yerbury contributing Volume II on the collective aspects.

One of the criticisms relating to the original work by Sykes and Glasbeek which has drifted back to the writer of this Preface concerns the long chapter on workers' compensation. The criticism, which it is believed came from a Western Australian source, was to the effect that the inclusion of the treatment of so many statutory systems made that chapter "unreadable". With all due respect such criticism makes no allowance whatever for practicalities and is basically unrealistic.

There are three possible ways in which to deal with workers' compensation in a work on general labour law:

(1) Omit the topic altogether. However, although it looks to the question of making good the bad effects of a social evil instead of endeavouring to prevent the occurrence of that evil, it still instances an important legislative trend and constitutes a topic which engages the attention of quite a numerous band of legal practitioners and union officials. Its omission therefore seems undesirable.

(2) Limit treatment to one of the state statutes, which in terms of practical realities would mean either New South Wales or Victoria. This is in fact what is done in the books published in Australia which deal with workers' compensation as a sole topic. However it would be odd for a work which purports to deal with labour law in general over the whole Australian spectrum suddenly to narrow in compass to one jurisdiction when it comes to workmen's compensation provisions. In any event why should the outlying states and the territories be entirely ignored? Even treatment of, say, two jurisdictions would not answer the problem.

(3) Encompass all the systems, endeavour to find the common pattern, and then indicate important differences in specific jurisdictions without going too far into the detail surrounding the particular jurisdiction.

This last was the method preferred in the original work and followed in the present production. Obviously there is a common pattern, for instance in the "course of employment" doctrine and the provisions regarding protected journeys. Important departures from the general pattern can then be presented. The danger is that one may be drawn too far into cataloguing the *minutiae* appertaining to one particular system; one may even make minor errors concerning such details and this is possible with respect to a jurisdiction like the Australian Capital Territory where the legislation is difficult to piece together, and to a lesser extent the Northern Territory.

However the author is aware of these traps and has endeavoured to guard against them. The third alternative with all its possible drawbacks seems to be preferable to the other two. The author is somewhat heartened by the fact that when discussing the "unreadable" comment with a colleague, the latter replied in a short phrase which signifies "Nonsense" but is somewhat shorter and is also unprintable.

The other criticism that one has heard is that the original work dealt too much with and relied too much on the "control" test in relation to the question of the nature of the employer-employee relationship. It did indeed deal with it in some detail but not entirely uncritically. It has become standard practice in recent years for writers to attack the control test but this is a fate to be expected of any common law doctrine which has stood for a long time. Age is no guarantee of sanctity. However the fact that the doctrine has been observed, at least nominally, by the courts for a long time does not mean that it necessarily lacks all virtues. An assessment of its virtues and defects and its general standing now and in the foreseeable future is therefore attempted at greater depth in the present work than in the original book. It seems that this is worthwhile if only by reason of the general non-viability of the alternative tests which have been proposed. Thus, take the most attractive-looking of these, viz, that the question is whether the person alleged to be an employee is part of the organizational structure of the undertaking. If a large company engaged a firm of solicitors on a yearly retainer basis but the firm remained free to accept legal work for third parties, it is probable that the solicitors would be "part of the organization" especially if their offices were in the same building, but would the partners be employees of the company for workers' compensation or vicarious liability purposes? It is the occurrence of this kind of shortcoming in alternative characterizations which seems to tend to make courts veer back to the superficially firmer ground of the older test.

The author wishes to confess to one error. In paragraphs [1402] and [1403] of Chapter 14 he appears to have made contradictory statements regarding under-21 student dependants in Western Australia. The position is that since the amending Act of 1970 such children are not only included but given a distinct entitlement: see [1409].

With regard to the abbreviations in respect of workers' compensation statutes, those who are curious as to the abbreviation "CAGA" applied to the Commonwealth Act relating to federal public service employees, are informed that this represented the significant letters in the title of the Act when Mr Whitlam was Prime Minister and as it sounds much more euphonious than anything that can be constructed from the present title of the Act, it has been retained.
