Dr Andreas Vossler is Director of the Foundation Degree in Counselling and Senior Lecturer in Psychology at the Open University. He is also a systemic trained couple and family psychotherapist. His current research activities focus on therapeutic work with couples and families, infidelity, internet infidelity, and counselling and psychotherapy. Andreas is co-editor of the *Counselling and Psychotherapy Research Handbook* (2014) and *Understanding Counselling and Psychotherapy* (2010; both Sage). He has authored three textbooks and published 17 book chapters and 20 articles in peer-reviewed papers on topics related to counselling and psychotherapy (family therapy, infidelity, online counselling, health psychology, psychiatry) and research methods. Andreas is on the editorial board of *Counselling Psychology Quarterly* and *Forum Community-Psychology*.

Dr Catriona Havard is a Senior Lecturer at the Open University. She has investigated how accurate people are at recognising faces, in the forensic context of eyewitness identification from line-ups. The aim of her research is to make eyewitness evidence more reliable, especially for children and older adult (over 60 years) witnesses, and to reduce misidentifications that could lead to wrongful convictions.

Dr Meg-John Barker is a Senior Lecturer in Psychology at the Open University and a UKCP accredited psychotherapist. Meg-John has published many academic books and papers on topics including mindfulness, relationships, sexuality and gender, as well as co-editing the journal *Psychology & Sexuality*. Professor Graham Pike is an academic with interests in forensic psychology, critical criminology and applied cognition, whose research focuses on issues of evidence and harm within the criminal justice system. He is Professor of Forensic Cognition at the Open University, Deputy Director of the Harm and Evidence Research Collaborative and Associate Director for the National Centre for Policing Research and Professional Development. His research has led to changes in the PACE Codes of Practice, numerous guidelines for policing practice and also development of the VIPER identification system and E-FIT software. Dr Bianca Raabe is an academic with interests in Social, Developmental and Counselling Psychology, whose research interests have focused on young people's constructions of citizenship and identity, and is currently interested in 'wild' therapy, and therapy in open spaces. In maintaining her therapeutic practice Bianca is involved in both short-term (three session counselling) and long-term psychotherapy. She is a Staff Tutor based in the North East of England, at the Open University, Gateshead. In her role as a Staff Tutor she has particular interest in collaborative teaching and learning and working with complex group dynamics.

Joanne H. Alexander is a psychology graduate researcher at the University of Northampton. Professor Jane E.M. Callaghan is a psychologist at the University of Northampton, where she leads the Centre for Family Life and undertakes applied psychology research. Her specialist interests include violence in the family, child and adolescent mental health, as well as gender and identity, and professionalism.

Dr Troy Cooper is a Senior Lecturer in Psychology at the Open University. Her first research was in eating disorders and addiction to alcohol and illegal drugs, and her first job was at the Addictions Research Unit (now National Addictions Centre) at the Institute of Psychiatry in London. Troy began a career at the Open University in the mid-1990s tutoring, teaching and writing on psychology modules, and developed research interests in online learning, the place of reflection in learning, and student well-being and success. Recently she gained a DipHE in Childhood and Adolescent counselling, and has worked with bereaved children. Dr Emily Glorney is a Senior Lecturer in Forensic Psychology at Royal Holloway, University of London, where she is the Programme Director for the MSc Forensic Psychology. She is also a Chartered and Registered Forensic Psychologist with extensive experience in the assessment and treatment of offenders in forensic mental health and prison settings. Emily's applied research interests focus on the mental health of offenders in hospitals and prisons. Emily has published research on traumatic brain injury and violence among female prisoners, peer mentoring, and religion and spirituality in recovery pathways of forensic mental health service users, substance misuse and mental illness, forensic mental health service delivery, and comparison of characteristics of sexual killers. Forthcoming work focuses on mental health and risk reduction in prisons, such as self-harm among male prisoners. Emily is on the editorial board for the *Journal of Aggression, Conflict and Peace Research* and is a reviewer for several international peer-reviewed journals publishing high-quality research related to forensic psychological issues and mental health.

Mary Haley is the Head of Psychotherapy at HMP Grendon, a prison comprised entirely of democratically run therapeutic communities. She is also the Wing Therapist on one of the six communities there. She is a UKCP registered Integrative Psychotherapist whose main area of interest is Attachment Theory, particularly in its relevance to forensic patients. Prior to working in HMP Grendon, Mary worked as an individual psychotherapist as part of the Mental Health In-Reach Team at HMP Whitemoor for over 12 years and before that was a prison governor grade, holding various management roles in several prisons over a period of 17 years. These included management of residential wings, security risk assessment, management of life sentenced prisoners, working in the women's estate policy unit and design and delivery of operational and management training. She has a small private practice and has done work for TV programmes doing psychological assessments for participants in some reality TV shows.

Dr Daniel Holman is a Research Associate in the Department of Sociological Studies at the University of Sheffield. He completed his PhD in 2012 at the University of Essex under the supervision of

Professor Joan Busfield, which was entitled Social Class and the Use of Talking Treatments. He has published peer-reviewed papers and appeared on national radio, based on this research. Daniel then took up a Research Associate post at the University of Cambridge to work on a large-scale Type 2 diabetes peer support randomised controlled trial. His current post focuses on understanding the links between health inequalities, ageing and social quality, especially through the application of social policy-oriented cross-national comparative research.

Amanda O'Donovan BA, MPsy, C Clin Psych is a Consultant Clinical Psychologist and specialises in psychological medicine and clinical health psychology in areas such as HIV, sexual health and well-being, sexual assault, chronic pain and Chronic Fatigue Syndrome (CFS). With this mixed background, his career was split then between clinical and academic work as a health policy researcher. Dr Andrew Reeves is a Senior Lecturer in Counselling and Psychotherapy at the University of Chester and a Senior Accredited Counsellor/Psychotherapist at the University of Liverpool. Andrew has undertaken research into counselling and psychotherapy interventions

with people who present at risk of suicide, and who self-injure, for many years and has written extensively in this area. He worked for many years in secondary care mental health services as a social worker and therapist. He is the former Editor-in-Chief of *Counselling and Psychotherapy Research* journal.

Dr Joan A. Reid is an Assistant Professor at the University of South Florida St Petersburg and a Licensed Mental Health Counselor in the State of Florida. Brigitte Squire MBE is a Consultant Clinical Psychologist and Programme Director of the Multi-Systemic Therapy (MST) Services of Cambridgeshire County Council and Cambridgeshire and Peterborough Foundation Trust. Originally qualified in Belgium in 1981, she advanced her career in England since 1990 working for the NHS and obtained an MA in Systemic Therapy at the City of London University in collaboration with the Tavistock Clinic in 1994. For the past 14 years she has driven the commissioning and progression of MST within the Cambridgeshire and Northampton County Council and led on four

MST Adaptations for specialist client groups (serious adolescent substance abuse, child abuse and neglect, family integrated transitions and adolescent sexual problem behaviour). She was a Sector Advisor for the Department of Health for four years, assisting in setting up new similar teams in the UK. Brigitte received a Cambridge Justice Award for outstanding contribution to Cambridgeshire's Criminal Justice System in 2007 and was a finalist for a national NHS Leadership Award under the category NHS Innovator of the Year in 2009. In 2010 she was awarded an Honorary MBE for her services to Youth Justice.

Henry Strick van Linschoten is a psychotherapist in private practice, based in London. He is an attachment-based psychoanalytic psychotherapist, specialising in relationships, sexual, gender and relational diversity, trauma and dissociation. He has contributed to the online offerings of Confer UK, where he is also an Advisor, and has a strong internet presence. He has worked for three years at HMP Holloway, the high-security prison for women in London. He is a registered member of the UK Council for Psychotherapy (UKCP), a member of the European Society for Trauma and Dissociation (ESTD) and registered with Pink Therapy. In his earlier career he graduated in Development Economics, Econometrics and Statistics, and was an international businessman.

Dr Paul Taylor is Deputy Head of the Department of Social and Political Science and a Senior Lecturer in Criminology at the University of Chester, UK. Paul writes in the area of mental health and criminal justice, being the lead editor of *A Companion to Criminal Justice, Mental Health and Risk* (Policy Press, 2014). He is also currently researching and writing on topics of well-being among authorised police firearms officers, and a military veteran's experience as a victim of domestic violence and abuse.
