In 1973, he took a special examination as law attorney and counsellor-at-law. After the special examination, he has worked as counsellor-at-law. During the years 1981–1986, he was employed as an expert of industrial property in Moscow in framework of cooperation of the countries socialist in the international organization, COMECON.

In 1983, he obtained a postgraduate diploma of Protection of Industrial Property. After his mission in Moscow, he worked in a Hungarian Patent Office as head of the department of trademarks. In 1988, he defended his candidate's thesis on 'Problems of Unification in Matter of Trademarks', and he has obtained a Ph.D. doctorate degree at University ELTE in Budapest (1989). Since 1995, he has been working in the faculty of Law and Political Sciences of Pazmány Péter Catholic University as an associate professor and later as a professor of the university. He habilitated in 2004 and was appointed as professor in 2006. He speaks Russian, German, and French fluently. He is author of fifteen books and circa 300 Hungarian and foreign publications and has appeared in recognized journals. In 1974, he married Agnes Baski. They have two children: Szilárd (1977) is a university assistant in Catholic University 'Pázmány Péter'; Enikő (1980) works as an architect in Budapest.
