Message from the Head

1996-97 is a very fruitful year.

The result of the 1996 Research Assessment Exercise conducted by the University Grants Committee was announced in early 1997. The proportion of active researchers in our Department is 0.69 which is higher than the University average of 0.63, and substantially higher than the average of 0.39 in the social work field! For this, the University has given an award of half a million to our Department for 1997-98 and the same for 1998-99.

This year, we have started actively to promote social work training to secondary school students. By doing this, we hope to encourage competition among social work departments in the various universities in promoting social work training to secondary schools. For the 1997 joint universities admission exercise, the number of applicants for the five social work degree programmes listed as their first three preferences has increased by 54% as compared to that of last year. For our BSW programme, the number of applicants has increased by 84%! As a result, the average A-level grade of BSW students admitted in 1997 is more than one fine grade better than that of the last year.

The above achievements will definitely encourage us to try our very best in teaching and research, while continuing with the good tradition of maintaining a close working relationship with colleagues in the social work field.

To develop social work knowledge relevant to Hong Kong and Chinese societies.

The Department has made significant contributions to research and practice innovations in the fields of social welfare and social work. Areas of expertise include family and child care, gerontology, mental health, social policy, health and rehabilitation, youth and delinquency, social welfare in China, social work education in Chinese societies, etc.

To foster development of social welfare services and social welfare policy in Hong Kong

Utilizing our knowledge and expertise in social welfare, members of the Department have been actively serving the community, advocating policy changes, and participating in the policy-making, development, management, implementation and evaluation of social welfare services.
