SINO-ITALIAN EXCHANGE OF NOTES FOR THE REGULATION OF CERTAIN OFFICIAL ASSETS OF ITALIAN GOVERNMEN'T AND PROPERTY OF ITALIAN NATIONALS IN CHINA

(I) NOTE FROM ITALIAN MINISTER FOR FOR-EIGN AFFAIRS TO CHINESE AMBASSADOR

Rome, 30th July 1947

Excellency,

I have the honour to refer to the conversations we had on May 13th last on the subject relating to certain property rights held in China by the Italian Foreign Ministry and Nationals. In the course of these conversations we reached the following understandings:

- (1) that the Chinese Government will recognize, in conformity with the laws and regulations enforced by the Chinese Government, the rights of the Italian Government in respect of:
 - (a) buildings and grounds of the Italian Consular Offices in Shanghai, Tientsin, Hankow;
 - (b) buildings and grounds of the Italian Clubs in Shanghai, Tientsin, annexes thereto, and
 - (c) buildings within the former compound of the Italian Embassy, Peiping (excluding former barracks):
- (2) that the Chinese Government recognizes the use, for official purposes only, by the Italian Government of that portion of the ground alloted to the Italian Foreign Ministry in the former Legation Quarter in Peiping, in which the buildings of the former Italian Embassy are situated, and

His Excellency Yii Tsune-Chi Ambassador of China ROME (3) that the Chinese Government will accord the Italian Nationals in respect of the property rights held by them in China such treatment as is or may be accorded to the Nationals of an Allied or a Neutral country.

I shall be much obliged if Your Excellency will confirm the foregoing.

(II) NOTE FROM CHINESE AMBASSADOR TO ITALIAN MINISTER FOR FOREIGN AFFAIRS
