

序

《精通商务英语 2000 词汇》是一本现代商务的工具参考书。它定位于我国当前改革开放和经济发展的需要。人类社会进入 20 世纪 70 年代以来,以微电子技术为基础的计算机技术和通信技术取得了迅速的发展,并以最快的速度进入现代社会的各个领域,从而产生了象 laptop(袖珍电脑)、multimedia(多媒体)、machine language(机器语言)、magazine concept(杂志型概念)等新词汇、新概念、新术语。随着改革开放的不断深入,这些新词汇、新概念、新术语在我国的经济生活中已屡见不鲜。如何对它们进行恰当的英汉对照,使它们能服务于我国的经济生活诚然是一个紧迫的问题。《精通商务英语 2000 词汇》的编者——我校的两名青年教师以及一位美国朋友试图从这方面进行探索,这是值得赞赏的。

本书的特点之一是新。它收集了商务活动中新的词汇、术语。如 magazine concept(杂志型概念),指企业根据不同观众对某些节目的偏爱而安排作电视广告的营销方法。

本书的特点之二是广。它收集的商务英语词汇内容比较广。 如日常生活中经常听到的 job hopping(跳槽),房地产行业中出现的 real estate investment trust(房地产投资信托公司),以及企业公共关系工作中经常有的 reposition(重塑企业形象,企业形象重新定位)等。

本书的特点之三是实。它收集的商务英语词汇基本上都是 具有一定的实用性。如 value-added tax(增值税)、outside director (外界董事,指积极参与企业的管理而又不是企业雇员的企业董事会成员)、zip-code marketing(邮区营销,以邮区的划分来制定市场营销策略)等。

《精通商务英语 2000 词汇》, 英汉双解, 英语语言地道纯正,中文对照恰到好处。由于学科的原因, 其中的有些专业术语就英汉对照的精确性而言尚有值得探讨的地方,相信广大读者会在实践中作出判断。

我相信《精通商务英语 2000 词汇》对于从事商务、金融、贸易等工作的各级领导、商务专业的师生都会有一定的参考价值,它不失为一本较好的工具参考书,我真诚地向社会各界读者推荐。

使用说明

- 1. 本书英汉双解,所选收的英语主词汇按字母顺序排列,以黑体字排印;词汇英语解释则以白体排印,汉语解释以宋体排印。
- 紧接英语主词汇在括号内以黑体字排印的词汇,表示主词汇 又可称作该词汇。
- 3. 若主词汇系缩写,则主词汇后紧接其全称,用"·····的缩写"说明。若主词汇有缩写则用《缩》标出,后紧接其缩写形式,用 黑体字排印。
- 4. 主词汇若多义,则英语解释按义项用"1."、"2."等分别列出。词性用斜体标出。汉语解释紧接在英语解释之后,不同义项的汉语解释分列在各义项后。若主词汇系口语、俚语、俗语或行话等则分别用<口>、<俚>、<俗>及<行>等标出。
- 5. 例句或例词与英汉解释之间以"*"标出间隔,例句与例句或例词与例词之间亦以"*"间隔。例句及例词中出现的主词用 "~"代替,若主词有曲折变化的,则视具体情况给出曲折变化 或用"~加曲折变化"的形式给出。
- 6. 若主词有同义词或对义词者,则在例句或例词后用"《同》" 或"《对》"标出,同义词或对义词英语词汇用黑体字排印。同 义词的汉语解释不给出,对义词的汉语解释则给出。与主词有 相同或相似用法的词汇以《比较》标出,用黑体字排印,给出 汉语解释。
- 7. 为加深及帮助对有些主词汇的了解,本书部分词汇后设有"< 参见>"一栏,该栏目列在词条的最后,列出的词汇在书中另

- acronym Abreeviation fromed from the first letters or parts of words and pronounced as words. Most acronyms are represented by all capitals. Ex: NASA. 首字母缩拼词(如 NASA,代表 National Aeronautics and Space Administration (美国)国家航空宇宙航行局) * The use of ~ in society is convenient but sometimes con-

- action research. The use of innovative ideas of proactive members of an organization to motivate a research team to investigate new ideas on an ongoing basis. 活动研究 * We need to start an ~ program. 我们需要开始一个活动研究项目。
- ad campaign An advertising strategy designed to promote the awareness of a product, service, or person. 广告活动,广告运动 * The new soft drink taunched one of the largest ~s in recent years. 这种新的软饮料开展了近年来最大的一次广告活动。
- ad hoc committee A temporary committee created to deal with a spe-

- advance planning Preliminary planning that is done before a final decision is made. 预先计划 * There's an ~ meeting this afternoon. 下午有一场预先计划会议。
- advertisement A public message paid for by a sponsor and appearing in print or in the broadcast media for the purpose of promoting a product, service, or idea. 广告 * The average person is bombarded by hundreds of ~s every day. 人们每天都被成百上千的广告所困扰。advertise r. 做广告
- advertising The use of sales messages paid for by a sponsor and communicated through the mass media usually on a repeated basis to an audience of potential buyers. 广告活动;广告业 ad agency 广告公司 adman 广告人 * Which ad agency is doing your advertising?哪一家广告公司为您做广告? * Michael is one of the best adman I know. 迈克尔是我见过的最好的广告人之一。

- affluent society A society characterized by a general level of economic well-being. 富有社会 * Japan has become an ~ in a relatively short period of time. 日本在相对较短的时间内成了一个富有社会。
- aftermarket The market for replacement parts, accessories, etc., as for an automobile, after its sale to the consumer. 零部件修配市场 * The ~ on cars is a rather lucrative one. 汽车零部件修配市场非常有利可图。
- agency A company, organization, or business whose primary activity is the provision of services to other companies (e.g., an advertising, public relations, real estate, or insurance agency. 机构;公司 (如广告公司,公关公司,房产公司,保险公司等) * Our ~ is basically a public relations consultant. 我们公司大体上是一家公关咨询公司。
- agency recognition A written or oral statement given to an ad agency by approriate officials of a client company testifying that the agency meets required standards and is entitled to commissions. 代理 机构认可书 * We will be happy to give you ~. 我们很乐意发给你们代理机构认可书。
- agency of record The principal advertising agency chosen by an advertiser to manage the activities of a media project involving a number of subordinate agencies. 主体代理机构 * S&S is the \sim in this

- agenda A list of things to be done. 议事日程,议程 * What's on the ~ this morning? 今天早上的日程有哪些?
- agent A person who acts as an intermediacy in a business transaction. 代理人,代理商 * Many writers use ~ s to shop their books to publishers. 许多作者通过代理人将书推销给出版商。
- aggregate demand The total dollars spent on goods and services in an e-conomy during a specified period of time. 总需要量 * What was the ~ during the iast quarter? 上一季度的总需求量为多少?
- agreement An understanding or arrangement between two or more people or countries, etc. A contract. 协议,契约 * We have an ~ with their company. 我们同他们公司有协议。
- agribusiness The part of the economy devoted to agriculture, and the production, processing, and distribution of food. 农业综合企业 * Mr. Dixon is involved in multi-million dollar ~ venture. 狄克逊先生经营着几百万美元的农业综合性企业。agriculture n. 农业
- AIDA process In advertising, an acronym that represents the essentials of an effective sales message: attract "attention", arouse "interest", create "desire" for the product, and stimulate "action". 广告的四个过程(即吸引注意力、引起兴趣、产生愿望和促使购买行动) * Our client wants us to concentrate on using the ~ in our next advertising campaign for them. 我们的客户想让我们利用广告的四个程序来开展下一次广告攻势。
- aide An assistant or helper. 助手,副官 * Miss Perkins is an ~ to the vice president. 珀金斯小姐是副总经理的助手。
- air rights Rights to the space above land owned by someone else. (±

- 地等不动产的)空间所有权 * The owners of the office building are in litigation with the next-door residents over ~. 该办公大楼的业主们正在为空间所有权与隔壁居民们进行诉讼。
- alien corporation A corporation charted in a foreign country but operating in the United States. 外国公司 * Toyota is an ~ within the U.S. 丰田是在美经营的外国公司。
- allowed time The amount of time that hourly and part-time employee are permitted to absent themselves from the job on personal breaks. (终点工和兼职雇员的)放松时间,个人休息时间 * Employees generally receive 10-15 minutes of ~ for every two hours of work. 雇员们每两小时有十至十五分钟的放松时间。
 - * break time 歇息时间 * Is it ~ yet? 到休息时间了吗?
- alphabet soup An informal characterization of the confusion of abbre viations used for the names of organizations of all kinds. IRS, CBS, MTV, UCLA, ETC. 〈口〉字母汤(对首字母缩略词滥用的非正式称呼) * All these abbreviations and acronyms look like ~ to me. 所有这些缩写及首字母缩略词对我来说是一锅字母汤。
- amalgamation A merger of two or more companies brought together by an outside interest, such as an investment bank. 合并,兼并 *
 The Ace Sugar company is an ~ of two other companies. Ace 糖业公司是其他两家公司合并起来的。amalgamate v. To unite, combine. 合并,统一
- American Stock Exchange The second largest stock exchange in the United States. 美国证券交易所(有时略作 ASE 或 AMEX) * Mr. Thomas follows the ~ every day. 托马斯先生每日都留意美国证券交易所的行情。
