编辑说明

一、《中国贸易外经统计年鉴——2007》是一部全面反映中国国内贸易、对外经济贸易和国际旅游业的资料性年刊。本年鉴收录了2006年中国国内贸易、对外经济贸易和国际旅游的主要统计数据,以及分省、自治区、直辖市和一些重要历史年份的相关统计数据。

二、本年鉴正文内容分为8个部分:1. 综合篇;2. 国内贸易篇;3. 国际收支篇;4. 对外贸易篇;5. 外资篇;6. 对外合作篇;7. 旅游篇;8. 企业篇。为便于读者使用,本年鉴对所用略语和主要统计指标的含义、统计范围和统计方法作了简要说明。

三、年鉴中涉及的全国性统计资料,均未包括香港、澳门特别行政区和台湾省。

四、本年鉴所列部分资料由国家统计局贸易外经司根据公安部、商务部、海关总署、国家工商行政管理总局、国家旅游局、国家外汇管理局等部门的资料加工整理,由于各部门职能不同,统计口径、范围和方法亦有所不同,因此书中有些数据可能不一致,使用统计数据时请参看附录。

五、本年鉴表中所使用的度量衡单位,均为国际统一标准计量单位。

六、年鉴表中的“空格”表示该项统计指标数据不足本表最小单位数、不详或无该项数据;“#”表示其中的主要项;“*”或“①”表示本表下有注释。

七、年鉴中没有标明年份的表均为2006年的数据。

PREFACE

I. 2007 *China Trade and External Economic Statistical Yearbook* reflects the situation of China in the development of the domestic and foreign trade, the external economic transactions and the international tourism synthetically. The yearbook covers the main data of the domestic trade, the foreign trade, the external economic transactions and the international tourism of China in 2006, and embodies the data from national level and all the provinces, autonomous regions and municipalities. It also lists the time series relative data of important indicators by years.

II. The yearbook contains the following 8 chapters: 1. Integration; 2. Domestic Trade; 3. Balance of Payments; 4. Foreign Trade; 5. Foreign Capital; 6. International Cooperation; 7. International Tourism; 8. Corporation. In addition, Explanatory Notes on Main Statistical Indicators are provided at the end of book.

III. The national data in the book do not include that of Hongkong Special Administrative Region, Macao Special Administrative Region and Taiwan Province.

IV. The major sources of data except these in the domestic trade are the regular statistical reporting forms provided by sectors such as the Ministry of Public Security, the Ministry of Commerce, the General Administration of Customs, the State Administration of Industrial & Commerce, the General Administration of Travel and Tourism, the State Administration of Foreign Exchange. The book is edited by the Department of Trade and External Economic Relation Statistics of the National Bureau of Statistics. Since the functions of sectors mentioned above are different, the requirement, the scope, the calculating specification and the method of statistics are not in the same, and some of the figures may not be in conformity. Readers who want to use the data please consult the explanatory note.

V. The units of measurement used in this yearbook are internationally standard measurement units.

VI. Notations used in the yearbook: (blank space) indicates that the figure is not large enough to be measured with the smallest unit in the table, or data are unknown or are not available; “#” indicates a major breakdown of the total; and “*” or “①” indicates footnotes at the end of the table.

VII. The data belong to 2006 in the table of without year in the yearbook.
