前言

随着我国改革开放日益深入,国际间金融活动日趋频繁,新理论、新操作、新准则、新法规不断涌现,为满足国内财政金融领域各方人士对专业术语特别是新词新义的急需,北京双语辞书发展中心特组织在京财政金融界精通英语的专家学者及高校教师近百人编写了这套《英汉汉英财政金融分科词汇手册》。

本套书的特点有三,一曰"全",二曰"新",三曰"实用"。

所谓"全",首先是指门类齐全。全套书包括财政、银行、会计、统计、审计、投资、证券、税收、保险、期货十个分册。其次,各分册内容全面,收词量大。既有理论,又有实务;既有国内,又有国际,举凡相关词汇尽量收入。

所谓"新",是指各分册均注意收入近年来国内新出台的准则、法规的新词新义,还特别注意收入计算机方面的词汇,例如: Hang Seng Index(恒生指数), audit of computer operations(计算机运算审计)等。

所谓"实用",首先是指本书分为英汉、汉英两部分,一书两用。其次,所收词条均以英文字母或汉语拼音字母顺序排列,一目了然。再次,版式设计简炼明晰,检索方便。

本书参编者众多,工作量巨大,虽初衷良好,且始终以严谨 自律,时时如履薄冰,不敢稍有草率,但囿于水平所限,不当之处 在所难免,切望读者同仁不吝赐教,以便再版时加以修正。
