该书是"中英(辽宁)国有企业重组与企业发展项目"的研究成果,是有关中小企业创业与发展的实用指导性图书。全书 3 篇 11 章,创业篇有 4 章,内容有创业者、创建企业的类型、创建企业的条件和程序、商业计划;运行篇 5 章,内容有市场营销、财务管理、人力资源管理、生产运作管理和企业经营风险与管理;发展篇 2 章,内容有发展概述和发展框架。各章前有导读,各节后有启示。该手册融我国中小企业管理思想和管理知识与经济发达国家新型管理理念和管理知识于一体,管理理念新颖,内容全面,实际实用,通俗易懂,是企业咨询经验的精华、也是中小企业创业与发展的指南。

该手册是中小企业家的必备读物,也是企业咨询人员和行政管理人员的工 作参考书。

# 总 序

"中英(辽宁)国有企业重组与企业发展项目"自 2000 年1月实施以来,至今有近三个年头的时间了。这个由英 国国际发展部负责的对华援助项目在辽宁的成功实施,不 仅使辽宁省有关部门和企业学习到了先进的企业重组和发 达国家发展中小企业的经验,对辽宁省国有企业改革和中 小企业发展起到了推动作用,而且也体现了辽宁省与英国 政府增进友谊、全面合作、共创未来的精神,是辽宁省与英 国政府友好合作关系的一个新篇章。

根据中英两国政府签署的《中国国有企业重组与企业 发展项目备忘录》的精神,这个技术援助项目包括既相对独 立而又相互联系的如下三个部分。

- 1. 国有企业重组模块。其主要任务是借鉴英国及经济发达国家在国有企业改革及管理中积累的经验,聘请国际著名咨询公司为试点的国有企业提供咨询服务。通过对国有企业的组织结构、发展战略、生产运营、市场营销、财务管理和人力资源等方面的系统重组,全面提升企业的管理水平,其目标是将面临困境的国有企业转变为具有自我生存和可持续发展能力的企业。在项目实施的三年中,有13家试点企业得到重组,并重新焕发出生机与活力。
- 2. 中小企业信息咨询模块。其主要工作是借鉴发达国家的经验,创建和开发为中小企业提供服务的信息咨询机构

及服务网络,为当地中小企业,特别是小型和微型企业的创 立和发展提供咨询服务。发展中小企业不仅可为地区经济 的发展和财富的增加寻找到新的增长点,而且对于创造新的 就业岗位、提高地区的就业水平、缓解因国有企业改革而引 起的富余人员下岗失业压力,具有重要意义。在这个项目 中,它是国有企业重组模块不可或缺的支持体系。

3. 中小企业信用担保模块。其使命是创建符合国际 惯例、在市场经济条件下能够独立运作并具有可持续发展 能力的中小企业信用担保机构。通过为中小企业在融资过 程中提供担保服务,解决地区中小企业在发展过程中所普 谝遇到的融资困难问题。该模块与中小企业信息咨询模块 结合起来,能为中小企业提供更多生存和发展的机会。

辽宁省是国家重要的工业基地,国有经济和国有企业仍 占有"半壁江山"。在社会主义市场经济条件下,国有企业虽 然在地区经济和社会发展中做出了重要的贡献,但在与其他 所有制类型企业的竞争中,其体制性和机制性的问题越来越 突出。根据中共中央十五届四中全会的精神,必须对国有经 济和国有企业进行战略性调整和重组,这是一项长期而艰巨 的仟条。在这个过程中,我们不仅需要自我创新出新的方法 和模式,而且更需要学习和借鉴发达国家在国有企业改革及 中小企业发展方面的经验和方法,结合辽宁省的实际情况, 创造性地对辽宁省国有企业进行战略性重组,并大力发展各 种类型的中小企业,为解决辽宁省机制性矛盾并开发新的经 济增长点寻找到一条可行的途径。

我们高兴地看到,"中英(辽宁)国有企业重组与企业发

展项目"在英方咨询专家的帮助下,运用先进适用的企业重组与中小企业发展的方法,经过近三年的实施,已经取得了丰硕的成果。重组企业成功的案例和方法为其他国有企业的改革提供了可资学习和效仿的典范;中小企业信息咨询机构和中小企业信用担保机构的创建和运行机制为建设中小企业服务体系提供了非常有益的经验和模式。

为了总结这个项目在辽宁省实施期间所获得的知识与成功经验,我们编辑出版了这套《中英(辽宁)国有企业重组与企业发展项目成果系列丛书》。本丛书包括《国有企业重组案例研究》、《中小企业创业与发展指导手册》和《中小企业信用担保探索与实践》,共三本。

#### General Foreword

It has been nearly three years since Sino-UK (Liaoning) State-Owned Enterprise Restructuring and Enterprise Development Project started in January, 2000. The successful implementation of this aid project undertaken by Department for International Development, UK not only promotes the SOE reform and SME development in Liaoning by providing access to related advanced experiences in developed countries for related departments and enterprises in Liaoning, but also embodies Liaoning Province and UK Government's spirit of strengthening friendship, cooperating in an all-round way and working for a bright future with joint efforts, starting a new page of friendly and cooperative relationship between the two sides.

In the light of SOERED Project Memorandum signed by Chinese and UK Governments, this project of technical assistance consists of the following three components that are relatively independent as well as related with each other.

#### 1. Restructuring Agency (RA)

This component works to draw on the advanced experiences of UK and other developed countries in SOE reform and management, and engages internationally well-known consultancy company to provide advisory service for pilot SOEs. It aims to turn around the loss-making SOEs into financially viable and sustain-

able enterprises by improving the overall management through systematic restructuring on SOE organization, development strategy, production operation, marketing, financial management and human resource management. Within the three-year period of the project, altogether thirteen pilot enterprises were restructured and put on new looks of vitality and vigour.

#### 2. Business Advisory Centre (BAC)

This component learns advanced experiences from developed countries, creates and develops SME advisory institutions and service network, and provides consultancy service for the start-up and development of local SMEs, especially the small and micro ones. SME development is a new source of local economic growth, and is also of great significance to creating more working opportunities and alleviating the pressure of laid-off and unemployment in SOE reform. In this project, it is an indispensable supporting system of RA.

#### 3. Credit Guarantee Fund (CGF)

This component sets up CGFs of independent operation and sustainable development in the market-oriented economy, and provides guarantee service for local SMEs to solve their common financing difficulties. It works together with BACs to provide more opportunities for SME start-up and development.

Liaoning is an important industrial base in China with still half of its enterprises being state-owned. Under the socialist market economy, SOEs still contribute a lot to the local economic and social development, though problems in their system and mechanism are becoming more and more serious. Following the guiding ideology in the Fourth Plenary Session of the Fifteenth Central Committee of the Party, strategic transformation and restructuring must be carried on SOEs, which is no doubt hard work for a long period. In this process, we not only need to find new methods and create new modes, but also learn from developed countries of their advanced experiences in SOE reform and SME development, and make good use of them in Liaoning to creatively carry out strategic restructuring on SOEs and make great efforts in developing all types of SMEs, thus to find a new way to solving the mechanism problems in Liaoning and explore new source for economic growth.

We are so glad to see that SOERED Project, with the help of UK consultants, by employing advanced and practical ways of enterprise restructuring and SME development, has achieved great successes after nearly three years' implementation. The successful cases and methods in enterprise restructuring set good examples for other SOEs' reform; the start-up and operating mechanism of BACs and CGFs provide rather valuable experiences and modes for the establishment of SME service system.

In order to sum up the knowledge and experiences gained during the project implementation in Liaoning, we compiled and published the Sino-UK (Liaoning) SOERED Project Achievements Book Series. It is composed of three books that are Case

Study on State-Owned Enterprise Restructuiring, Guide to Small and Medium Enterprise Start-up and Development, and Research and Practice of Small and Medium Enterprise Credit Guarantee.

We wish that the publication of this book series could help to disseminate and replicate the advanced and practical experiences in enterprise restructuring and SME development in developed countries to a wider range, could promote the SOE reform process and the establishment of SME service system and contribute to the economic and social development of Liaoning and even the whole nation.

#### **Foreword**

The Small and Medium Enterprise (SME) is a vital ingredient in any well-balanced economy. Indeed the smallest firms have been shown to be the largest net job creators in both the USA and the European Union in recent years. SME's also provide a large measure of diversity, flexibility and innovation to an economy particularly at local and regional level.

In China, accession to WTO seems likely to provide an impetus to the development of the SME sector since firms can now compete on a "level playing field" and can exploit many of the new niches which become available with the opening up of the economy. WTO therefore represents an opportunity as well as a threat to the Chinese economy but is likely to be particularly welcomed by SME's with a strong strategic orientation and ability to identify and develop new product and market opportunities. The support of SME's at local level will therefore become a vital component in the emergence of a healthy and dynamic market-based economy.

The BAC model has been developed in many countries and essentially seeks to correct a prevalent "market failure" whereby the smallest firms with the most need for support do not take it up because of the high perceived cost of doing so (in terms of time, money, loss of independence, etc.). This means that supply (eg private consultancies) is not well-matched to demand. The result
