

#### Foreword

The Conference Economic Interaction between Guangxi and Macau was jointly-held by the Macau Foundation, the University of Macau and the Guangxi University from June 3 to June 6, 1997 at Beihai of Guangxi. Based on theory and practice, this Conference investigated how the economies of Guangxi and Macau could take every opportunity to realize the strategy and method for the complementarity of the two places' advantages in this new era. There were around 50 participants in the Conference, including specialists, entrepreneurs and government officials in charge of economic affairs; and 22 papers with various aspects were presented. Through discussion, the background of economic interaction, advantages and uniqueness of the two economies, forms and choices of districts for cooperation, principles and measures for interaction were identified and analyzed.

This is the first cooperation between the academics of Macau and Guangxi, that aiming at the issues of interaction between the two economies. Its success indicates that this kind of cooperation could be developed further. The papers presented are compiled into conference proceedings with English abstracts. The purposes of this proceedings are to promote the conference findings extensively, to arouse the attention for further studies of specialists, scholars, economic people, and the concerned government departments. After all, it aims at actively promoting economic cooperation and development between Guangxi and Macau. The views expressed of the essays in this proceedings are those of the authors themselves and they are not necessarily those of the organizers.

#### **桂**澳經濟合作的條件與途徑初探

#### 摘要

本文以經典的"優勢互補"原理爲指導思想,論証廣西澳門發展區域經濟合作的條件與途徑。根據澳門經濟結構的關整和發展方向定位,以及廣西獨特的區位優勢,判定兩地通過區域經濟合作將是最佳的戰略選擇,進而提出:控制源頭——用澳門的資金開發廣西的基礎產業:建設門戶——動員大西南資金合作開發澳門對外開放設施:開發通道——以西江作爲實現桂澳經濟一體化的聯繫紐帶,正是桂澳經濟合作的基本涂徑。

## ON THE CONDITIONS & MEANS OF ECONOMIC COOPERATION BEWTEEN GUANGXI AND MACAU

Liu Chao-Ming\*

#### Abstract

This paper takes the classical principle of comparative advantage as its guiding thinking. Judging from the adjustment of economic structure and development path of Macau and the location-specific advantage of Guangxi, regional economic cooperation is the best strategical selection. These strategies include (1)develop the Guangxi's industry by using Macau's capital; (2)assist Macau to open up itself by using capital from the south-western China; (3)choose the West River as the intermediary to integrate the economic co-operation between Guangxi and Macau.

#### 桂澳經濟合作的條件與途徑初探

廣西和澳門雖然在地理上有廣東省間隔,但兩地通過西江流域卻形成一個首尾相連的開放性區域整體。處於西江上中游的廣西自治區,在南昆鐵路開通後將成爲大西南腹地對外開放的前沿。這個前沿有三大對外通道:一是南向通道,經北海、欽州和防城港三個口岸從海路通向東南亞;二是西南向通道,經陸路通向越南;三是東向通道,經西江流域從水路通向澳門和香港。憑借這種一衣帶水的經濟聯繫,以及考慮到利用澳門的自由港體制,廣西對開展與澳門的經濟合作具有強烈的願望和要求。基於這個前提,本文著重討論柱準之間開展經濟合作的可行性及其涂徑。

#### 一、澳門經濟結構的調整與發展方向定位

從1997年到1999年,可能是澳門對經濟發展方向重新定位的探索期。因爲,無論香港或澳門,經濟發展的動力或引力因素主要來自於自由港體制,而兩埠的繁榮昌盛則在很大程度上取決於中資力量的壯大和中國大陸的支持。在1997年和1999年港、澳分別回歸祖國後,"中國因素"的作用可能會變得更爲重要。所以,在新的歷史機遇和國際背景下,由發展方向重新定位所引發的經濟結構調整也就勢所必然。爲了準確回答這個問題,我們有必要回顧一下澳門經濟發展過程中所經歷的幾次大的結構調整。自1557年葡萄牙人佔據澳門至鴉片戰爭前的300年間,澳門採取了貿易立埠的發展戰略。這一時期的澳門是中國對外貿易的主要商埠。中國的傳統產品如絲網、茶葉、瓷器等經澳門銷往世界各地,不僅使中國長期處於貿易出超地位(大量白銀流入中國),而且還促進了中國境內工場手工業的產生(最早的資本主義萌芽)。鴉片戰爭後,香港取代澳門成爲對外的最大商埠,澳門經濟才被迫轉向了博彩和鴉片貿易等特種行業。

從本世紀50年代後期始,葡萄牙允許澳門產品免稅進入葡屬地區,澳門才逐步發展起一些現代紡織工業。70年代,香港廠商利用歐美對澳門的貿易優惠,把一些勞動密集型的出口加工業轉移到澳門,進一步促進了澳門的經濟增長,這一時期年均增長速度高達16.7%。至80年代中期,澳門的出口加工業佔澳門GDP比重高達36.9%,成爲第一大產業。但進入90年代後,澳門的出口加工業放慢了增長步伐,其比重也降至25%左右,傳統的博彩旅遊業重新昻頭,其比重升至1/3以上,又成爲澳門的最大產業。

在本世紀最後3年,港澳雙雙回歸祖國後,澳門經濟將朝甚麼方向發展,經濟結構 將如何調整,已超過了澳門本土的意義。從發揮澳門的經濟優勢和它與大陸的關係出 發,本文提出以下三種發展模式供選擇:

#### (一)主導產業模式

博彩業和出口加工業是澳門的兩大優勢產業,它在澳門未來的經濟發展中仍將發揮重要的作用。但是,這兩大產業在發展過程中其局限性也日漸顯露。就出口加工業來說,其勞動密集型特徵要求以勞動力充裕和成本低廉爲條件,而澳門恰恰是一個勞動力短缺的地區,並且其生產成本已大大高於東南亞國家和與大陸鄰近地區。澳門的出口加工業以成衣業爲主,其發展主要依賴歐美國家給予的貿易優惠及配額,一旦取消配額,澳門的成衣業必將陷入困境。就博彩業來說,它是澳門的最大產業,已佔澳門GDP的1/3。雖然《中華人民共和國澳門特別行政區基本法》規定,澳門可以根據本地整體利益
