



前言

本世紀前一半可謂軍事政治爲主,而後一半則已首重經濟貿易。世界日漸變小,人口日益增多,資源日趨減少,各國均須大力發展經濟、貿易和商業。六十年代以來,全球當數東亞地區發展最速。七十年代以來,佔人類四分之一的中華民族,包括中國大陸、台灣、香港、新加坡和東南亞及世界各國的華人,已在世界貿易和商業中擁有空前重要的地位。

雖然六十年代中葉迄今已出版了衆多有關各行各業的詞典,而且英語早已是擧世公認的國際商業語言,但是比較詳盡的英漢貿易商業詞典仍付闕如,就連英語貿易詞典都遍搜不獲。編者亦文亦商,切身體驗,深感此需,遂應商務印書館的邀約,不顧任重時急,毅然允承主編本詞典。

本詞典旨在爲各地兼用中、英兩種語言從事貿易、商業、 會計、銀行、保險、運輸、廣告、通訊等的人士,提供一本 有關貿易及商業術語、略語和符號的最新最全的英漢對照簡 捷參考手册。本詞典亦爲兼用英、中兩種語言從事教育、研究、出版、翻譯、新聞傳播、及公共關係等工作的有關人士, 提供一册有用的參考書。

本詞典的選詞標準是:凡與國際貿易直接有關的詞條, 包括進口出口、詢價報盤、貨幣量衡、談判簽約、檢驗保險、 包裝運輸、單據票證、會計結算、索賠仲裁等,則盡量包羅; 凡對貿易關係重要的詞條,包括零售批發、銀行財務、廣告 通訊等,則大量收集;凡與貿易間接有關的詞條,包括經濟學、工商管理、稅制、證券、股票、金銀等,則酌量選錄;凡與貿易關係不大或其實並無關係的詞語,包括工會、就業、工資福利、人壽保險、商業教育和培訓、地產房產等等,則一概不收。本詞典亦適當編入爲貿易服務的主要國際機構名稱,但一律不收個別工商企業公司的名稱或個別行業的專用術語,以避廣告宣傳之嫌。本詞典尤其注重編纂近十餘年來出現的新詞。

編者謹此銘謝商務印書館香港和北京編輯部、英國圖書館和香港圖書館所給予的種種協助;並感謝吾友倫敦大學中文畢業生Mr. M. J. Parker(白克强先生)協助校對。

編者學識謭陋,公務繁冗,覊旅頻仍,疏誤難免,謹此 祈願以本詞典拋磚引玉,請讀者專家不吝指教,衷心期望有 更多更好更詳細的英漢貿易商業詞典迅速面世。

FOREWORD

If the first half of this century was dominated by military and political events, the most far-reaching changes of the latter half have been those of an economic and commercial nature. With the ever smaller world, larger population and growing scarcity of resources, all nations have to make great efforts to develop their economy, trade and commerce. Since the 1960's East Asia has experienced the fastest economic growth in the world. Since the 1970's the Chinese people from Chinese Mainland, Taiwan, Hong Kong, Singapore and other Southeast Asian countries, and all corners of the globe, who together constitute nearly one fourth of mankind, have occupied an unprecedentedly and increasingly important position in world trade and commerce.

However, despite a plethora of dictionaries on various subjects and professions since the mid-1960's, there has been a surprising absence of up-to-date comprehensive English-Chinese dictionaries on trade and commerce. Even more surprising has been the apparent shortage of English dictionaries on this subject, although English has long been universally acknowledged as the international language of commerce. The author felt the need for such a dictionary out of his own experiences in both the publication and trade professions, and therefore was pleased to accept the invitation of the Commercial Press to compile this Dictionary.

The aim of this Dictionary is to provide a most up-to-date comprehensive English-Chinese quick reference handbook on trade and commercial terms, phrases, abbreviations and symbols for all people engaged in or studying trade and commerce or related spheres such as insurance, shipping, accounting, banking, advertising and communications. It could also be a useful reference manual for people engaged in education, research, publication, translation, journalism and public relations for the above-mentioned subjects and areas.

The principle followed in compiling this Dictionary is to include as

thoroughly as possible those entries which are directly related to international trade covering import and export, inquiries and offers. currencies and measurements, negotiations and contracts, inspection and insurance, packing and shipping, bills and credits, accounting and settlement, claims and arbitration; to include as far as reasonably possible those entries which are important to trade covering retail and wholesale, banking and finance, advertising and communications: to include on a more selective basis entries on topics which are indirectly related to trade such as economics and management, securities and stocks, gold and silver; and to exclude categories which are only slightly or not actually related with trade such as trade union and employment, wages and welfare systems, life assurance, business education and training, real estate and property. Although names of principal international trade oriented associations and organisations are also included, this Dictionary does not mention names of individual manufacturing and commercial companies to avoid any suspicion of advertising. Terms related to specific industries, trades or professions are also excluded. The preference is given to new terms which have come into use during the past decade.

The author would like to acknowledge his sincere thanks to the Commercial Press in Hong Kong and Beijing, the British Library and the Hong Kong Libraries for their assistance; and to my friend Mr. M. J. Parker, a graduate in Chinese from London University, for his help with the proof-reading.

The author was limited by the constraints of his knowledge and by business pressures and frequent travelling, and would have liked to have been able to devote more time and efforts to the compilation of this Dictionary. However, it is his sincere hope that this Dictionary will at least provide a starting point for more and better up-to-date comprehensive dictionaries on this most important topic, and the author and publisher would welcome comments and suggestions from users of this Dictionary.

體例說明

- 一、本詞 一律用黑正體排印。外來詞、縮略語、度量衡、 貨幣單位等均作爲詞條,按英語字母順序編排,以便於 翻查參考。爲節省篇幅,普通詞典均有的國家、城市、 港口等地名、度量衡換算表等,不再臚列。而一般詞典 所缺少的貿易術語專義和新詞新義則盡量兼收並蓄。
- 二、**發音** 部分新詞或特殊的本詞後用國際音標註明讀音。 一般詞條不註音。
- 三、**詞性** 應予注意的詞,則在本詞(或音標)後註明。一 般詞條不註詞性。
- 四、釋義 只選用與貿易商業有關的詞義。用";"分開不同 的釋義;用"/"分開各地的不同譯名;詞義較多者,以 "1","2"…分別之。
- 五、**其他** 用"[]"表示特殊類別和來源,如[縮]、[電縮]、[前綴]、[英]、[美],等等。
 - 用"()"表示:可有可無的字母或釋義;可以省略(或縮略語)的部分:解釋性的文字;同義或參考的詞條等。
- 六、**附錄** 英漢對照的國際商會《跟單信用證統一慣例和實務》全文。此篇文件是舉世公認的國際貿易和商業的重要準則。
