

中文版序

欢迎中国读者走入英国行政法世界。在此,我们尝试通过简要分析英国行政法的显著特点和重要的发展趋势,为读者理解本书提供一个宏观背景。

(一)

欧陆多数国家的行政法制度是以法国行政法为基础的,这种行政法制度的特点是拥有专门的行政法院体系、专业性的法官、独有的程序和原则。从历史上看,英国行政法与之迥然不同。戴西这位或许是英国最具有影响力的公法理论学家,在1885年首次出版的《宪法研究导论》一书中所阐发的法治理念,强调法律面前人人平等和不得享有专横权力。戴西之所以提出这一法治理念,部分出于面对行政国家权力的不断扩张,需要保护公民个人权利的考虑。在戴西看来,这一理念比法国的行政法制度优越。其结果是,英国行政法的核心内容一直循着戴西的正统理论思路快速发展起来的,只不过这一切都是在没有全面规划的背景下进行的。例如,由法官确立的司法审查原则,就是通过普通法以个案为基础逐步呈现出来的,而在今天这些原则已成为控制行政权行使的重要方面。与此同时,行政裁判所和如监察专员等其他法定救济途径的快速扩展,也满足了人们对行政正义的追求。当今,它们已遍及补救金、住房、社会保障、教育、移民等众多领域。本书视各类行政救济途径为完整的救济链条,范围从替代性救济方式、公民宪章、监察专员、裁判所到作为最终手段的司法审查。

(二)

与多数国家不同,英国没有成文宪法,英国的宪政很大程度上是由制定法、普通法、宪法性条约等构成,且相当倚重宪政传统。在此重要意义上,英国宪法与行政法,是不可

分割的统一体。例如,长期以来,议会主权原则被视为英国宪政的基本原则,从理论上看议会有权制定或废除授予国家行政机关权力的任何法律,不受任何限制。虽然到目前为止英国尚未建立可以宣布议会立法无效的宪法法院,但以共认的权力分立原则为基础的法治是与议会主权原则几乎同等重要的原则,为英国宪政的支柱之一,在行政法上法治具体体现为合法性原则。在捍卫法治之时,尽管法官无权推翻议会立法,但却负有保证行政机关合法行使议会授予的权力的职责。同样,法官有权监督特权的合法行使(目前主要由各部大臣行使),且保证行政机关遵循程序公正要求。因此,在一些法官和学者看来,应当从消极意义上对行政法进行狭义的界定,即行政法是有关控制行政权的法律。

然而,近几十年来,英国已超越了狭窄的普通法传统。自 20 世纪 70 年代早期英国成为欧洲经济共同体的成员国以来,英国法受到欧洲法的影响越来越大。欧洲法不仅通过欧盟法对英国资内法院产生的约束力限制了议会主权这一核心原则,而且推进了本书所探讨的行政法原则的发展,例如合法预期原则和比例原则相继在英国法上确立。

(三)

1997 年以来政府推行的宪政改革,对英国行政法产生了相当重大的影响。于 2000 年 10 月全面实施的 1998 年《人权法》,大体相当于英国资内的人权法案,它把《欧洲人权公约》所确立的权利转化为英国资内法。根据《人权法》的规定,英国公民若认为其受《欧洲人权公约》保护的权利被侵犯,即可直接向英国资内法院寻求救济。虽然《人权法》并未授予英国资内法院宣布基本法律无效的权力,但却要求法官以与《欧洲人权公约》相一致的方式解释基本法律,从而大大提升了法院的地位。事实上,2005 年通过的《宪政改革法》,明确规定组建新的最高法院承担上议院的司法职能。可以认为,这一举措连同该法确立的更为独立、更为开放的法官任命制度,是对宪政上更为牢固的权力分立要求的再次肯定。除此之外,还有其他许多改革举措。苏格兰、威尔士和北爱尔兰,各自均获得了相应的下放权力;作为立法机关的上议院的组成,得以调整;2000 年出台的《信息公开法》,确立公民享有普遍的知情权,除法定的免予公开的情形外,公共部门的决定应更为透明公开。而就行政司法领域而言,根据 Legatt 的建议和 2007 年《裁判所、法院和执行法》(Tribunals, Courts and Enforcement Act)的规定,政府对裁判所进行重组,形成统一的裁判所体系,从而实现裁判所的管理和程序的协调一致。所有这一切,已逐步形成了英国宪政成文化的重要内容。

(四)

自 20 世纪 80 年代中期以来,英国政府开始推行自由市场创新方案,以此提高行政效率。与此相适应,行政国家开始从过去的所谓福利国家(由全民健康服务、补助金、住房、教育等方面组成)转型。在此过程中,新的治理方式——如新公共管理方式、原国有企业的私有化及其规制、公众参与、咨询和电子政府——层出不穷。而至关重要的是,很明显,先前由政府直接负责公共服务的提供,而现在在契约国家中,则经常是由私营部门或自主性组织根据合同的约定代表中央或地方政府提供公共服务。在迈向当今通常称之为的治理方向过程中进行的变革所带来的后果之一,是要想明确划分公法与私法之间的界限变得愈来愈困难。

(五)

或许,当前英国行政法面临的最大争议,是有关议会、行政与司法各自的作用问题。一些学者和法官认为,在个人的权利和自由面临威胁时,法院应当运用普通法主张权力推翻立法规定。之所以会形成这一观点的原因主要在于,某一政党一旦在大选中获胜,在英国议会中获得多数席位,并组建政府,便几乎总能使用多数席位实现自己的立法目标(有时被称为“选举独裁”),议会中的立法审查机制可能无力改变政府有失偏颇的立法措施。这一缺陷的存在意味着,法院可以被视为现有唯一的可以纠偏的可行机制。然而,一些赞同 Griffith 教授称之为政治性宪法观点的学者,对由非民选产生的法官经常性介入政治过程的做法的正当性,提出了强烈的质疑,他们把民选政府的权力置于优先地位。

最后,我们对杨伟东教授表示诚挚的谢意,他是位富有才气的学者,由他翻译必使本书增色不少。我们也对北京大学出版社表示感谢,正是她的努力使本书的中文版能够在中国面世。

英文版序

自 2002 年本书第四版出版发行以来,政府的宪政改革计划又有了重要进展。2000 年《信息公开法》全面实施,2005 年《宪政改革法》出台。同时,政府对裁判所的运作进行了一系列改革,而 2005 年《调查法》已获得御准。此外,法院在人权法、司法审查和公共机关侵权责任领域中又作出许多重要判决。

为对上述发展作出阐释,并提高本书的内在逻辑性,本版以前四版的变化为基础,重新安排本书的结构和内容。第一章是对行政法的总体分析,第二章则是对构成行政法基础的关键性理念的阐释。第三、四章勾勒出现代行政国家的结构,并以行政法为视角探讨了欧盟的组织框架和法理基础。尔后,本书延续了前几版的框架模式,以所谓的“救济链条”为线索探讨责任机制这一核心问题。在对议会、各类监察专员、裁判所和调查为公民提供的救济方式逐一进行评价之后,本书将焦点转向详细分析司法审查和法院更为宏观的作用之上。鉴于《欧洲人权公约》和 1998 年《人权法》显而易见的重要性,本版新增两个独立章节专门分析行政法与人权问题,其中一章放在全面分析司法审查理由之前,而另一章则置其后,其目的在于试图能对这一日益具有扩散性影响的法律领域进行更为全面的整体性探讨和分析。

本书进而详细分析了对司法审查的明示和默示限制以及司法审查程序所能提供的救济方式,并探讨了公共机关签订合同问题和公共机关^{*}的侵权责任问题。最后一章以简要评价当前行政法的发展状况作为全书的结语。

* 本书将 public authority 统一译为“公共机关”,不取“公共当局”、“行政机关”。不译为“公共当局”,是因为它无法清楚指明机关或机构的行政性(不过,因“local authority”代表某一地方政府整体,实行议行合一,译为“地方当局”是恰当的);不译为“行政机关”,在于它无法反映英国公共职能的变迁和不能涵盖现代英国承担公共职能主体的范围。目前,英国的公共管理已远超越了行政机关的范围,大量公共职能是由非行政机关承担的。本书中,“公共机关”泛指传统意义上的行政机关和承担公共职能的公、私团体。——译者注
