Preface

The idea for a book on liability for products comparing the approaches of English and French lawyers and the wider context of the two legal systems, came to me soon after the enactment of the EC Product Liability Directive in 1985, but its appearance has taken very much longer than I anticipated. This is due in part, no doubt, to a number of other projects which have caught my attention, but it is also due to the fact that, as I worked, I felt that I needed to explore further into first French law and then (so as to compare what I found there) English law, looking beyond the private laws of contract and tort and into the laws of administrative liability, criminal law, and criminal and civil procedure and including material on the EC Consumer Guarantees Directive in 1999 (which added a second European dimension to the study).

I would like to start by thanking the editors at Oxford University Press who have been both encouraging and very patient over the years in relation to this work: Richard Hart, John Louth and, most recently and in particular, Gwen Booth. At times a work of this kind can become a strain rather than a joy and Gwen has been a great and practical help in getting the work finished. I have also had the benefit of and am most grateful to a number of research assistants who have helped me in particular to keep the work up-to-date and by checking references: Jonathan Bremner, Charles Clarke, Hadrien Costa de Beauregard, Lydie Reiss, and Andrew Scott. Given the range of its subject-matter, I have set a cut-off date of 1 January 2004 and while I have included some primary material after this date, I have not included new secondary material.

French Cases

French cases are referred to by their deciding body and date, together with any reference where a report of the decision may be found. Sometimes this is supplemented by the name of a party (e.g. *affaire Jand'hur*), this being standard practice as regards decisions of administrative courts. I have abbreviated the month of the date to three letter English abbreviations. Many decisions of the Cour de cassation and Conseil d'Etat (as well as all codified law and many individual *lois*) are available from the *service public* website, <<http://www.legifrance.gouv.fr>>.

The highest court judging civil and criminal cases is the Cour de cassation, which is divided according to the subject matter of the case. These are abbreviated in the notes as follows:

The Cour de cassation's plenary sessions which are now called the Assemblée plénière, used to be called the Chambres réunies; until 1947 the Cour de cassation possessed a Chambre des

requêtes which acted as a filter for the main court. The Chambre mixte sits to resolve divergences of interpretation and case law.
