Her own books include *African American Mystery Writers: A Historical and Thematic Study* (McFarland, 2008) and *Wicked Albany: Lawlessness & Liquor in the Prohibition Era* (The History Press, 2009). Bailey is the author of a mystery series and the 2009–2010 Executive Vice President of Mystery Writers of America.

Joel Black teaches film and comparative literature at the University of Georgia. Noir*, *The Vampire Film*, *More Things than Are Dreamt Of*, *Film Noir* (Taschen) and directed studies of David Lean, Robert Aldrich, and Roger Corman with Alain Silver. His other books include *Modern Amazons*, *Cinema of Obsession*, and monographs on Bogart, Dietrich, Elizabeth Taylor, Mae West, and Robert DeNiro for the Taschen Icon series. A bilingual reprint of his seminal book on Preston Sturges was published by the San Sebastián Film Festival. Articles have appeared in *Photon*, *Cinefantastique*, *Midnight Marquee*, and the *DGA Magazine*. His DVD commentaries include *Out of the Past*, *The Dark Corner*, *Nightmare Alley*, *Lady in the Lake*, *Kiss of Death*, *Brute Force* and *Crossfire*. He holds a Masters from UCLA, has been a producer on feature films and documentaries, and lectured on film-making at UCLA and at other colleges in the Los Angeles area where he works as an educator.

Heather Worthington is Senior Lecturer in English Literature at Cardiff University, where she teaches nineteenth- and twentieth-century crime fiction and children's literature. The author of *The Rise of the Detective in Early Nineteenth-Century Popular Fiction* (Palgrave, 2005), she is currently working on a second monograph, *Shadowing Sherlock Holmes: Crime Fiction 1850–1900*. She has also written on T. H. White's *The Once and Future King*, Bulwer-Lytton's early fiction, and Chesterton's *The Man Who Was Thursday*.
