## PREFACE

For over a century lawyers have prophesied or asserted the demise of Equity. Yet it continues to flourish. Australian lawyers can, justly, claim some responsibility in this. In a country still not well endowed with legal text books, the writings on Equity stand out as a notable exception. The last ten years or so have witnessed the advent of more than half a dozen works which together have illuminated much of Equity jurisprudence. Over the same period there has been a revitalised interest in, and utilisation of, equitable doctrines, remedies and institutions. One need only point to the vogue of the trading trust and to the burgeoning of equitable intervention in contract. More important, perhaps, is the renewed judicial appreciation of Equity's potency—an appreciation which is unshackling the restraints the late nineteenth and early twentieth century lawyers imposed upon equitable doctrine, and which is developing doctrine to meet new concerns. One can, doubtless, point to instances where the judges may have faltered. *Allen v. Snyder* [1977] 2 N.S.W.L.R. 685 is a contentious example. But it is in the High Court where old orthodoxies have been reappraised, new doctrines established or foreshadowed. The list of recent equity decisions is impressive and growing, and includes *Commonwealth v. John Fairfax & Sons Ltd* (1981) 55 A.L.J.R. 45; *Taylor v. Johnson* (1983) 151 C.L.R. 422; *Hewett v. Court* (1983) 149 C.L.R. 639; *Legione v. Hateley* (1983) 57 A.L.J.R. 292; *Commercial Bank of Australia v. Amadio* (1983) 151 C.L.R. 447; *Heid v. Reliance Finance Corporation Pty Ltd* (1983) 57 A.L.J.R. 683; *Chan v. Zacharia* (1984) 58 A.L.J.R. 353 and *Hospital Products Ltd v. United States Surgical Corporation* (1984) 58 A.L.J.R. 587.

This book is something of a reflection of the last decade. It is an outcome of a seminar on Equity held at the Australian National University in May 1984 which brought together for the first time a group of judges, writers, practitioners and academics who, in one role or another, have contributed to fostering an understanding of Equity jurisprudence in Australia. Save for the concluding essay, each was commented upon, discussed and criticised at the seminar, and then revised in light of the commentaries. While each author accepts responsibility for the views, etc. expressed in his own contribution, the volume itself embodies the ideas, suggestions and criticisms of all the participants at the seminar.
