The Cl list furnished by the War Department of Japanese who were possible war criminal suspects, carried among other names, the listing of Hachiro Arita, reputably the head of the "Twenty-Year War Society". He was an advisor with Shinnin rank of the Cabinet Advisory Board since July. 1963. Among other duties he was Foreign Affairs Minister in 1939-h0: a leading expansionist as Foreign Minister and an Ardent Nationalist. He was born in 1884 and the last known address was 1426 1-Chome, Shimo, Ochial Yodobashi-Ku, Tokyo.

Due to the prominent position he carried in the "Twenty-Year War Society", copies of this report are being designated for File 250, Captioned Patriotic Societies.

UNDEVELOPED LEADS: Obtain full biographical background of subject in order that a thorough and intelligent interrogation may be conducted of this individual with specific analysis placed upon the aims and obligations of the "Twenty-Year War Society"; the names of the individuals who confirmed the idea of the Society and the location of any and all records of same.

An examination of the CIS files discloses the following information regarding the Subject, which was obtained from a publication of the Military Intelligence Division, dated 10 August 1945:

Officially reported to have chosen to go to Austria as Minister in preference to subscribing to Japan's policy in Manchuria. Later gained the Army's confidence and as a foreign minister supported a policy of expansionism in Asia, compared with which Manchuria was child's play. Reputed to have reached high position through shrewdness and common sense rather than because of brilliant diplomatic gifts. Apparently able to temper aggressiveness of militarists in dealing with foreign nations without antagonizing former.

Ambassador Grew in "Ten Years in Japan" reveals ARITA as always friendly and at times even sympathetic, but habitually cautious. However, in December 1938, told Ambassador Grew he would rather call a spade a spade and not try to reconcile principles against realities as did his predecessor. In April 1940 flatly stated negotiations for new trade treaty (to replace one denounced by United States) were futile in view of wide divergence of Japanese and American views.

Japan and Germany concluded the Anti-Comintern Pact while ARITA was foreign Minister in Hirota Cabinet. Was spokesman for "New Order in East Asia" under premiers Konoye and Hiranuma. As foreign minister in Yonai cabinet, issued statement 29 June 1940 proposing division of world into spheres of influence in each of which one nation would exert supremacy, Japan to be "stabilizing force in East Asia". Stressed close ties of peoples of East Asia and South Seas, pointing out inevitability of all uniting in one sphere, their desting being of grave concern to Japan.

Radio Tokyo on March 27, 1945, announced ARITA was heading a group of eight (8) prominent civilians in organizing the "20 Year War Society".

The following information regarding the Subject was obtained from the card files of CIS:

ARITA, Hachiro is associated with the national activities committee designed to study the ways and means of carrying on the present war against the Anglo-Americans for 20 years.

Is a cabinet advisor with a long record of high position in the foreign office. Former Minister under Hirota (April 1936 to February 1937), Konoye (October 1938 to January 1939), Hiranuma (January 1939 to August 1939) and Yonai (January 1940 to July 1940). He was a foreign minister when the following pacts were signed: Japan-Germany Anti-Comintern, November 25, 1936; Japan-Germany Cultural, November 1938; he holds positions in the FAA and NGAA.

Member of the Association for the 20 Years War, inaugural meeting held 27 March 1945; appears to be for the purpose of publicizing the necessity of a long war.

The following information regarding the Subject was obtained from the OWI publication, dated 25 July 1945:

February 1936—Ambassador to China for a brief period in succession to Ambassador Anyoshi. "This was the difficult period of negotiation with Chiang Kai Shek, which followed the outburst of a series of Anti-Japanese incidents in China." (Japan Advertiser, 30 October 1938).

February 1937—Foreign Minister in Hirota Cabinet. Japan-Germany Anti-Comintern Pact signed 25 November 1936. "Has been interested ever since in strengthening the Anti-Comintern Pact." (Japan Advertiser, 30 October 1938).

ARITA's name has not appeared on any published list of war criminal suspects, and he has not been interned.
