PREFACE

This bulletin of copyright decisions is the twenty-fourth in a series compiled by the Copyright Office for official and public use. Substantially all copyright cases, as well as those dealing with related subjects in the field of intellectual property, which have been decided during the years 1975 and 1976 in the federal and state courts have been included.

The first citation listed under the name of the case is the source from which the case was reprinted. Most of the citations are to the *National Reporter System*, issued by the West Publishing Company and to the *United States Patents Quarterly*, published by the Bureau of National Affairs. The publishers of these reporters have kindly granted permission to use their syllabi and these are printed in full to facilitate the work of those who consult the bulletins. "See also" references, enclosed in brackets, have been provided to assist in referring to earlier or subsequent phases of the same or connected litigation.

A supplemental list of cases, which do not directly involve copyright, but may be of related interest, have been included in the appendix of the bulletin. These cases were also decided during 1975-76. Certain features of the cases have been summarized by Benjamin W. Rudd and Wilma S. Davis.
