# The Author



Prof. Dr Márta Dezső (born 8 February 1950) studied law at Eötvös Loránd University, Budapest, Hungary (1968–1973). She obtained a Cs.C. (now Ph.D.) degree from the Hungarian Academy of Sciences in 1994, based on a thesis on electoral systems and political representation. Eötvös Loránd University granted her the title, Dr Habil in 2003, based in part on the publication, 'The Role and Influence of Referendums on Governmental Systems'.

She was a research fellow at the Institute for Legal Studies of the Hungarian Academy of Sciences (1973–1990). Since 1990, she has been a lecturer at the Department of Constitutional Law, Faculty of Law and Political Sciences,

Eötvös Loránd University. In 1994, she was appointed Associate Professor and since 2005, has been a Professor of Constitutional Law at Eötvös Loránd University.

Since 1990, Professor Dezső has been advisor to several institutions: the Hungarian National Electoral Committee, the Ministry of Justice, and the Parliamentary Commission for the Drafting of a New Constitution (1996–1998). She represented the Association of Central and Eastern European Election Officials at the Commission of Venice, Council for Democratic Elections (2000–2005). She was involved as expert in the elaboration of several statutes in Hungary, including the Parliamentary Election Act, the Act on Referendum, the Hungarian Citizenship Act, and the Act on the Hungarian Academy of Sciences.

She has participated in a number of international academic cooperation programmes as well as international conferences, mainly on electoral systems. She has written several books and numerous articles in the field of constitutional law, European Community law, and human rights.

At present Professor Dezső is head of the Department of Constitutional Law, Faculty of Law and Political Sciences, Eötvös Loránd University. Since 1998 she has been Vice Dean in charge of international relations. She is a member of several scholarly societies, and president of the editorial board of the bilingual periodical, Annales Universitatis Scientiarum Budapestiensis de Rolando Eötvös Nominatae, Sectio iuridica.
