本指南是一部关于 SSCI(社会科学引文索引)和 A&HCI(艺术与人文引文索引)收录期刊投稿地址方面的大型工具书,正文收录 2 800 余种期刊最新的投稿联系信息,包括英文刊名、刊期、国际标准号、中文刊名、收录内容、出版社地址、联系电话、电子邮件地址以及投稿要求等。为方便读者查阅,编写了按学科专业分的中、英文主题索引。并收录了各期刊的影响因子及美国科学信息研究所的其他产品信息。本指南可供广大科技工作者、大专院校师生以及情报、翻译、编辑人员使用。

前 言

在社会科学和人文艺术的研究工作及科研管理工作中,我们经常遇到一些作者咨询社会科学期刊和人文艺术期刊,尤其是《社会科学引文索引》(Social Science Citation Index,简称 SSCI)和《艺术与人文引文索引》(Arts & Humanities Citation Index,简称 A&HCI)收录期刊投稿地址等方面的问题。究其原因:一是我国高等学校和科研机构的大量科研成果迫切需要推向世界,与国际同行交流;二是国内至今尚无能够全面系统地介绍国际上相关学科一流学术期刊投稿联系方式的工具书;三是目前国内对国际上一流学术期刊的利用不足,因经费短缺,很多科研单位及高校只订购了很少的外文期刊,所以当科研工作者需要查找有关的外文期刊和工具书时,常常遇到很多困难。

SSCI 和 A&HCI 所收录的期刊,一般都是国际上相关学科中的权威期刊,得到了国际学术界、图书情报界、出版界、科研管理部门的广泛认同。SSCI 和 A&HCI 所提供的某一论文被引频率的高低,通常在一定程度上反映了该论文在某一学科领域的学术水平。因此,我国科研管理部门、科研机构和各高等学校以及广大科研工作者,越来越重视在 SSCI 和 A&HCI 发表科研论文。为了适应我国社会科学和人文艺术科学迅猛发展的新形式,为了满足我国科研工作者向 SSCI 和 A&HCI 收录期刊投稿的需要,我们经过多方调查研究,组织力量搜索和查阅了大量有关文献信息资料,经过一年多的努力,编辑了这本《SSCI 和 A&HCI 收录期刊投稿信息指南》。

在资料收集、编辑过程中,我们遵循实事求是的科学态度,坚持尽量详细、信息新且准确的原则,收编了截至 2003 年 2 月底网上和现刊上的 2 800 余种 SSCI 和 A&HCI 来源出版物中的 2 700 余种刊物的投稿联系信息。虽然本工具书中仍有少量出版物未能收集到联系信息,但那些大多是特邀撰稿人的专题论文丛书或

会议录、会议文摘等无相对固定投稿联系信息的出版物。尽管本工具书尚有不足之处,然而它毕竟填补了国内没有全面提供社会科学、人文艺术各学科期刊投稿联系信息方面的工具书之空白,是一本很有实用价值的工具书。我们希望本书的出版能为我国广大科研工作者向国内外优秀科技期刊投稿提供方便,为扩大我国科学研究成果的国际影响,提高我国在国际上的学术地位发挥作用。

本工具书在制定计划、收集资料以及编写过程中,得到了武汉大学社会科学部、信息管理学院的关心和支持,得到了教师和学生的帮助和参与,特别是武汉大学社会科学部极为重视此项研究工作,特为此立项,为这一工作的进行提供了基本条件,在此深致谢意。本书收录期刊的中文介绍,部分参考使用了中国图书进出口总公司编写的《外国报刊目录》的内容,在此一并致谢。

由于编写时间仓促、经验不足,书中难免存在某些缺陷,欢迎读者批评指正,以便将来再版时更加完善。

2. 正文部分按出版物名称的英文字母顺序排列, 其中 and, in, on, of, the 等连词、介词、冠词亦参加排列。

3. 本指南收入了 2 800 余种期刊最新准确的投稿联系信息, 包括出版社、编辑部、编者的通讯地址、电话、传真号码及电子邮件地址等。如期刊《ACTA SOCIOLOGICA》, 它的投稿联系信息如下:

4. 本指南所提供的信息,绝大部分是从互联网上查找到的,少数是从2002年期刊上摘录的信息。书中少量未能提供信息的出版物中,主要是进展丛书、专题论文丛书、会议录或论文摘要类出版物。这些进展丛书、专题论文丛书大多数是由编辑部或主编直接特约撰稿人撰稿,而会议录丛书或摘要的投稿联系信息则要根据有关会议主办者的会议征文而定。在未能提供投稿联系信息的出版物中,属于期刊的为数甚少。

5. 考虑到读者全面了解或从学科主题角度查找所需学科专业领域的需要,我们编制了中、英文主题索引,读者可由此查找到相关学科的主题及期刊,并可按页码查看具体的信息内容。

6. 为方便读者全面了解 SSCI 和 A&HCI 历年收录概况、SSCI 和 A&HCI 及 ISI 的其他数据库收录我国各学科期刊的情况、各种期刊的影响因子以及 ISI 的其他信息产品等情况,我们在书末编入了相应的附录,以备用时参考。

WRITER'S GUIDELINES

The ABA Journal is the official publication of the American Bar Association. It is published 12 times a year. The Journal is distributed to more than 370,000 readers nationwide. Its content is designed to appeal to the association diverse membership, with some emphasis on general practitioners in smaller law firms. In writing an article for possible publication in the Journal, please be familiar with the following guidelines.

Type of article. The focus of the Journal is on current events in the law and on ideas that will help lawyers to practice better and more efficiently. Articles should emphasize practical, rather than theoretical or esoteric material.

Readership. As you write, keep your audience in mind. The typical reader of the Journal is a lawyer whose age is 43, who is in private practice in a law firm of five to 10 lawyers. Most are general practitioners.

Writing Style. The Journal is a magazine that covers topical issues involving lawyers. Please avoid the style of law reviews, academic journals or legal briefs. Articles should be written in an informal, journalistic style. Short quotations from people and specific examples will improve an article.

Length. Feature articles should be no longer than 3,000 words. News stories or departments such as Focus are generally 750 words.

Title. Developing a working title for an article may help you keep it in focus. The working title may be accepted as is or altered by the Journal staff as it deems appropriate.

Editing. All articles are subject to editing by the Journal. All articles are edited to conform to the Journal editorial style, which generally follows the AP Stylebook. The Journal inserts subheads, captions and readouts as needed.

Copyright. By having an article published in the Journal, authors thereby grant all property rights in the article to the American Bar Association and consent to an unqualified right by the ABA to copyright the work. This grant includes the right of the ABA to republish the article in other media, including electronic databases. This applies unless other arrangements are made in writing.

Citations. Citations to cases and other materials should

be incorporated into the text; footnotes are not permitted.

Structure. It is suggested that articles open with an interesting catchy lead, followed by a "nut paragraph" that tersely states the gist of the article.

Biographical data. At the end of an article, give your name, whether you are a lawyer, your place of employment, and whether you serve on an ABA committee or other entity. This data may be shortened.

Manuscripts. Manuscripts should be typewritten in a standard font (not all italics or all capitals) and double spaced. A cover letter should accompany the manuscript, indicating your name, address and telephone number. You also can submit your article via e-mail to cassensd@staff.abanet.org. Attachments should be in Text or ASCII format. You will be notified within four weeks if the Journal will publish the article.

Graphics. The Journal obtains appropriate artwork or photographs, if any, to illustrate article

MANUSCRIPT GUIDELINES AND EDITORIAL POLICIES

The Executive, published quarterly by the Academy of Management, seeks articles that capture an executive's attention by providing useful information that stimulates new ways of thinking about managing and leading. Only articles that are thoroughly grounded in accepted theory, research, or practice are sought.

The Executive's goals are:

1. To provide fresh ideas and perspectives, grounded in recent advances in management theory and research, on contemporary issues that managers and executives must face.

2. To become a primary source of useful ideas for those who seek to educate present and future managers and executives.

3. To become a forum through which practicing managers and executives can challenge the meaningfulness of our translations of management theory and research.

Contributors are encouraged to interact with executives to conceive ideas for an article. This may lead to a jointly authored manuscript or an interview preceded and followed by commentary written by the interviewer. The commentary would provide the linkage to theory and/or research and implications for managers in similar situations.

A typical article might begin with either a brief case illustrating the primary theme, or posing certain questions and issues that our readers undoubtedly face (or perhaps need to address), or some other beginning that will stimulate a busy person to want to read further. A typical article <usb>will also satisfy the academic reader who seeks more than just opinions and wants to see a serious effort at connecting ideas to accepted theory and research.

With respect to style and format, manuscripts should: be written in clear, straightforward language, avoiding jargon and technical terms, include at the beginning an Executive Overview of approximately 200 words,

use subheadings, but not the traditional ones such as "Introduction"; use instead, "The Future Challenge" or "Does TQM have a future?" for the purpose of documentation, cite notes in the body of the paper using superscript note numbers, include at the end of the manuscript a section entitled "Endnotes." It is imperative that authors document their work as thoroughly as possible, yet not bore the reader with endless lists of references. This section should include references that support claims made in the body of the manuscript and, in some cases, might be written like the body of the manuscript itself; i.e., in simple prose, not as an exhaustive listing of references. Essentials only should be provided, not a complete bibliography of an entire body of literature. Samples of our endnote style are available on request from the managing editor, Jerry Oster, at the address below.

Authors are encouraged to get feedback from colleagues and practitioners on early drafts. A paper can be improved dramatically when knowledgeable reviewers are asked for reactions in advance of submission.

Manuscripts should be double-spaced, and no more than 30 pages in length, including figures. When questions arise regarding issues of grammar or style,

authors should refer to the University of Chicago Press Manual of Style. The name(s) of the author(s) should not appear anywhere on the manuscript, except on the title page.

The Executive is published in February, May, August, and November.

Generally, manuscripts are reviewed by the Editor and then sent to an Associate Editor to solicit two blind reviews. In some cases, a manuscript may be returned without review if judged to be inappropriate for publication in The Executive.

Authors should expect reviews to take from 60 to 90 days after receipt of their manuscript. If their manuscript is accepted for publication, authors should also expect to submit their final draft on a 3.5" diskette.

Contributors should use surface mail to submit one electronic copy of their manuscript, along with one paper copy. The electronic copy should be on a 3.5 inch diskette, in MS-Word 6.0 or 7.0 or WordPerfect for Windows. No Mac diskettes, please.

Submission of Papers

Authors are requested to submit their original manuscript and figures with three copies either to the Editor-in-Chief: F.A. Haight (all subject areas), Institute of Transport Studies, University of California, Irvine, CA 92697-3600, USA; or to one of the Associate Editors: R. Submission of a paper implies that it has not been published previously, that it is not under consideration for publication elsewhere, and that if accepted it will not be published elsewhere in the same form, in English or in any other language, without the written consent of the publisher.

Manuscript Preparation

General: Manuscripts must be typewritten, double-spaced with wide margins on one side of white paper. Good quality printouts with a font size of 12 or 10 pt are required. The corresponding author should be identified (include a Fax number and E-mail address). Full postal addresses must be given for all co-authors. Authors should consult a recent issue of the journal for style if possible. An electronic copy of the paper should accompany the final version. The Editors reserve the right to adjust style to certain standards of uniformity. Authors should retain a copy of their manuscript since we cannot accept responsibility for damage or loss of papers. Original manuscripts are discarded one month after publication.

Abstract: This should describe in straightforward language the contents of the paper, but not its motivation. It should explain briefly the procedures and results, and must not contain abbreviations and acronyms.

Text: Follow this order when typing manuscripts: Title, Authors, Affiliations, Abstract, Keywords (list up to six), Main text, Acknowledgements, Appendix, References, Figure Captions and then Tables. Do not import the Figures or Tables into your text. The corresponding author should be identified with an asterisk and footnote. All other footnotes (except for table footnotes) should be identified with superscript Arabic numbers. Do not under any circumstances use "bullets" (whether oversize dots, or dashes) to set out items in a list. Use (a), (b), ... and if possible incorporate the list into ordinary paragraphing.

Units: Authors are seriously recommended to use SI (metric) units in their manuscripts, with optional English equivalents in parentheses.

References: All publications cited in the text should be presented in a list of references following the text of the manuscript. In the text refer to the author's name (without initials) and year of publication (e.g. "Since Peterson (1993) has shown that..." or "This is in the agreement with results obtained later (Kramer, 1994)"). For three or more authors use the first author followed by "et al.", in the text. The list of references should be arranged alphabetically by authors' names. The manuscript should be carefully checked to ensure that the spelling of authors' names and dates are exactly the same in the text as in the reference list.

References should be given in the following form:

Illustrations: All illustrations should be provided in camera-ready form, suitable for reproduction (which may include reduction) without retouching. Photographs, charts and diagrams are all to be referred to as "Figure(s)" and should be numbered consecutively in the order to which they are referred. They should accompany the manuscript, but should not be included within the text. All illustrations should be clearly marked on the back with the figure number and the author's name. All figures are to have a caption. Captions should be supplied on a separate sheet.

Line drawings: Good quality printouts on white paper produced in black ink are required. All lettering, graph lines and points on graphs should be sufficiently large and bold to permit reproduction when the diagram has been reduced to a size suitable for inclusion in the journal. Dye-line prints or photocopies are not suitable for reproduction. Do not use any type of shading on computer-generated illustrations.

Photographs: Original photographs must be supplied as they are to be reproduced (e.g. black and white or colour). If necessary, a scale should be marked on the photograph. Please note that photocopies of photographs are not acceptable.

Colour: Authors will be charged for colour at current printing costs.

Tables: Tables should be numbered consecutively and given a suitable caption and each table typed on a separate sheet. Footnotes to tables should be typed below the table and should be referred to by superscript lowercase letters. No vertical rules should be used. Tables should not duplicate results presented elsewhere in the manuscript, (e.g. in graphs).

Electronic Submission

Authors should submit an electronic copy of their paper with the final version of the manuscript. The electronic copy should match the hardcopy exactly. Always keep a backup copy of the electronic file for reference and safety. Proofs

Proofs will be sent to the author (first named author if no corresponding author is identified of multi-authored papers) and should be returned within 48 hours of receipt. Corrections should be restricted to typesetting errors; any others may be charged to the author. Any queries should be answered in full. Please note that authors are urged to check their proofs carefully before return, since the inclusion of late corrections cannot be guaranteed. Twenty-five offprints will be supplied free of charge. Guide for Authors

Submission of Papers

Authors are requested to submit their original manuscript and figures plus two copies to the **Editor-in-Chief of Accounting, Organizations and Society: Anthony G. Hopwood, Said Business School, 59 George Street, Oxford OX1 2BE, UK.**

Submission of a paper implies that it has not been published previously, that it is not under consideration for publication elsewhere, and that if accepted it will not be published elsewhere in the same form, in English or in any other language, without the written consent of the publisher. The contribution of the author(s) should be an original one and should in no way violate any existing copyright, and it should contain nothing of a libellous or scandalous nature.

Types of Contributions

Original papers; review articles; short communications; reports of conferences and meetings; book reviews; letters to the editor; forthcoming meetings; selected bibliography.

Manuscript Preparation

General: Manuscripts must be typewritten, double-spaced with wide margins on one side of white paper. Good quality printouts with a font size of 12 or 10 pt are required. A cover page should give the title of the manuscript, the author's name, position and institutional affiliation, and an acknowledgement, if

desired. The title of the manuscript, but not the authors names, should appear on the first page of the text. The corresponding author should be identified (include a Fax number and E-mail address). Full postal addresses must be given for all co-authors on the cover sheet. Authors should consult a recent issue of the journal for style if possible. An electronic copy of the paper should accompany the final version. The Editors reserve the right to adjust style to certain standards of uniformity. Authors should retain a copy of their manuscript since we cannot accept responsibility for damage or loss of papers. Original manuscripts are discarded one month after publication unless the Publisher is asked to return original material after use.

Abstract and Index: Three copies of an abstract not exceeding 80 words should accompany each manuscript submitted. Authors are also asked to supply a maximum of 10 keywords or phrases which will be used for indexing purposes.

Text: Follow this order when typing manuscripts: Title, Authors, Affiliations, Abstract, Keywords, Main text, Acknowledgements, Appendix, References, Vitae, Figure Captions and then Tables. Do not import the Figures or Tables into your text but supply them as separate files. The corresponding author should be identified with an asterisk and footnote. All other footnotes (except for table footnotes) should be identified with superscript Arabic numbers. Footnotes for clarification or elaboration should be used sparingly.

Research Instruments: If the manuscript refers to questionnaires or other research instruments which are not fully reproduced in the text, authors must also submit three copies of the complete research. Because of space limitations, questionnaires and other research instruments sometimes may not be fully reproduced in the published paper. When they are not fully reproduced a note must be inserted in the text of the paper indicating the address from which copies of the complete instrument are available.

References: All publications cited in the text should be present in a list of references following the text of the manuscript. The work should be cited by author's name and year of publication in the body of the text, e.g. (Watson, 1975); or when reference is made to a specific page (Wilkes & Harrison, 1975, p. 21). Where the author's name is included in the text, the name should not be repeated in the reference citation: e.g. "Angrist (1975, p. 79) says...". For identification purposes, the suffix a, b, etc. should follow the date when the bibliography contains more than one work published by an author in a single year. For 2-6 authors, all authors are to be listed at first citation, with "&" separating the last two authors. For more than six authors, use the first six authors followed by et al. In subsequent citations for three or more authors use author et al. in the text. The list of references should be arranged alphabetically by authors' names. The manuscript should be carefully checked to ensure that the spelling of authors names and dates are exactly the same in the text as in the reference list. Each reference should contain full bibliographical details and journal titles should not be abbreviated. References should be given in the following form:

Illustrations: All illustrations should be provided in camera-ready form, suitable for reproduction (which may include reduction) without retouching. Photographs, charts and diagrams are all to be referred to as "Figure(s)" and should be numbered consecutively in the order to which they are referred. They should accompany the manuscript, but should not be included within the text. All illustrations should be clearly marked on the back with the figure number and the author's name. All figures are to have a caption. Captions should be supplied on a separate sheet at the end of the paper. The author should clearly indicate in the text where he or she would like each figure to be placed.

Line drawings: Good quality printouts on white paper produced in black ink are required. All lettering, graph lines and points on graphs should be sufficiently large and bold to permit reproduction when the diagram has been reduced to a size suitable for inclusion in the journal. Dye-line prints or photocopies are not suitable for reproduction. Do not use any type of shading on computer-generated illustrations.

Photographs: Original photographs must be supplied as they are to be reproduced (e.g. black and white or colour). If necessary, a scale should be marked on the photograph. Please note that photocopies of photographs are not acceptable.

Colour: Authors will be charged for colour at current printing costs.

Tables: Tables should be numbered consecutively and given a suitable caption and each table typed on a separate sheet. Footnotes to tables should be typed below the table and should be referred to by superscript lowercase letters. No vertical rules should be used. Tables should not duplicate results presented elsewhere in the manuscript, (e.g. in graphs). The author should clearly indicate in the text where he or she would like each table to be placed.

Electronic Submission

Authors should submit an electronic copy of the final version of their paper with the final version of the manuscript. The electronic copy should match the hardcopy exactly. Please specify what software was used, including which release, and what computer was used (IBM compatible PC or Apple Macintosh). Always keep a backup copy of the electronic file for reference and safety. Full details of electronic submission and formats can be obtained from <http://www.elsevier.nl/locate/disksub> or from Author Services at Elsevier Science.

Proofs

Proofs will be sent to the author (first named author if no corresponding author is identified of multi-authored papers) and should be returned within 48 hours of receipt. Corrections should be restricted to typesetting errors; any others may be charged to the author. Any queries should be answered in full. Please note that authors are urged to check their proofs carefully before return, since the inclusion of late corrections cannot be guaranteed. Proofs are to be returned to the Log-in Department, Elsevier Science, Stover Court, Bampfylde Street, Exeter, Devon EX1 2AH, UK.

Offprints

Twenty-five offprints will be supplied free of charge. Offprints and copies of the issue can be ordered at a specially reduced rate using the order form sent to the corresponding author after the manuscript has been accepted. Orders for reprints (after publication) will incur a 50% surcharge.

Copyright

All authors must sign the "Transfer of Copyright" agreement before the article can be published. This transfer agreement enables Elsevier Science Ltd to protect the copyrighted material for the authors, but does not relinquish the author's proprietary rights. Editorial Policy

According to the policies set by the Publications Committee (which were endorsed by the Executive Committee and were published in the Accounting Education News, June 1987), The Accounting Review "should be viewed as the premier journal for publishing articles reporting the results of accounting research and explaining and illustrating related research methodology. The scope of acceptable articles should embrace any research methodology and any accounting-related subject, as long as the articles meet the standards established for publication in the journal....No special sections should be necessary. The primary, but not exclusive, audience should be as it is now-academics, graduate students, and others

interested in accounting research."

The primary criterion for publication in *The Accounting Review* is the significance of the contribution an article makes to the literature.

The efficiency and effectiveness of the editorial review process is critically dependent upon the actions of both authors submitting papers and the reviewers. Authors accept the responsibility of preparing research papers at a level suitable for evaluation by independent reviewers. Such preparation, therefore, should include subjecting the manuscript to critique by colleagues and others and revising it accordingly prior to submission. The review process is not to be used as a means of obtaining feedback at early stages of developing the research.

Reviewers and associate editors are responsible for providing critically constructive and prompt evaluations of submitted research papers based on the significance of their contribution and on the rigor of analysis and presentation. Associate editors also make editorial recommendations to the editor.

Manuscript Preparation and Style

The *Accounting Review's* manuscript preparation guidelines follow (with a slight modification) the B-format of the *Chicago Manual of Style* (14th ed.; University of Chicago Press). Another helpful guide to usage and style is *The Elements of Style*, by William Strunk, Jr., and E. B. White (Macmillan). Spelling follows Webster's International Dictionary.

Format

All manuscripts should be typed on one side of 8 1/2 x 11" good quality paper and be double spaced, except for indented quotations.

Manuscripts should be as concise as the subject and research method permit, generally not to exceed 7,000 words.

Margins of at least one inch from top, bottom and sides should facilitate editing and duplication.

To promote anonymous review, authors should not identify themselves directly or indirectly in their papers or in experimental test instruments included with the submission. Single authors should not use the editorial "we."

A cover page should show the title of the paper, the author's name, title and affiliation, email address, any acknowledgements, and a footnote indicating whether the author(s) would be willing to share the data (see last paragraph in this statement).

Pagination: All pages, including tables, appendices and references, should be serially numbered. The first section of the paper should be untitled and unnumbered. Major sections may be numbered in Roman numerals. Subsections should not be numbered.

Numbers: Spell out numbers from one to ten, except when used in tables and lists, and when used with mathematical, statistical, scientific, or technical units and quantities, such as distances, weights and measures. For example: three days; 3 kilometers; 30 years. All other numbers are expressed numerically. Percentages and Decimal Fractions: In nontechnical copy use the word percent in the text.

Hyphens: Use a hyphen to join unit modifiers or to clarify usage. For example: a well-presented analysis; re-form. See Webster's for correct usage. **Key Words:** The abstract is to be followed by four key words that will assist in indexing the paper.

Abstract / Introduction

An Abstract of about 100 words should be presented on a separate page immediately preceding the text. The Abstract should concisely inform the reader of the

manuscript's topic, its methods and its findings. Key Words and the Data Availability statements should follow the Abstract. The text of the paper should start with a section labeled "I. Introduction," which provides more details about the paper's purpose, motivation, methodology and findings. Both the Abstract and the introduction should be relatively non-technical, yet clear enough for an informed reader to understand the manuscript's contribution. The manuscript's title, but neither the author's name nor other identification designations, should appear on the Abstract page.

Tables and Figures

The author should note the following general requirements:

Each table and figure (graphic) should appear on a separate page and should be placed at the end of the text. Each should bear an Arabic number and a complete title indicating the exact contents of the table or figure.

A reference to each graphic should be made in the text. The author should indicate by marginal notation where each graphic should be inserted in the text.

Graphics should be reasonably interpreted without reference to the text.

Source lines and notes should be included as necessary.

Equations: Equations should be numbered in parentheses flush with the right-hand margin.

Documentation

Citations: Work cited should use the "author-date system" keyed to a list of works in the reference list (see below). Authors should make an effort to include the relevant page numbers in the cited works.

In the text, works are cited as follows: authors' last name and date, without comma, in parentheses: for example, (Jones 1987); with two authors: (Jones and Freeman 1973); with more than two: (Jones et al. 1985); with more than one source cited together (Jones 1987; Freeman 1986); with two or more works by one author: (Jones 1985, 1987).

Unless confusion would result, do not use "p." or "pp." before page numbers: for example, (Jones 1987, 115).

When the reference list contains more than one work of an author published in the same year, the suffix a, b, etc. follows the date in the text citation: for example, (Jones 1987a) or (Jones 1987a; Freeman 1985b).

If an author's name is mentioned in the text, it need not be repeated in the citation; for example, "Jones (1987, 115) says...."

Citations to institutional works should use acronyms or short titles where practicable; for example, (AAA ASOBAT 1966); (AICPA Cohen Commission Report 1977). Where brief, the full title of an institutional work might be shown in a citation: for example, (ICAEW The Corporate Report 1975).

If the manuscript refers to statutes, legal treatises or court cases, citations acceptable in law reviews should be used.

Reference List: Every manuscript must include a list of references containing only those works cited. Each entry should contain all data necessary for unambiguous identification. With the author-date system, use the following format recommended by the *Chicago Manual*:

Arrange citations in alphabetical order according to surname of the first author or the name of the institution responsible for the citation.

Use author's initials instead of proper names.

Date of publication should be placed immediately after author's name.

Titles of journals should not be abbreviated.

Multiple works by the same author(s) in the same year are distinguished by letters after the date.

Inclusive page numbers are treated as recommended in Chicago Manual section 8.67.

Footnotes: Footnotes are not used for documentation. Textual footnotes should be used only for extensions and useful excursions of information that if included in the body of the text might disrupt its continuity. Footnotes should be consecutively numbered throughout the manuscript with superscript Arabic numerals. Footnote text should be doubled-spaced and placed at the end of the article.

Submission of Manuscripts

Authors should note the following guidelines for submitting manuscripts:

Manuscripts currently under consideration by another journal or publisher should not be submitted. The author must state that the work is not submitted or published elsewhere.

In the case of manuscripts reporting on field surveys or experiments, four copies of the instrument (questionnaire, case, interview plan or the like) should be submitted. Information that might identify the author(s) must be deleted from the instrument.

Four copies should be submitted together with a check in U.S. funds for \$75.00 for members or \$100.00 for nonmembers of the AAA made payable to the American Accounting Association. Effective January 1990, the submission fee is nonrefundable.

The author should retain a copy of the paper.

Revisions must be submitted within 12 months from request, otherwise they will be considered new submissions.

Permission is hereby granted to reproduce any of the contents of the Review for use in courses of instruction, as long as the source and American Accounting
