## 前　　言

1992年4月，我国第一部全面的、综合性的保障妇女权益、促进男女平等的基本法《中华人民共和国妇女权益保障法》（以下简称《妇女权益保障法》），经第七届全国人民代表大会第五次会议审议通过，同年10月1日起施行。这部凝聚着我国数十年妇女运动经验的专门法律颁布实施后，在全社会引起了强烈反响，也受到世界的瞩目，这是我国加强社会主义民主和法制建设的又一重大成果。

乔石同志多次强调，法律制定后，还必须坚决贯彻执行，如果我们制定的法律得不到实施，实际上等于没有法；并提出，常委会要继续把法律实施情况的检查监督放在同立法同等重要位置。《妇女权益保障法》施行两年来，各地人大及其常委会充分发挥国家权力机关的作用，积极探索，勇于实践，普遍制定了《妇女权益保障法》实施办法；法规注重解决当地的实际问题，具有较强的针对性和可操作性，受到欢迎。在监督方面，注意了强化执法监督的力度和实效，加强了执法检查和人民代表的视察、调查及舆论监督，促进了政府及有关部门的执法工作，推动法律的深入贯彻实施。妇女的参政状况有所改善，政治地位逐步提高，妇女的劳动、文化、财产、婚姻家庭权益和人身权利的保障工作有了长足进步。同时，我们也要看到，贯彻实施《妇女权益保障法》任重而道远，必须继续发挥各级人大及其常委会的监督职能作用，不断总结经验，开拓进取，使保障妇女权益、实现男女平等的妇女事

业不断登上新的台阶，取得更大的成绩。

《人大与妇女权益保障》一书，汇集了全国29个省、自治区、直辖市人大内务司法委员会（法制委员会、政法委员会）贯彻实施《妇女权益保障法》的经验文章；28个省、自治区、直辖市和深圳经济特区人大常委会通过的《妇女权益保障法》实施办法；还收集了宪法和部分法律、法规。这本书是各级人大及其常委会贯彻实施《妇女权益保障法》的经验集锦，是加强保障妇女权益地方性立法成功实践的集锦，是进一步健全人大监督机制积极探索和有益尝试的集锦。在我国改革开放的历史新时期，人民代表大会制度在国家政治、经济和社会生活中日益发挥重要作用的今天，这本书的出版具有十分重要的意义。它丰富了人大立法和监督的工作经验，有利于人民代表大会制度的建设和发展；它作为经验交流和启迪，有利于推动《妇女权益保障法》的贯彻实施，树立全社会尊重妇女、保护妇女的新风尚，激发广大妇女投身改革开放和社会主义现代化建设事业的积极性；它还将以国家权力机关保障妇女权益、促进男女平等的实绩向世界展示我国社会主义制度的无比优越。
