## 2.3 金融形势

## 货币信贷继续保持快速增长

## 一、货币供应量增长29.31%

2009年9月末,广义货币供应量( $M_2$ )余额为58.54万亿元,同比增长29.31%,增幅比上年末高11.49个百分点,比上月末高0.78个百分点;狭义货币供应量( $M_1$ )余额为20.17万亿元,同比增长29.51%,增幅比上年末高20.45个百分点,比上月末高1.79个百分点;市场货币流通量( $M_0$ )余额为3.68万亿元,同比增长15.96%。前三个季度净投放现金2569亿元,同比多投放965亿元。

## 二、金融机构人民币各项贷款增长34.16%

2009年9月末,金融机构人民币各项贷款余额39.04万亿元,同比增长34.16%,增幅比上年末高15.43个百分点,比上月末高0.05个百分点。前三个季度人民币贷款增加8.67万亿元,同比多增5.19万亿元。从分部门情况看,居民户贷款增加1.84万亿元,其中短期贷款增加6672亿元,中长期贷款增加1.17万亿元;非金融性公司及其他部门贷款增加6.83万亿元,其中短期贷款增加1.44万亿元,中长期贷款增加4.30万亿元,票据融资增加8803亿元。9月当月人民币各项贷款增加5167亿元。

2009年9月末,金融机构外汇各项贷款余额3433亿美元,同比增长28.34%。前三个季度外汇各项贷款增加997亿美元,同比多增505亿美元。其中,9月外汇各项贷款增加177亿美元。

本外币并表后,2009年9月末,金融机构本外币各项贷款余额为41.39万亿元,同比增长33.83%。前三个季度新增本外币各项贷款9.35万亿元,同比多增5.64万亿元。当月新增本外币各项贷款6368亿元。

## 三、金融机构人民币各项存款增长28.35%

2009年9月末,金融机构人民币各项存款余额

为58.39万亿元,同比增长28.35%,增幅比上年末高8.62个百分点,比上月末高0.86个百分点。前三个季度人民币各项存款增加11.75万亿元,同比多增5.18万亿元。从分部门情况看,居民户存款增加3.80万亿元,非金融性公司存款增加6.64万亿元,财政存款增加1.03万亿元。非金融性公司存款中,企业存款增加5.60万亿元。9月当月人民币各项存款增加9992亿元。

2009年9月末,外汇各项存款余额2032亿美元,同比增长7.83%。前三个季度外汇各项存款增加105亿美元,同比少增172亿美元。其中,9月外汇各项存款下降32亿美元。

本外币并表后,2009年9月末,金融机构本外币各项存款余额为59.78万亿元,同比增长27.79%。前三个季度新增本外币各项存款11.82万亿元,同比多增5.14万亿元。当月新增本外币各项存款9766亿元。

## 四、银行间市场利率小幅上升

2009年9月,银行间市场人民币交易累计成交13.51万亿元,日均成交5872亿元,日均成交同比增长29.92%,日均同比多成交1352亿元。

2009年9月,银行间市场同业拆借月加权平均利率1.27%,比上月上升0.06个百分点;质押式债券回购月加权平均利率1.28%,比上月上升0.05个百分点。

## 五、国家外汇储备增长19.26%

2009年9月末,国家外汇储备余额为22726亿美元,同比增长19.26%。前三个季度国家外汇储备增加3266亿美元,同比少增507亿美元。9月外汇储备增加618亿美元。2009年9月末,人民币汇率为1美元兑6.8290元人民币。

2.3 ■ Financial Performance

## Monetary Credit Continued to Increase Rapidly

### 1. The money supply increased by 29.31%

At end-September 2009, broad money supply ( $M_2$ ) stood at 58.54 trillion yuan, increasing by 29.31% year-on-year, up by 11.49 percentage points from the end of previous year and up by 0.78 percentage point from the end of previous month. Narrow money supply ( $M_1$ ) registered 20.17 trillion yuan, increasing by 29.51% year-on-year, up by 20.45 percentage points from the end of previous year and up by 1.79 percentage points from the end of previous month. Cash in circulation ( $M_0$ ) grew by 15.96% year-on-year to 3.68 trillion yuan. Net cash injections in the first three quarters of 2009 totaled 256.9 billion yuan, 96.5 billion yuan more than that recorded in the same period of previous year.

### 2. RMB loans increased by 34.16%

At end-September 2009, outstanding RMB loans totaled 39.04 trillion yuan, growing by 34.16% year-on-year, up by 15.43 percentage points from the end of previous year and up by 0.05 percentage point from the end of previous month. In the first three quarters of 2009, RMB loans registered an increase of 8.67 trillion yuan, 5.19 trillion yuan more than the increase recorded in the first three quarters of 2008. By sector, loans to households increased by 1.84 trillion yuan, among which short-term loans rose by 667.2 billion yuan, and medium- term and long-term loans rose by 1.17 trillion yuan. Loans to non-financial institutions and other sectors expanded by 6.83 trillion yuan, among which, short-term loans rose by 1.44 trillion yuan, medium- term and long-term loans rose by 4.30 trillion yuan, and paper financing witnessed an increase of 880.3 billion yuan. In September, RMB loans rose by 516.7 billion yuan.

At end-September 2009, outstanding loans denominated in foreign currencies of financial institutions totaled US\$343.3 billion, rose by 28.34% year-on-year. In the first three quarters of 2009, loans denominated in foreign currencies increased by US\$ 99.7 billion, US\$ 50.5 billion more than that in the same period of previous year. In September, loans denominated by foreign currencies increased by US\$ 17.7 billion.

At end-September 2009, outstanding loans denominated by RMB and foreign currencies of financial institutions totaled 41.39 trillion yuan, increasing by 33.83% year-on-year. In the first three quarters of 2009, loans denominated by RMB and foreign currencies increased by 9.35 trillion yuan, 5.64 trillion yuan more than the growth in the same period of 2008. In September, loans denominated by RMB and foreign currencies increased by 636.8 billion yuan.

### 3. RMB deposits increased by 28.35%

At end-September 2009, outstanding RMB deposits totaled 58.39 trillion yuan with a year-on-year growth of 28.35%, up by

8.62 percentage points from the end of previous year and up by 0.86 percentage point from the end of previous month. In the first three quarters of 2009, RMB deposits registered an increase of 11.75 trillion yuan, 5.18 trillion yuan more than the growth in the same period of previous year. By sector, household deposits grew by 3.80 trillion yuan, deposits of non-financial corporations grew by 6.64 trillion yuan, and fiscal deposits grew by 1.03 trillion yuan. Among the deposits of non-financial corporations, enterprises deposits increased by 5.60 trillion yuan. In September, RMB deposits rose by 999.2 billion yuan.

At end-September 2009, outstanding deposits denominated in foreign currencies increased by 7.83% to US\$203.2 billion. In the first three quarters of 2009, deposits denominated in foreign currencies increased by US\$ 10.5 billion, US\$17.2 billion less than that recorded in the same period of previous year. In September, deposits denominated in foreign currencies decreased by US\$ 3.2 billion.

At end-September 2009, outstanding deposits denominated by RMB and foreign currencies of financial institutions totaled 59.78 trillion yuan with a year-on-year growth of 27.79%. In the first three quarters of 2009, deposits denominated by RMB and foreign currencies increased by 11.82 trillion yuan, 5.14 trillion yuan more than that in the same period of previous year. In September, deposits denominated by RMB and foreign currencies increased by 976.6 billion yuan.

### 4. Interest rates increased slightly in the inter-bank market

In September 2009, RMB trade volume in the inter-bank market amounted to 13.51 trillion yuan. The average daily turnover increased by 29.92% year-on-year to 587.2 billion yuan, 135.2 billion yuan more than that recorded in the same period of previous year.

In September 2009, the monthly weighted interest rate for inter-bank lending averaged at 1.27%, up by 0.06 percentage point from previous month. The monthly weighted interest rate for bond pledged repo averaged at 1.28%, up by 0.05 percentage point from previous month.

### 5. Official foreign exchange reserves increased by 19.26%

At end-September 2009, official foreign exchange reserves reached US\$2272.6 billion, registered an increase rate of 19.26% year-on-year. In the first three quarters of 2009, official foreign exchange reserves rose by US\$326.6 billion, US\$ 50.7 billion less than the growth in the same period of previous year. In September, foreign exchange reserves increased by US\$61.8 billion. At end-September, the RMB exchange rate stood at 6.8290 yuan per US dollar.
