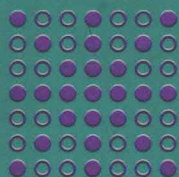

The aim of this bibliography is to provide an up to date list of resources for librarians, information professionals, academics and individual women and men working on gender issues. Selection Criteria

This selective bibliography is not comprehensive and cannot cover the whole of this growing subject area. It is intended rather, as a guide to textbooks, manuals, general introductions and policy documents in the field.

The criteria for inclusion have been extended to include books published outside of Britain and available through UK distributors. All must be relevant to overseas use.

The main methods of selection were : consultation with relevant NGO's, specialist publishers, writers, academic institutions and workers in the field of gender issues in development. The final selection of materials was

approved and quality assessed by Juliet McCaffrey, British Council Lead Consultant on Gender and Development. All references were checked with the publisher or against Bookdata's Bookfind or Whitakers Bookbank CD-ROMs to confirm publication details and price. A few titles without available ISBNs or prices are included in the list, because they were relevant to the subject area.

Arrangement

For ease of use, the data is arranged by subject categories, within which the items are sub-divided into geographical or national coverage and then arranged alphabetically by title.

There are three indexes ; title, author and item number. World Bank reports on relevant subjects are included in Appendix A. The prices of WB and other reports are not given, as costs may vary internationally. The UK distributors will provide details of cost upon application. British Council purchasers should order all books through Askews, in the usual manner.

Readership Levels

The following codes have been used to identify the appropriate readership level of each book :

- VT - vocational, technical, practical guides
- B - basic texts, primers, self-help guides, self-access guides, beginners manuals
- T - teaching manuals, books for professionals working in the field
- S - undergraduate, postgraduate, student
- P - professional, theory, policy making, reference books for NGO's
- G - general interest
