

INTRODUCTION

This fifth and new Bibliography of selected titles has been compiled to serve the specialist and student of Southwestern Asia from the Nile to the Indus, and from Anatolia and the Caucasus to the Arabian Sea.

The countries include Turkey (Anatolia), Syria, Lebanon, Israel, Egypt, Jordan, Saudi Arabia, Yemen, Aden (Colony, Western and Eastern Protectorates, and Socotra and Abd el-Kuri islands), Dhufar, Oman, Trucial Oman Coast, Qatar Peninsula, Bahrain Island, 2 Neutral Zones, Al Kuwait, Iraq, Iran, Caucasus (mainly Transcaucasia), Afghanistan and West Pakistan.

Special effort has been made to include titles of articles and books published from January 1 - December 31, 1957. Under Anthropogeography, with but few exceptions, no references published prior to January 1, 1956 have been included. However, under Natural History there has been no time restriction because this is the first major series of Bibliographies on Southwestern Asia on these subjects.

In a few cases references to areas adjoining or related by culture contact to Southwestern Asia have been incorporated. For example, some titles refer to the Horn of Africa on the west, to the Republics of Soviet Central Asia on the north, and to India on the east.

Universities and libraries throughout the world should find this list of titles a ready source of reference, especially when the Subject Index becomes available.

The Table of Contents reveals the organization of the material. For the convenience of the specialist it was decided to group the Zoological titles under these 7 headings: Zoology General; Arthropods; Birds; Fish; Mammals; Mollusks; and Reptiles and Amphibians.

The following 33 foreign languages, the majority translated, have been used: Amharic, Arabic, Armenian, Azerbaidzhani, Czech, Danish, Dutch, Finnish, Flemish, French, Georgian, German, Greek, Gujerati, Hebrew, Hindustani, Hungarian, Italian, Japanese, Kurdish, Latin, Magyar, Norwegian, Persian, Polish, Portuguese, Russian, Serbo-Croatian, Spanish, Swedish, Turkish, Urdu and Uzbek.

Since this working Bibliography will be used principally by those who read English, French, German, Italian, Spanish and Portuguese, the title in languages other than these has been translated, but the original language of the book or article is given. If there is a summary in English, French or German, this is indicated as for example: "In Turkish with English summary."

This includes a summary of archaeological field work in the Asiatic territory of the Soviet Union, 1952-54: Kazakhstan, Khorezm (Khwarazym) area, Kirghiz SSR, Tadzhikistan, Turkmenistan, Uzbekistan, Trans-Ural Region, Western and Eastern Siberia. In addition, Chard edited COWA Bibliography for Area 18 - Northern Asia, No. 1, 1957, based on 1950-55 and divided into: General (1-8); Russian Turkestan including the Central Asiatic Republics (9-37); Trans-Ural Region (38-45); Western Siberia and Altai (46-67); and Eastern Siberia (68-77). These Surveys and Bibliographies arrived too late to be included in Bibliography: V.

- (14) An annotated Research Bibliography of studies in Arabic, English and French of the Fellah of the Egyptian Nile, 1788-1955, by Dr. Lyman H. Coult, Jr. with the assistance of Karim Durzi to be published by the University of Miami Press in March, 1958. This Bibliography should be considered as complementary to our B: I-V.
- (15) Bibliography on the Arabian Peninsula by Squadron Leader Eric Macro with 2380 titles to be published by the University of Miami Press in July, 1958. These references supplement our B: I-V.

culture contacts by sea with the Persian Gulf. Furthermore, Dr. Ware has just returned from Colombo, where she has been compiling references from Ceylon.

The Bibliography is divided into:

- 1. ANTHROPOGEOGRAPHY (Nos. 1-4303), including Anthropology (physical, ethnology, sociology, folklore, population problems, migration and settlement, and linguistics), Archaeology (Prehistory to Classical), Geology and Palaeontology, Agriculture (irrigation, hydro-electric development, soil conservation and land reclamation), Astronomy, Cartography, Meteorology, Medicine (public health, disease, nutrition and dentistry), Art (ancient), Drama, Literature, Music, and Poetry. The two deliberate major omissions are references to Politics (Government documents, Treaties, etc.) and Oil. However, the reader is referred to the "Bibliography on the Arabian Peninsula" by Squadron Leader Eric Macro with 2380 titles to be published by the University of Miami Press, 1958. This Bibliography contains many references to oil exploration and development.
- 2. NATURAL HISTORY divided into Zoology (Nos. 4304-6110) including General (4304-4579), Arthropods (4580-5570), Birds (5571-5720), Fish (5721-5838), Mammals (5839-5995), Mollusks (5996-6049), Reptiles and Amphibians (6050-6110), and Botany (6111-6739).

Because of the large number of Anthropogeographical references (4304) in this Bibliography, there appeared the desirability of dividing this section into subheadings for the convenience of the reader. Several attempts were made to establish clearly defined categories. However, the overlapping of subjects rendered this inadvisable. The result would have been to have numerous small sub-divisions or many references under a general heading with relatively few in each sub-group. For this reason, I decided to follow the pattern established previously, namely, alphabetical listing by author. The specialist seeking reference to a particular subject such as Medicine, or to an area such as Iraq, can easily check the pertinent titles. Furthermore, we have begun to prepare a Subject Index on Bibliographies I-V for the convenience of the reader.

Variations in spellings, translations and transliterations and some minor inconsistencies occur, since many secondary sources were used and such a wide range of Journals (see list of 926 Abbreviations and 161 Special Journals) was drawn upon. This list of Abbreviations includes some Institutions, such as UNESCO, FAO, WHO, etc. In some cases we have not thought fit to include a particular Journal in the List of Abbreviations; in others, an incomplete title has been allowed to stand.

A decision was made to capitalize the Asiatic, Desert, Italian, Moroccan and Nejdi Locust because the title refers to a specific crop destroyer.

To improve the appearance of the page, all italics have been omitted.

Because of increased publication costs, particularly since 1945, I have placed on microfilm 100 articles with about 13,000 pages of statistical tables, photographs, charts, maps and supplementary data of my own and those of numerous co-workers in Southwestern Asia and adjoining areas. In Bibliography V, for the convenience of the researcher, the most recent titles have been included under each author with the ADIM number. A copy of each of these microfilms may be purchased from the American Documentation Institute (ADI), c/o Photoduplication Service, Library of Congress.

My own list of 450 publications and documents microfilmed from January, 1941-May, 1958, will be available for distribution in July. Three monographs are scheduled to appear in the Peabody Museum Papers, Harvard University: (a) Body-mark-

ing in Southwestern Asia (in press); (b) An Anthropological Reconnaissance in West Pakistan (Baluchistan and Bahawalpur), 1950; and (c) Archaeological Survey of the North Arabian Desert, 1925-55.

These 5 Bibliographies on Southwestern Asia with the following 31, 309 references

in 34 languages should be considered as a single unit for research:

To summarize, Bibliographies I-V with 31,309 titles include at least 35,000 references because sections of the same article appear under one entry; this is especially true under Zoology and Botany. The total number of cards required for these references, the Abbreviations and Author Indexes is estimated at 70,000 requiring 1225 photo-offset pages. The Subject Index to Bibliographies: I-V is in preparation and should be ready for distribution during the spring of 1959.

Attention is called to the following:

- (a) The islands of Socotra and Abd el-Kuri in the Arabian Sea have been included.
 - (b) References to Cyprus and the Aegean Islands have been omitted.
- (c) A few selected titles for Somalia, Ethiopia, Soviet Central Asia and India have been included; these have special links to Southwestern Asia.
- (d) Natural History references for the entire area have not been confined to the years 1940-56. As in Bibliographies I-IV, series of titles by the same author have been grouped under the same entry.
- (e) Arbitrary decisions were made to include agriculture, cultivation, forestry, crops and crop pests (except specific Arthropods), etc. under Anthropogeography; technical, mainly taxonomic, articles appear under Botany (Nos. 6111-6739). For this reason the botanist must refer to both sections.
- (f) There was some difficulty in deciding whether fossil Mollusca should be placed in Anthropogeography, where Geological references are given, or under Mollusca in Natural History. The specialist should consult both sections.
- (g) Spellings of proper names often caused difficulty, especially in regard to transliteration of Arabic and Russian. Although in general we have attempted to follow the Library of Congress system, in certain cases an arbitrary rendition has seemed advisable.
- (h) Parasites causing disease and using Man as the host have been classed under Anthropogeography. The only exceptions are where the vectors are described in detail; these have been placed under Arthropods (e.g. ticks). Animal diseases have generally been listed under the host.
- (i) Some references remain incomplete: authors' initials are missing; date of publication could not be found; and in a few cases the Journal is either given as found or has not been abbreviated.
- (j) Abbreviations have been checked, wherever possible, in the World List of Scientific Periodicals for 1900-50, New York and London, 1952.

The Director generously supplied a list of their publications together with those in press. Dr. Harry W. Hazard and assistants at the American Geographical Society completed a provisional edition of "Bibliography of the Arabian Peninsula," pp. 1-256, in the HRAF Behavior Sciences Bibliographies. Under 27 headings and with many brief annotations, this Bibliography is of great reference value.

In Bibliography V special effort was made to include references to Arthropods (Nos. 4580-5570). Attention is called to the Bibliography of Fisheries of the Western Sector prepared by the Indo-Pacific Fisheries Council (Document IPFC/C50/7) dated January 5, 1950. These titles are presumed to be available. Copies are known to be on file in the Library of the Marine Laboratory, University of Miami and FAO Library, Rome.

In some cases the page numbers to Hebrew references are reversed in accordance with the usage prevalent in certain Hebrew periodicals.

Since no Bibliography can ever be complete, I would be especially grateful for Addenda, so that these may be included in the proposed Bibliography VI. However, new Anthropogeographical titles must have been published since January 1, 1958.

The original plan of these Bibliographies was to select Anthropogeographical references from January 1, 1940 and all Natural History references available regardless of date. In order to bring the references in this Series of 5 Bibliographies up to the end of 1957 every effort has been made to include not only the current 1957 titles in Anthropogeography, but also many which had not been found for Bibliographies I-IV.

Assistance from librarians and specialists was requested from many sources in the United States, Europe, North Africa, throughout Southwestern Asia, and as far east as New Delhi and Bombay. The response was indeed most gratifying.

As a direct result, the 19,268 Anthropogeographical references in Bibliographies I-V should be considered as an entity to give the researcher an excellent background.

Bibliography VI will be almost entirely limited to titles published since January 1, 1958, except for the Natural History sections.

In order to reorganize the collecting of references for B:V and to arrange for wider coverage, especially in Anthropology, Archaeology, Medicine (Tropical Diseases with special emphasis on Malaria), Zoology and Botany, I travelled from London to Rome.

London

- (a) Methods of improving coverage were discussed with the Librarian, British Museum (Natural History), and with Mr. B.J. Clifton.
- (b) It was decided to employ Miss Annette Blankley, Assistant Librarian, Anti-Locust Research Centre, to collect titles dealing with Arthropoda, especially locusts. This arrangement proved highly satisfactory.
- (c) Mr. Reginald J. Hoy, Librarian, School of African and Oriental Studies, University of London, arranged to supply certain titles to Bibliographies and to forward copies of their own Bibliographies as published.
- (d) Major N.D. Jennings, Librarian, Royal Geographical Society, was invited to send titles dealing with geographical subjects from relatively obscure publications.
- (e) Titles were selected in the following Libraries: British Museum; India Office; Institute of Archaeology, University of London; London Library; Royal Central Asian Society; and the Royal Geographical Society.
- (f) Through Mr. Reginald J. Hoy I met Mr. Leslie E.D. Barber, a trained research worker, who was engaged to select certain references from the current accessions in the School of Oriental and African Studies, University of London. Mr. Barber sent about 100 cards prior to an illness which proved fatal.

Oxford

- (a) Through my undergraduate colleague at New College, Dr. J.N. Myres, Bodley's Librarian, special facilities were placed at my disposal.
 - (b) Mr. Robert G. Sawers was employed to collect recent book titles.

Paris

- (a) Miss Yvonne Oddon, Librarian, Musée de l'Homme, guided me to new sources of material and made arrangements for me to meet Mr. Jean Meyriat at UNESCO.
- (b) Mr. Jean Meyriat, Director of the International Bibliography of Social Science and Director of the International Committee for Social Science Documentation, Cultural Anthropology, 27 rue Saint-Guillaume, Paris, offered to exchange references. As a result I sent him all the cards on B:IV.
- (c) Dr. Luther Evans, Director-General, UNESCO, introduced me to the Librarian and to a visitor, Dr. Matta Akrawi, Chancellor of the newly-created University of Iraq in Baghdad.

Florence

- (a) Dr. Claudia Massari guided me to new Italian sources in the magnificent library of the Istituto di Antropologia.
- (b) Dr. Lidio Cipriani supplied references from his private anthropological library.

Rome

- (a) Dr. Genna, Istituto di Antropologia, Città Universitaria, indicated reference sources in the Library.
- (b) Dr. Carlo della Valle gave me access to the Library of the Royal Italian Geographical Society.

(c) Monsignor Albareda, Librarian of the Vatican, presented me with the recent issues of the Pubblicazioni della Biblioteca Apostolica Vaticana.

(d) The Librarian, Istituto Pontificio, gave Dr. Ware and myself access to their large collection of scientific Journals from which we selected several hundred im-

portant references.

- (e) Mr. Hans Jenssen, Librarian, and his assistants at FAO Headquarters, Viale delle Terme di Caracalla, as well as having selected cards from their card catalog copied, most generously made available many recent published and mimeographed documents. Because of the permanent reference value of B:I-IV, Mr. Jennsen arranged to send me, beginning December 1, 1957, a copy of every card referring to Southwestern Asia accessioned in FAO Library. This requires making an extra card for the University of Miami Bibliographies. Arrangements have been made to present to the Middle East Institute, Washington, duplicate references or those to subjects not included in our Bibliographies, for example, most government documents. Since that date references have been received regularly by air mail from FAO, Rome. This special assistance is greatly appreciated.
- (f) Dr. G.L. Kesteven, Director of Fisheries Division, FAO, Rome, is preparing for publication an elaborate annotated Bibliography on the Fishes of the World. A set of B:I-IV having already proved useful, Dr. Kesteven suggested that we aim to eliminate duplication of effort. After two-long conferences we agreed to the following procedure: (1) as soon as the cards on Fishes in B:V were processed, they were to be sent to Dr. Kesteven in Rome; (2) Mr. S.J. Holt, who was going on FAO business to London in January, 1958, was to confer with Mr. B.J. Clifton, our researcher at the British Museum (Natural History), and arrange to send copies of his cards on Fishes direct to FAO; (3) Dr. Kesteven at the close of each year would send us copies of their current cards referring to Fishes within our prescribed area; and (4) copies of their publications would be sent for inclusion in our list of Bibliographies.

It was most gratifying to find the wide use of B:I-IV both at home and in Europe. Naturally, the series becomes the more important the longer it continues. As an example of the many references to B:I-IV in the literature, I cite the following by Dr. Harry W. Hazard, American Geographical Society, from his Introduction to "Bibliography of the Arabian Peninsula," HRAF, 1956, "Residual coverage is wide but by no means exhaustive (especially in the minutiae of Botany and Zoology, for which reference should be made to the several volumes of Field's Bibliography on Southwestern Asia..."

In order to make B:I-V more useful to librarian, specialist, researcher and student, it is planned to supplement the Author Index with a Subject Index. At the moment B:VI is planned for 1959; sporadic collecting of references has begun, but the concentrated drive has been deferred temporarily.

ACKNOWLEDGEMENTS

This Bibliography with 6,739 titles in 33 languages, and 926 Abbreviations required all the assistance I could muster from California to New Delhi. Once again, I called upon the assistance of my colleagues in the United States, in Europe, in North Africa, in Southwestern Asia, in West Pakistan and in India. Only with their generous cooperation could this assemblage have been compiled during the past twelve months.

The majority of sources used in Bibliographies I-IV were once again combed for titles. These and some new sources have been included in Bibliography V.

Because of the daily pressure of their duties, I have learned that it is necessary to employ local assistants in key libraries and institutions at home and abroad; this is the only method possible to obtain good cooperation. Many librarians and research workers responded to direct mail requests. However, in many cases local facilities do not permit the copying of cards and titles except under outside direction, supervision and the employment of local secretarial help.

The following assistants worked on Bibliography V:

1. Dr. Edith W. Ware revisited libraries and Near Eastern specialists in Edinburgh, London, Oxford, Louvain, Rome, Istanbul and Beirut. In addition, Dr. Ware made special trips to Ankara, Tehran, Karachi, Bombay and Colombo to select references for B:V.

At my request Dr. Ware went to Louvain in order to obtain titles from Dr. Gonzague Ryckmans in the University of Louvain. As he had done for B:IV, Dr. Ryckmans very generously contributed about 100 titles from his files. Once again, I should like to express my gratitude to this distinguished scholar.

In Ankara Professor Shevket Aziz Kansu and Dr. Suleyman Muzaffer Senyurek very graciously supplied references and indicated sources of Turkish materials, mainly in Anthropology and Archaeology.

- Dr. Ware was eminently qualified to make this journey. Trained as an Egyptologist at the University of Chicago and for many years Research Assistant to the late Professor James H. Breasted, Dr. Ware not only assisted me with setting up the plan for Bibliography I, but also worked for many months on each of Bibliographies I-IV so that she is entirely familiar with the selection of material and its general arrangement. Dr. Ware left New York by air in June for London and spent 4 months in England and Scotland collecting references for B:V and editing two manuscripts:
 - (a) "Bibliography on the Arabian Peninsula" by Squadron Leader Eric Macro; and
 - (b) "The History and Tribes of Jordan" by Colonel F.G. Peake (Peake Pasha). Dr. Ware sent about 2000 titles, which have been incorporated into B:V.

To Dr. Ware I am most grateful for her most welcome additions and for her perseverance and research skills combined with the difficulties of travel and living conditions abroad.

- 2. Dr. Claude T. Richards, who edited part of the Near East Translation Project Series of the American Council of Learned Societies, acted as Coordinator of all the materials being received from four continents. Exactly the same system was followed as in Bibliographies I-IV. Dr. Richards revised and edited the entire list of 6739 titles, compiled the Abbreviations and prepared the Author Index in collaboration with Mrs. Levine. He also checked the final copy for photo-offset. His patience, meticulous accuracy and knowledge of languages once again proved invaluable.
- 3. Renata (Mrs. Peter) Dodge selected references in the New York Public Library and in the Harvard Libraries, mainly Peabody Museum and Widener. Her knowledge of Czech, German, French and Italian enabled her to choose titles from Journals in these languages. The result was most gratifying and our coverage was thereby greatly strengthened.
- 4. Mr. Bernard J. Clifton, Librarian, Department of Entomology, British Museum (Natural History) consented, once again, to go through their reference files and incoming Accessions in order to select Zoological and Botanical titles. The splendid array of Natural History titles is primarily due to his patient and constant search. I am deeply grateful to him for his large series of titles. Following my visit to London in September, it was arranged to employ Miss Annette Blankley (see No. 5) to select all references to Arthropoda, especially locusts.
- 5. Miss Annette Blankley, Assistant Librarian in the Anti-Locust Research Centre, 1 Princes' Gate, London S.W. 7, selected references to Arthropoda, mainly locusts. This specialized Library, organized under the direction of my friend, Dr. B.P. Uvarov, receives publications on locusts from every part of the world. In Bibliography V, for the convenience of the reader, all references to locusts and locust control have been placed under Arthropods. I am grateful to Miss Blankley for her diligence in selecting titles from so many scattered sources.
- 6. Mrs. Walter T. Swingle selected several hundred titles in the U.S. Department of Agriculture Library. After Mrs. Swingle left for Europe, Miss Ethel L. Coon continued the search with profitable results.
- 7. Mrs. Elizabeth Koenig, librarian, National Institutes of Health, Bethesda, Maryland, selected several hundred medical references.

8. In Baghdad Mr. Rashid al-Haik continued to select and translate titles from

a wide range of Arabic sources.

9. Mrs. Calvin (Donna) Reinhardt, Acting Head, Catalogue Department, University of Miami, checked some obscure references in Journals and in the List of Abbreviations. Mrs. Reinhardt also alphabetized the 6739 cards and the Author Index, so that they would conform to the Library of Congress system, with the exception of the Arabic authors which we have grouped under the definite article rather than under the first letter of the last name. Thus, Al-Khatib is listed under the letter "A," not "K." We believe that this will make the Author Index easier to use by the researcher.

10. Mr. Vladimir Maurin, who checked the Russian proper names, titles and Abbreviations, read through the entire manuscript to correct Errata, especially

in Russian, German and French.

11. Mrs. Vladimir Maurin, Reference Librarian, Medical Library, University of Miami, checked some of the Abbreviations and medical references.

12. Mrs. Mildred Crowe Langner, Medical Librarian, University of Miami, checked some medical terminology, especially from translated titles.

13. Birdie (Mrs. Irving) Levine typed the majority of cards, including mine from Harvard and Europe (England, France and Italy) and also 4 large series from Dr. Edith W. Ware which were received by air from Ankara, Beirut, Tehran and Bombay. Mrs. Levine also checked the new entries for duplicates already published in B: I-IV and under the direction of Dr. Claude T. Richards compiled and arranged the Author Index. Her care and accuracy are greatly appreciated.

1. The Librarian, School of Oriental and African Studies, University of London, who continued to forward copies of their Bibliographies of Asia. These have been placed on file in Peabody Museum, Harvard University.

The 495 rejects, mainly titles translated from Arabic by Rashid al-Haik in Baghdad, will be placed on 2 microfilms in the American Documentation Institute, Photoduplication Service, Library of Congress, where copies may be purchased. These rejects are either from regions outside our area or on subjects not included in B: I-V.

In conclusion, my gratitude must be expressed to all those who assisted in the

compilation of this Bibliography, and to Mr. Grant for his technical skill.

It has been a great pleasure to collaborate, once again, with Mr. Malcolm Ross, University of Miami Editor, on the publication of this fifth Bibliography on Southwestern Asia, the area which is now of vital interest to the United States.
