

Asian Migrants and European Labour Markets

In an era of globalization and demographic transition international migration has become an important issue for European governments. The past decades have seen an increasing and diversifying flow of migrants from different parts of the world, including many from South, South East and East Asia. It has become apparent that in several countries of Europe the demand for workers in certain sectors of the labour market is increasing and that Asia has become an important source for these workers.

This collection explores the phenomenon of Asian immigration in Europe and particularly the ways in which Asian immigrants gain access to local labour markets, including analyses of the factors fostering and sustaining integration. The book includes studies of nine European countries, including Germany, France, Spain, Italy and the United Kingdom, shedding light on the labour market positions of different ethnic groups within Europe with a focus on immigrant entrepreneurship and economic strategies. In the analysis, socio-cultural, economic, institutional and policy aspects are taken into account.

Asian Migrants and European Labour Markets will interest scholars in the field of labour economics, population and migration studies, geography and international business.

Ernst Spaan is Senior Researcher at the Netherlands Interdisciplinary Demographic Institute with an interest in population and development issues, international migration and inter-ethnic relations. He has collaborated on a range of research projects concerning international migration. Felicitas Hillmann is Senior Lecturer (*Privatdozent*) at the Free University, Berlin. Her academic interests are in the fields of social geography and development research. For some years her research has focused on migration and gender, ethnic economies and the labour market insertion of immigrants. Ton van Naerssen is Associate Professor in the Department of Geography at Radboud University, Nijmegen. His research interests include development theory, international migration and the governance of urban poverty in developing countries.

- David McEvoy is Emeritus Professor of Urban Geography at Liverpool John Moores University. He was Director of the School of Social Science in that university from 1991–98. His research on ethnic minority resi-

dence and on ethnic minority business in Britain and Canada stretches over twenty years. It has been funded by the Social Science Research Council (UK), the Economic and Social Research Council (UK), the Commission for Racial Equality (UK) and the Canadian High Commission in London.

Tariq Modood is the Director of the Centre for the Study of Ethnicity and Citizenship and a founding editor of the new international journal Ethnicities. He is at the Department of Sociology, University of Bristol. He is a leading authority in the field of ethnicity and was the principal researcher of the Fourth National Survey of Ethnic Minorities in Britain published as Ethnic Minorities in Britain: Diversity and Disadvantage (1997). His other publications include Changing Ethnic Identities (with S. Beishon and S. Virdee, 1994) and Asian Self-employment (with H. Metcalf and S. Virdee). He also edited Church, State and Religious Minorities (1997) and Debating Cultural Hybridity and the Politics of Multiculturalism in the New Europe (1997), both with P. Werbner. He has completed a Nuffield Foundationsponsored project, South Asian Women and Employment, with Fauzia Ahmad. He is working on several comparative cross-national projects on ethnicity and public policy with colleagues in the United States and Canada.

Liane Mozère is Professor of Sociology at the University of Metz. She has been working for many years on migrant populations and on informality (illegal work) in France as well as on Philippine women working illegally as domestics in Paris. She has published a reader on the subject entitled Travail au noir: informalité, liberté ou sujétio? (1999). Another book is forthcoming on the theme of family child care in a suburb of Paris, with particular attention to the handling of foreign and migrant women caring for children and how they 'manage' their 'business'.

Ton van Naerssen is senior lecturer and co-ordinator of the Master's programme 'Globalisation and urban development' of the Nijmegen School of Management, Radboud University, Nijmegen. He is a development geographer with a special interest in development theory, urban issues and South East Asia. He was co-editor of Urban Social Movements in the Third World (1989), The Diversity of Development (1997) and Healthy Cities in Developing Countries (2002).

Knut Onsager (dr. polit. in social geography) is a geographer and Research Officer at the Norwegian Institute of Urban and Regional Research. He specializes in industrial systems, innovation systems, entrepreneurship and labour markets. His research includes work on immigration and the labour market insertion of immigrants in Norway. Harry van den Tillaart is a sociologist working at the Institute of Applied Social Sciences, Radboud University of Nijmegen. His work focuses on small and medium-size businesses and entrepreneurship. He is researching immigrant entrepreneurs and issues of urban development. He has documented the increase in immigrant entrepreneurs and the changes in choice of industry these entrepreneurs – in particular those of the second generation – made in the Netherlands 1985–2004. Preface

In the current era of globalization, a conspicuous feature has been the increasing migration flows from Asia to Europe, both highly dynamic migration regions and increasingly interconnected. In contrast to the former 'guest workers' from Mediterranean countries to selected countries in northern Europe, who found work in industry and manufacturing mainly through bilateral agreements between governments and employers, recently arrived Asians have carved out niches on the European labour market as, for instance, Indian and Pakistani retailers, Vietnamese caterers, Filipino domestic workers or Sikh milkers. Likewise conspicuous is that, up to now, relatively little research has been devoted to the modes of incorporation of Asians into the European labour market. To help fill this void, we decided to initiate a research network on Asian migrants and entrepreneurs in Europe.

This book owes its origin to a conference on 'Asian Immigrants and Entrepreneurs in the European Community' which took place in the city of Nijmegen (the Netherlands) on 9-11 May 2001. The conference was funded by the European Science Foundation (ESF) under the ESF SCSS Exploratory Workshop Scheme. It was the first workshop highlighting especially the role of Asian immigrants in European labour markets, including the development of Asian immigrant entrepreneurship. Initiators were the Netherlands Interdisciplinary Demographic Institute (NIDI), the Nijmegen Centre of Border Research of the University of Nijmegen (now Radboud University Nijmegen) and the Economic and Social Science Institute of the Hans Boeckler Foundation in Dusseldorf (WSI), Germany. They acted on behalf of the European Network on Asian Immigrants. During the conference nineteen papers were presented by conference participants from ten European countries. Moreover a symposium was held during which Dan Hiebert, David Ley (both from the University of British Columbia), Ivan Light (University of California) and Jan Rath (University of Amsterdam) gave their valuable inputs with regard to the conference theme. We thank these persons and institutions for their support for the conference.

We are grateful to all participants whose enthusiasm convinced us to continue with a book project, and to the anonymous referees of the initial book

proposal who suggested expanding the subject to encompass the broader theme of Asian immigrants on the European labour market. We want to extend our gratitude to all the contributing authors whose quick acceptance of our invitation to contribute strengthened our idea of the usefulness of the project. Most of the authors updated or rewrote their contributions while some wrote completely new ones. Many thanks also to Tonny Nieuwstraten-Prins and Jacqueline van der Helm of NIDI for the technical editing and preparing the layout of the book, and to Jing Maglunob for editing the English of some chapters. Others whom we would like to thank for their contribution to the preparation of the ESF workshop and the ensuing book project are David McEvoy (Liverpool John Moores University), Natalia Ribas-Mateos (then at Universitat Autònoma de Barcelona), Daniele Cologna (Synergia s.r.l., Milan), Marisha Maas and Marcel Nieling (both from the Department of Geography, Radboud University Nijmegen), Helga de Valk (NIDI) and Leon Vermeulen (NIDI).
