PUBLISHER'S FOREWORD

In keeping with CALIFORNIA JURISPRUDENCE's tradition of furnishing the Bench and Bar of California current California Law, the publisher presents herewith CALIFORNIA JURISPRUDENCE, SECOND EDITION, Volume 17, Revised.

The Coverage of This Volume

This replacement volume includes a rewriting and expansion of the article DRUGS AND DRUGGISTS to cover the numerous developments under the narcotics law since volume 17 was first published. Also included is a rewriting of the article ELECTIONS, which now contains a discussion of the one-man one-vote rule and also reflects many statutory changes, such as those pertaining to political party committees, that have occurred since original volume 17 was published. The important article EMINENT DOMAIN remains divided, with the latter part to appear in revised volume 18, but the division has been handled to avoid any gap in coverage pending the publication of revised volume 18. The rewriting of EMINENT DOMAIN takes into account the important statutory additions and changes enacted in 1967 on the subject of condemnation. Other articles reorganized, revised, and updated in this volume are: DUELING; DURESS AND UNDUE INFLUENCE; EASEMENTS; EJECTMENT; ELECTION OF REMEDIES; ELECTRIC COMPANIES; and ELEVATORS AND ESCALATORS.

The Plan and Format of This Volume

In over-all plan and format, Volume 17 Cal Jur 2d, Revised, fits perfectly in the CALIFORNIA JURISPRUDENCE, SECOND EDITION, mold. All of the controlling law of California, case and statutory, is here. Also here, as in every volume of Cal Jur 2d, are copious references to American Law Reports (ALR, ALR2d, and ALR3d) annotations, and to American Jurisprudence (Am Jur and Am Jur 2d). For further assur-

ance of completeness of coverage, references to pertinent forms in American Jurisprudence Legal Forms and American Jurisprudence Pleading and Practice Forms, and to the invaluable evidentiary and trial aids to be found in American Jurisprudence Proof of Facts and American Jurisprudence Trials have been included.

Index; Parallel References

A complete fact-word and legal-concept index to each of the articles in this volume appears in the back of the volume. A table of Parallel References in the front of the volume enables the user to translate references to titles and sections in the original Volume 17, Cal Jur 2d, to the corresponding titles and sections in this revised volume.
