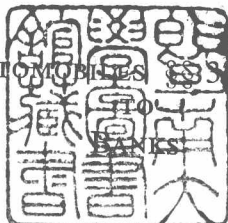

In keeping with CALIFORNIA JURISPRUDENCE's tradition of furnishing the Bench and Bar of California current California Law, the publisher presents herewith CALIFORNIA JURISPRUDENCE, SECOND EDITION, Volume 7, Revised.

The Coverage of This Volume

Included in this volume are the balance of the article AUTOMOBILES, the article AVIATION, which has been thoroughly revised to reflect both federal and state statutory changes that have occurred since the original Volume 7 of Cal Jur 2d was published, and the article BANKS, which has been updated to include pertinent provisions of the Uniform Commercial Code as well as to show changes in case law and in other code provisions. The entire article BANKS is now included in this one volume. The remaining articles in the volume—BAIL AND RECOGNIZANCE and BAILMENTS—have also been reorganized and updated.

The Plan and Format of This Volume

In over-all plan and format, Volume 7 Cal Jur 2d, Revised, fits perfectly in the CALIFORNIA JURISPRUDENCE, SECOND EDITION, mold. All of the controlling law of California, case and statutory, is here. Also here, as in every volume of Cal Jur 2d, are copious references to American Law Reports (ALR, ALR2d, and ALR3d) annotations, and to American Jurisprudence (Am Jur and Am Jur 2d). For further assurance of completeness of coverage, references to pertinent forms in American Jurisprudence Legal Forms and American Jurisprudence Pleading and Practice Forms, and to the invaluable evidentiary and trial aids to be found in American Jurisprudence Proof of Facts and American Jurisprudence Trials have been included.

A complete fact-word and legal-concept index to each of the articles in this volume appears in the back of the volume. A table of Parallel References in the front of the volume enables the user to translate references to titles and sections in the original Volume 7, Cal Jur 2d, to the corresponding titles and sections in this revised volume.
