

Through assets restructuring and adjustment of business structure, the company straightens out and rationalizes the ownership of assets and equities. Through the capital market, its stock of capital is effectively utilized. It is also ready to extend its tentacles into the new and high technology industry.







浦东世纪公园

浦东世纪公园位于上海市浦东新区花木行政文化中心,占地总面积 140 9公顷,总投资为9.14亿元人民币,是上海内环线中心区域内最 大的富有自然特征的生态型城市公园。浦发集团负责该项目的资金 监管和成本控制。

The Century Park in Pudong

Located within the Huamu Administrative and Cultural Center; the park covers 140.3 hectares and the total investment is 914 million yuan. It is the biggest eco-park within the Inner Ring Road of Shanghai. PDC did the financial supervision and cost control for the project.



该项目为浦东国际机场南线双向快速干道,全长20.2公里,总投资为22亿元。


