

### PUDONG



- The development of Pudong is a cross-century undertaking. It means a historical opportunity for the city of Shanghai. If the Bund was a signature of 20th's Shanghai with flourishing economy, Pudong New Area would be a landmark of Shanghai's vitality in the new millennium.
- Pudong has attracted much attention from around the world. Is it true that Waigaoqiao Free Trade Zone in Pudong is the most economically open place in China?
- Exactly. Its superior geographical location and all the special policies it received from the central government has qualified Waigaoqiao Free Trade Zone to become an area where China's market can merge into the global economy. Now it has taken on the initial shape of a free trade zone and is known as the forefront of Pudong's development. By the end of 1998, Waigaoqiao Free Trade Zone had attracted foreign investors from 49 countries and regions. Over 3580 projects, from domestic and overseas investors both, had been approved here, with a total investment exceeding \$4.3 billion, including 53 Subsidiaries established by the Fortune 500 enterprises.

- B: It's very convenient for the visitor to reach Waigaoqiao Free Trade Zone by now. Waigaoqiao Free Trade Zone was located in the northeast of the city, close to the estuary of Yangtze River. It lies at the intersection of China's eastern coastline and its golden waterway-Yangtze River. It is 20 kilometers from Pudong New Area to


Waigaoqiao Free Trade Zone. At present, convenient traffic network is achieved by a transportation network of composed of bridges, tunnels and metro lines.


- A:What are the major functions of Waigaoqiao Free

- A:What are the major conveniences of bonded storage in Waigaoqiao Free Trade Zone?
- B. Any commodity which enters the Free Trade Zone can be stored and exempted from tariff for a considerably long period of time.
- The warehouses within the zone are allowed to undertake simple commercial processing business, like freight sorting and packing, selecting, brand-labeling, and mark-washing etc.
- The bonded goods can be stored wholly and drawn fragmentarily, or be stored fragmentarily and drawn wholly for convenience of customer.



- A The freight transportation is quite busy here. They are going to...?

  B:The freight distribution business spun off by the bonded storage is growing fast in Waigaoqiao Free Trade Zone. By the end of 1998, there had registered 60 companies which are solely engaged in this business. Many multi-national companies have moved their freight distribution operation, part of the regional supply branch in the Asian-Pacific into Waigaoqiao Free Trade Zone. These goods will be distributed to both the domestic and overseas market both.



- What is the difference between Waigaoqiao Free Trade Zone and the non-free trade zone in term of the manufacturing and processing?
- Waigaoqiao Free Trade Zone provides a much more friendly environment for doing processing ,compared with the non-free trade zones.
  - One does not need to apply for import & export licenses and business licenses in order to undertake processing business in the zone.
  - The imported materials and components are exempted from tariff.
  - All the self-use imported equipments, raw materials and office appliances are exempted from tariff.
- After going through necessary import formalities, products can be sold into the domestic market according to re-export ratio. The customs will collect the duty according to ratio of raw material and components imported.
- The manufacturing enterprises in the Free Trade Zone can also engage themselves in international trade and bonded warehousing.


#### Information Technology Park 信息产业园区

- What are the major manufacturing sectors in the zone?
  In the context of globalization, many multinational corporations treat their facilities in Waigaoqiao as an important link in their global manufacturing and operation system. The export processing sector in Waigaoqiao Free Trade Zone now composes of two major industries:the info industry supported by HP, Intel, IBM, Philips, JVC and Pioneer Electronics, the mechanical and electrical industry brought about by Delphi, Eaton and FAG.
- The companies you mentioned are all the subsidiaries of multinational companies. However, and is the environment also friendly for small and medium-sized enterprises to engage in manufacturing and processing there?
- Actually, some small and medium-sized processing facilities in Waigaoqiao Free Trade Zone are doing very well by fully taking advantage of the policies which allow them to diversify their operation with one core business and operating in a flexible and versatile way. The small and medium-sized manufacturing enterprise can import and renew the equipment at any time, and adapt to the latest market demand. Meanwhile, they can also supply parts and components for bigger manufacturers.




- Is it possible for overseas investors to set up trading company in Waigaoqiao Free Trade Zone?
- Yes. Moreover, Waigaoqiao Free Trade Zone is the only place for the foreign investors to establish their trading companies in China according to the regulation of P. R. China. The operation scope of trading company registered in Free Trade Zone can be described like:
  - international trade
  - entrepot trade
  - trade within the Free Trade Zone, and trade consulting service related to trade
  - simple commercial processing
  - no restriction on the types of goods

The above-mentioned features are exclusive trade to Waigaoqiao Free Trade Zone. When the goods are sold into the domestic market outside the Zone, they are required to entrust an import & export company.
