SUNGARI CONDITIONS OF BUSINESS

These Conditions of Business are formulated in accordance with the relevant laws, rules, regulations of the People's Republic of China(PRC), and also in light of international practice. Buyers and Sellers are advised to read carefully the Conditions of Business and each clause contained herein, and be responsible for their actions while carrying out these Conditions. Sungari shall have the right to explain and resolve any special problems not mentioned in this document. Any disputes arising form or in connection with the performance of these Conditions shall, in accordance with laws of the PRC, be submitted to the courts or arbitration organizations of the PRC for final settlement.

A The Buver

1. Bidder and Buver

- a) A bidder shall be defined as a person who has been confirmed by Sungari to have completed the necessary registration procedures and based on such confirmation then has the right to bid at the auction.
- b) The buyer shall be the highest bidder confirmed by Sungari
- c) Every bidder shall be deemed to act as principal unless Sungari has, before the date of the auction, acknowledged in writing that the bidder is acting as agent on behalf of a disclosed principal.
- Every bidder shall based on suitable and obtain a bidding number before making any bid at the auction.
- e) In making a bid, the Bidder acknowledges the minimum increment offered by Sungari. Only Sungari on-site auctioneer has the right to adjust the increment.

2. Catalogue Descriptions

- a) Any representation or statement by Sungari whether in the catalogue or any other form of publication as to the authorship, origin, date, age, size, medium, attribution, ownership, genuineness, provenance, condition, estimated selling price or artistic value of any lot is a statement of opinion only. It does not represent any guarantee by Sungari, and is provided for the Buyer's reference only.
- b) If there is any difference in color, appearance or other characteristic, between an illustration and an original piece caused by photography and printing, reference should be made to the original.
- c) Prior to the date of the auction, the Buyer should carefully examine the Lot he intended to purchase, to determine its actual condition and should be legally responsible for any bid made.

3. Commission Bids

- a) Prospective Buyers are advised to attend the auction in person. In the event the Buyer is unable to do so, Sungari will accept the Buyer's written instruction to bid on their behalf,but neither Sungari nor its employees shall be liable to the Buyer for any neglect or default in so doing or for failure to do so.
- b) Prospective Buyers shall three days prior to the auc-

tion day, authorize Sungari to act as his agent by completing the Commission Bid Agreement and shall pay thirty percent of the maximum Estimated Price of the Lot to Sungari. The balance shall be paid within seven days of the successful bid. c) In the event that Sungari has received commission bids on a Lot for identical amounts and at the auction these commission bids are the highest bids for that Lot, the Lot shall be knocked down to the person whose commission

4. Premium

The Buyer who is successful in bidding for a Lot shall pay 12% of the Hammer Price as a Premium as well as Expenses to Sungari, and the Buyer also acknowledges Sungari's right to collect commission and Expenses from the Seller according to the Conditions. If the Buyer does not pay the premium and Expenses. Sungari shall be entitled to exercise a lien on the Lot of the Buyer.

5. Payment and Collection of Purchases

bid (for the relevant Lot) was received first.

- a) After a Lot has been sold, the Buyer shall pay the full amount on the spot and remove the Lot purchased(at the Buyer's expense), or the Buyer may pay thirty percent of the total amount as deposit, and the Buyer shall pay the balance in one payment and remove the Lot purchased within days from the date of sale. The Lot shall be considered unsold if after seven days payment has not been made and the deposit will not be refunded to the Buyer. In the event the Buyer refuses to pay for the balance the deposit also will not be refunded.
- b) All Payments shall be made in the currency indicated by Sungari. Payment by the Buyer in a currency other than that indicated by Sungari shall be converted at the market exchange rate announced by the State Administration of Foreign Exchange Control of the PRC on the last working day prior to the auction 4ay.
- c) The Buyer shall be responsible for any removal, storage and or other charges on any Lot not removed within seven working days from the date of the auction, and the company shall bear no re-ponsibility for any resulting consequences.
- d) Any packing and handing of purchased Lots by Sungan's employees are undertaken solely as a free service to Buyers, and will only be undertaken at Sungan's discretion. Buyer will be responsible for any losses which occur. Sungan's shall not be liable in any event for any damage to glass or frames, irrespective of cause. In addition, Sungan's shall not be liable for any errors or omissions or damage caused by packers and shippers that Sungan's has recommended to Buyers.
- e) If a Buyer fails either to pay for or to remove any Lot by the time stipulated, Sungari has shall have the right to exercise the following remedies:
 - To take legal action against the Buyer for all losses suffers due to the breach of contract, including interest loss on the Purchases Price due to the Buyer's delay in Payment or refusal to make payment. The interest charge shall be based on the rate published for the same period by the People's Bank of China.
- · To rescind or retain that or any other Lots sold to

- the Buyer at the same or any other auction, until the Buyer fulfills his stipulated obligations. All costs and expenses incurred in connection therewith, including storage, shall be borne by the Buyer.
- To resell the Lot by public auction or any other method. Any deficiency in the Purchase Price resulting from such resale together with full costs incurred in connection with the Lot shall be paid to Sungari by the Buver.
- Sungari shall be entitled to a lien on any property of the Buyer which is in Sungari's possession for any purpose.

6. Guarantee

- a) Any Lot which proves to be a "deliberate forgery" may be returned by the Buyer to Sungari within 35 days after the date of the auction. Sungari will set aside the sale and refund the Buyer, provided that the Buyer satisfies Sungari with respect to all of the following conditions:
- Sungari has receive notice in writing from the Buyer stating that in his view the Lot is a Forgery;
- Within fourteen days of receipt of such notice, Sungari has the Lot in its possession in the same condition as at the date of auction;
- Within a reasonable time thereafter, the Buyer satisfies Sungari that the Lot is a Forgery;
- The Buyer has since the sale retained uninterrupted ownership of the Lot and the Lot is free from any liens or encumbrances.
- Documentation can be provided that the Lot was Last sold by Sungari.
- b) The Buyer shall have no rights under any one of the following conditions, to require Sungari to set aside the sale:
- The catalogue description at the date of the auction was in accordance with the then generally accepted opinion of scholars or experts or fairly indicated there to be a conflict of such opinion;
- 2) It can be established that the Lot is a Forgery only by means of scientific process not generally accepted for use until after publication of the catalogue or by means of process which at the date of the auction was unreasonably expensive or impractical or likely to have caused damage to the Lot;
- The Buyer has transferred his ownership of the Lot and the original invoice is not available.

B The Seller

1. The Seller and Guarantee

- a) The Seller or the Trustor should enjoy indisputable ownership of the lot he entrusts Sungari to auction.
- The Seller shall compensate Sungari and the Buyer for all losses arising form dispute over the ownership of the lot.
- c) When a Seller entrusts Sungari with the sale of an artwork through auction, the Seller must possess suitable personal identification as well as documentation of the work to be auctioned. The Seller shall also provide a letter of authorization and sign an agent agreement with Sungari.
 d) When a Seller brings a work of art into China for auction by Sungari, which the government of the PRC precludes from export, the Seller must obtain documentation from the Customs of the PRC, for such import to be valid.

2. Sungari shall have absolute discretion as to:

- To decide whether the Lot is Suitable for sale by Sungari, and if so as to the place and date of sale, the conditions of sale and the mannner in which such sale is conducted;
- To provide any explanations or make any appraisals of any Lot in the catalogue or by mass media;
- c) Whether the views of any expert shall be obtained;
- d) Sungari reserves the right to withdraw any Lot or alter the Reserve at any time prior to the actual sale if, in its sole judgment, Sungari has doubts as to the provenance of the Lot or suspects that the Lot may be a Forgery or upon the Seller violating any clause of these Conditions.

3. Commission and Expenses

- a) Except as otherwise provided in an agreement between the Seller and Sungari, the Seller shall pay 10% of the Hammer Price as commission. Insurance shall be calculated at 1% of the Hammer Price.
- b) Where a Lot involves the auction of cultural of historical relics, a fee shall also be charged, according to the standards of the government department of Cultural Relics, for performing authentication of the sealing wax.
- c) If bids for a Lot fail to reach the Reserve, the Seller hereby agrees to pay 3% of the Reserve to Sungari as service charges in addition to other Expenses incurred.

4. Insurance

- a) Unless otherwise instructed by the Seller, all Lots will automatically be insured by Sungari for such sum as Sungari shall from time to time in its absolute discretion estimate. The validity of the insurance period shall continue up to the day on which the total purchase price is paid in full by the Buyer.
- b) The Seller shall pay an insurance fee equal to 1% of the Hammer price. If the Lot fail to sell, the Seller shall pay 1% of the Reserve.
- c) If the Seller instructs Sungari in writing not to insure a Lot, all risks and responsibility shall be borne by the Seller. Sungari shall bear no responsibility for any and all losses which occur in such event.
- d) Sungari accepts no responsibility for damage caused by woodworm or by changes in atmospheric conditions and Sungari shall not be liable for such damage nor for any othe damage to the stand, picture frames or to glass in picture frames. Damages to the Lot caused by other reason and any claim resulting therein shall be handled in accordance with the relevant laws and regulations of the PRC. In the event of a successful insurance claim, Sungari shall after deducting its expenses refind the balance to the Seller.

5. Payment of Sale Proceeds

- a) If the Buyer paid in full the total purchase price and has not raised any dispute with Sungari, within 35 days of the date of sale, Sungari shall make payment in Remuinbi Yuan of the sale proceeds to the Seller. Sungari reserves the right in its sole discretion to accept payment from the Buyer in any other currency, with no obligations to the seller.
- b) If Sungari has still not received the full purchase price from the Buyer on the date of payment, then payment of sale proceeds shall be made within seven days from the

date on which Sungari receive full payment at the purchase price from the Buyer.

 c) If Sungari pays the Seller an amount equal to the sale proceeds prior to receiving full payment of the purchase price from the Buyer, then the ownership of the Lot shall pass to Sungari.
 d) The Seller shall be solely responsible for the payment of taxes owing on the sale proceeds.

6. Collection of the Purchase Price

a) If the Buyer fails to pay to Sungari the Purchase Price within 35 days of the date of sale, Sungari will endeavor to take the Seller's instructions in determining the appropriate course of action to be taken and, so far as in Sungari opinions is practicable, will assist the Seller to collect the Purchase Price from the Buyer save that Sungari shall not be obliged to sue-against the Buyer in its own name.

b) Sungari reserves the right and is hereby authorized at the Seller's expense, and in each case at Sungari absolute discretion, to agree to special terms for payment of the Purchase Price, to remove store and insure the Lot sold, to settle claims made by Seller against the Buyer on such terms as Sungari shall think fit, to take such steps as are necessary to collect money due from the Buyer to the Seller.

7. Charges for Withdrawn Lots

The seller may withdraw a Lot at any time prilor to the auction but, once the printing of the catalogue or any other publication including the Lot has begun, a charge of 20% of the insurance value of the Lot as determined by Sungari and other expenses shall become payable.

8. Unsold Lots

a) Lots unsold by auction must be collected at the Seller's expense within a period of two months from the day of receipt by the Seller of notice from Sungari requiring collection of the Lot. Upon the expiry of such period Sungari shall have the right to sell such Lots by public or private sale and on such terms as it thinks fit and to deduct from the Proceeds of Sale any commission or other expenses owing to Sungari. Any remainder shall then be paid to the Seller.

b) In the event the Seller fails to remove the Lot within two months, the Seller shall be liable for all accidents occurring thereafter. If Sungari is requested by the Seller to assist in returning the Lot, the Lot shall be returned at the Seller's own risk and expense and shall not be insured in transit unless Sungari is specifically instructed otherwise by the Seller who shall then pay the insurance premium.

C Other Rights and Obligations

- Sungari as agent for the Seller and buyer is not responsible for any default by the Seller or the Buyer.
- Sungari has at its absolute discretion the right to refuse any bid, to advance the bidding as it may decide, to withdraw or divide any Lot, to combine any two or more Lots and in the case of dispute to put up any Lot for auction again.
- Sungari has the responsibility to call to the Buyer's attention any flaw in a Lot, to request such person to examine the original and determine his act in auction

- activities on his own accord.
- Sungari has the right to discuss the Reserve with the Seller, to decide the currency applying at the auction, the form of the auction, and the amount of increment.
- Sungari shall be obliged to maintain contidence with respect to both the Buyer and the Seller and to protect the rights and interests of the Buyer, the Seller and Sungari from infringement in accordance with the laws of the People's Republic of China and these Conditions.
- Sungari has the responsibility to indicate clearly that
 the circulation of certain Lots is restricted to within
 the boundaries of the PRC, in according with China's
 relevant laws and regulations concerning cultural and
 historical relies.

D Definitions

In these Conditions, the following terms shall bear the meaning ascribed to them as set forth below:

- Sungari means Sungari International Auction Company, Ltd.
- Expenses shall mean costs for insurance, illustration,au thentication of the sealing wax of cultural and historical relics, freight and other expenses charged by Sungari.
- Hammer Price shall mean the price at which a Lot is knocked down by the auctioneer to the Buyer.
- Reserve shall mean the lowest price at which a Lot may be sold as determined by Sungari, in consultation with the Seller and as indicated in the agent agreement.
- Estimated Price shall mean the estimated selling price of each Lot printed beneath the Lot description. The Estimated Price is determined by Sungari and is subiest to revision.
- Premium and Commission shall mean the agent costs paid to Sungari by Buyer and Seller respectively.
- Purchase Price shall mean the Hammer Price, plus the Premium, any fines incurred by the Buyer through failure to fulfill their obligations and any other expenses.
- Proceeds of Sale shall mean the net amount due to the Seller being the Hammer Price less Commission and other Expenses.
- Notice shall mean notice in writing and if given by post shall be deemed to have been received by the receiver in the ordinary course of post.

Note: These Conditions of Business are written in Chinese and English. If there are any discrepancies between two versions, the Chinese version shall be taken.
