Most lawyers practicing today took a required course in Legal Ethics while in law school, followed by a specific bar examination on that same subject. It was not always so. When I started teaching, my law school did not even offer the course. In those days, it was easy for law students to learn the Golden Rule: Thou shalt not lie, cheat, steal, . . . or advertise.

Times have changed. The emphasis on legal ethics began in 1974 as part of what Spiro Agnew then referred to as our "post-Watergate morality." I started teaching legal ethics because the Dean knew I was the new boy on the block, and had been a lawyer for the Senate Watergate Committee.

Some people think that ethics can be taught only at mother's knee. It's a little more complicated than that. Those who think of ethics as intuition are often the same people whom courts routinely disqualify because they do not appreciate the complexities of the rules of conflicts of interest. Many lawyers today are, for instance, ignorant of recent developments regarding conflicts of interest and attorney disqualification. Several years ago, one of my former academic colleagues, who also practiced law, said she did not buy malpractice insurance because her contract with her clients required them

to waive their malpractice claims. Her listeners nodded knowingly, oblivious to the fact that her standard waiver agreement violated state ethics rules, was not enforceable, and could cause her to lose her license.

One need not rely on anecdotal analysis. The few existing empirical studies show that many lawyers often are unaware of basic information about the law governing the practice of law. Consequently, many malpractice suits arise out of violations of professional ethics. In recent years, several major law firms have settled for substantial sums various malpractice claims based on ethical violations, and several criminal actions have brought into focus the role of lawyers.

What we call "lawyer's ethics" is real "law" in the same way that the Rules of Civil Procedure are law. These ethics rules are not mere advice. Instead, they impose substantive requirements on lawyers and judges and are just as complex as the rules of civil practice or the rules of evidence. Many ethics rules cannot be known through some sort of innate awareness nor are they automatically infused into ordinary human beings once they are admitted to the bar.

This Nutshell is intended to offer an initiation to this complex topic. Because the American Bar Association has been the undisputed leader in developing ethics rules, this book is organized around the ABA Model Rules of Professional Conduct. Almost all jurisdictions base their ethics rules on this ABA product. Even when a jurisdiction, such as Califor-

nia, uses a different format, the substantive rules reflect the substantial ABA influence.

In addition to the ABA Model Rules, each jurisdiction has its own rules, which are derived from the ABA Rules but often with non-uniform amendments. There is also case law, the commentators, and influential advisory ethics opinions of various bar associations and the ABA Ethics Committee. In addition, the American Law Institute's Restatement of the Law Governing Lawyers, Third, has been an important and helpful tool. I will refer to all of these sources but, given the limited nature of a Nutshell, I am limited in discussing them in detail. For that, one should turn to other secondary sources such as (please forgive the shameless selfpromotion): Rotunda & Dzienkowski, Legal Ethics: The Lawver's Deskbook on Professional Responsibility (ABA & Thomson West, 2012 ed., updated yearly) (a treatise on legal ethics, published jointly by the ABA & Thomson West Publishing), or, Rotunda & Dzienkowski, Professional Responsibility: A Student's Guide (ABA & Thomson West, 2012 ed., updated yearly) or Rotunda, Professional Responsibility (Thomson West, 9th ed., 2011) (Black Letter series). Finally, do not forget that ethical lawyering goes well beyond the four corners of the ABA rules: the kind of lawyer you are affects, and is affected by, the kind of person you are.

In completing this new edition, I am thankful for the help I have received from Travis M. Casey, J.D., 2013 and Jacob Cole Genzuk, J.D., 2012, and Maria Sanchez, my faculty assistant.

If I might miss something here or there, please bear in mind the words of Judge Henry de Bracton, who beseeched over 750 years ago: "I ask the reader, if he finds in this work anything superfluous or erroneous, to correct and amend it, or pass it over with eyes half closed, for to keep all in mind and err in nothing is divine rather than human."
