The last seven years since the Eighth edition of this book have seen wholesale change and reform in virtually every aspect of the legal system. The aim of the book remains unchanged: to provide an accessible and relatively concise exposition of the main principles, rules, and issues. In writing this new edition we have sought, within the constraints of length, to reflect the areas and emphasis that we have found from our own experience to be important to the modern generation of students.
