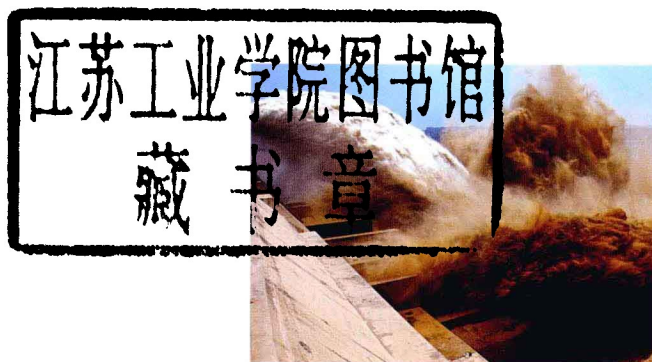

This book is composed of three parts: Overview, Part One and Part Two. The Overview talks about the goal of maintaining the healthy life of the Yellow River and the ways of reaching the goal based on the characteristics of the Yellow River, current situation and challenges in coming future. In Part One, the author studies the problems of each reach from headwaters to estuary of the Yellow River. In Part Two, the author analyzes the issues of management and protection of water resources, development of water and sediment regulation system, west route of the South-North Water Transfer Project, water right regime and basin ecological compensation mechanism, from the perspective of the Yellow River basin management.
