Preface

This book was compiled in order to enable professionals to establish an international perspective on the **legal liability of hospitals**. Chapter 4 deals with a general discussion of the legal grounds of hospital liability, and presents an invaluable *Comparative Diagram*. In Chapters 5–9, every individual consecutive chapter on hospital liability of the above-mentioned countries is introduced by a short discussion of their unique health care systems and hospitals. Thereafter, from every legal system's unique perspective, legal principles, doctrines and legal grounds for the liability of hospitals are identified with full reference to their case law. Chapter 10 and the *Summary* conclude the book.

The book covers a wide range of topics: health care; health care systems; hospitals (state and private); hospital companies; the hospital industry; the history of hospitals; medicine and medical law. This wide range of subjects will be of benefit to a large range of legal and medical professionals.

In toto, it will be useful to all lawyers and all those involved in the medico-legal profession to be able to consult an international reference on the legal liability of hospitals. It could facilitate court proceedings and proposed legislative interventions and could also assist the establishment of a concise hospital liability law worldwide.
