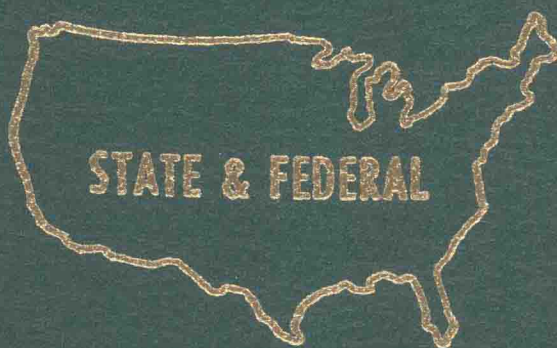

FOREWORD

Much has changed in bankruptcy law in the years since the earlier Am Jur 2d article on Bankruptcy was published at the time the Bankruptcy Reform Act of 1978 replaced the Bankruptcy Act of 1898. In 1982, the United States Supreme Court held the broad grant of jurisdiction provided to bankruptcy judges by the Reform Act to violate Article III of the Constitution. The Bankruptcy Amendments and Federal Judgeship Act of 1984 which responded to this ruling by creating a revised jurisdictional structure also made a number of changes in substantive bankruptcy law. New Bankruptcy Rules took effect on August 1, 1983, superseding the Bankruptcy Rules promulgated for practice under the 1898 Act. Additional changes in bankruptcy law resulted from various other legislation, including the Bankruptcy Judges, United States Trustees, and Family Farmer Act of 1986 which provided, among other things, for the creation of a permanent and nationwide United States trustee program and a new Bankruptcy Code Chapter 12 dealing with the adjustment of debts of family farmers. The new article on Bankruptcy addresses not only such statutory and rules changes but examines in detail the construction and application of bankruptcy law by the courts. Further amendments to go into effect August 1991 are also noted.

The Bankruptcy article has been enhanced by the inclusion of *Observations, Cautions, Practice guides, Checklists, Illustrations*, and the like which show practical applications and effects of legal principles.

A **Table of Statutes and Rules Cited**, a **Table of Parallel References**, and an **Index** covering all of the above topics will be found in Volumes 9, 9A, 9B.
