

PREFACE

As long ago as 355 B.C. Demosthenes argued that 'the laws forbid the same man to be tried twice on the same issue'. Similar pleas have been made countless times since then; and, no doubt, Demosthenes was not the first to argue the rule against double jeopardy. This study attempts to provide a coherent analysis of the concept of double jeopardy, with particular emphasis on English law.

In the course of preparing this study, which is based upon my doctoral dissertation for Cambridge University, I have been expertly guided and warmly encouraged by Professor Glanville Williams, to whom I owe my greatest debt of thanks. I have also profited greatly by discussion with other faculty members at Cambridge University and with my colleagues at the University of Toronto and my former colleagues at Osgoode Hall Law School.
