PREFACE

IN the selection and arrangement of materials for this casebook, the editor has been guided chiefly by what might be called the practical viewpoint. He has endeavored to give a realistic picture of the jurisdiction and actual functioning of the federal courts. This does not mean, however, that the historical and political approaches have been overlooked.

Due emphasis has been laid on the interrelations of state and federal courts. Many important and fascinating problems lie in that sometimes dim borderland between these two jurisdictions. One entire chapter has been devoted to this subject, and it has been constantly kept in view all through the book.

No previous knowledge of the jurisdiction and procedure of the federal courts has been presumed. Yet the editor has taken it for granted that the student is fairly familiar with the outstanding subjects which are included in the curriculum of the first two years in a modern law school. The editor believes that courses in federal jurisdiction and procedure should be postponed in law school courses, if possible, until the third year.

Specialties, such as patents and copyrights, are completely omitted. Bankruptcy is treated only in connection with the distinctive appellate jurisdiction of the Circuit Court of Appeals in this field. A few cases are given to indicate the nature, basis, and extent of the federal jurisdiction in admiralty. No cases are given dealing with criminal procedure in the federal courts. Federal appellate procedure is stressed only from the standpoints of the method and scope of appellate review. So anomalous, so difficult; and so important, however, is the procedure by which cases are removed from state to federal courts, that this subject is treated in detail and at some length.

A number of extracts from the editor's textbook on federal jurisdiction and procedure have been included in this casebook. These extracts are quite numerous in the first chapter. The editor believes that the student beginning the reading of cases in the field covered by this casebook will be quite perplexed without some elementary knowledge of the nature and organization of the federal judicial system. It did not seem fair to impose the burden of supplying this knowledge upon the instructor; it did not seem wise to take the chance that in some haphazard fashion the student might himself acquire this knowledge on the outside. After the first chapter, these extracts are for the most part summaries for the purpose of orientation. Case-hardened instructors can, of course, merely call these extracts to the student's attention and then omit them from discussion in the classroom.

PREFACE

Many of the opinions have been rather rigidly edited. This saves space and permits the inclusion of a larger number of cases. Omissions are always indicated by asterisks, which obviates the necessity of frequent notes stating that part of the opinion has been omitted. When a case dealt with different and disassociated topics, the editor has not hesitated to split the opinion and to set out, under the appropriate topic, that part of the opinion dealing with such topic. Quite a few dissenting opinions are included—sometimes with the majority opinion, and, in a few instances, alone, without the majority opinion. This has always been duly indicated.

The attention of both student and instructor is specially directed to the notes. These are numerous, sometimes quite elaborate, and varied in character. Some notes give information on topics which, for lack of space, are not treated in the cases included in the text; some cite cases in agreement with, or opposed to, the instant case in the text; others, usually with a brief reference to the precise point involved, qualify or restrict the doctrine of the text case or raise problems which this doctrine involves. Quite numerous are the references to articles and notes in law reviews; for here, in the editor's opinion, will be found the best writing done on the subject of federal jurisdiction and procedure. Particularly helpful, it is hoped, are references to notes in the law reviews discussing the cases included in the text. The editor, in the preparation of the notes, has searched both the files and the indexes of more than fifty of the leading American law reviews.

This editor gratefully acknowledges his indebtedness to editors of casebooks in this field, to writers of textbooks, and to authors who in law reviews have written both leading articles and notes. Particularly deep is his obligation to Professor Medina, editor of the previous casebook on Federal Jurisdiction and Procedure in the American Casebook Series. Full responsibility for the present casebook, however, rests solely upon the editor.

Provisions of the Federal Constitution and statutes that are deemed important by the editor are set out in the text and in the cases dealing with these provisions. There is accordingly no appendix. It is believed that, by means of the table of contents and the index, little trouble should be experienced in finding any particular provision of this Constitution or these statutes.
