FOREWORD

The very substantial body of new law affecting major topics appearing in Volume 32 of Am Jur 2d, or within its alphabetical scope, compels its rewriting and reissuance in three replacement volumes, 32, 32A, and 32B.

Thus, the enhanced role of the federal courts and the vast number of rules and cases generated since the original publication of Volume 32 of Am Jur 2d in 1967 has necessitated the complete reorganization and rewriting of the article Federal Practice and Procedure, a much expanded article in keeping with the heightened importance of the subject.

The Federal Rules of Evidence, together with the substantial body of case law which has been generated under these rules, are now discussed, in detail, in an entirely new article in Volume 32B of Am Jur 2d, and will replace the earlier treatment in a separate New Topic Service volume.

With respect to False Imprisonment, efforts of proprietors of retail establishments to reduce losses from shoplifting have led to increased customer detentions, giving rise to a larger number of actions for false imprisonment. Some legislatures have responded by the enactment of statutes limiting liability of proprietors upon compliance therewith. The new article, appearing in Volume 32 of Am Jur 2d, includes an expanded discussion of these statutes and the current case law generated thereby.

Repeal of the Miller-Tydings Act (15 USCS § 1) and the McGuire Act (15 USCS § 45) since the original publication of Volume 32 of Am Jur 2d in 1967 has rendered state fair trade laws largely obsolete, and the relatively short article on this subject, appearing in new Volume 32 of Am Jur 2d, reflects this important change in the law.

The large number of cases construing Federal Employers' Liability and Compensation Acts which have been decided since 1967 requires a current treatment of this important topic.

The other topics in original Volume 32 have also been completely re-searched and rewritten.
