



## Preface

There have been considerable developments in administrative law over the last four years. There has been legislation on a range of matters pertaining to administrative law. The important statutes include the Parliamentary Standards Act 2009, Constitutional Reform and Governance Act 2010, Local Government Act 2010, Equality Act 2010, Public Bodies Act 2011 and Localism Act 2011. The courts have continued to be active and there have been many significant new judicial decisions. Case law is discussed and analysed in detail, important examples being *AF/Tariq*, *Al Rawi*, *Quila*, *Croydon and Cart*. The Human Rights Act 1998 has, not surprisingly, generated a large amount of case law, as the courts have grappled with many of the key issues under this new statute. There has been much interesting secondary literature.

There is one new chapter in this edition. It addresses the problems of natural justice in the context of cases concerned with national security. There has been much case law on this topic and the government looks set to introduce legislation that raises important points of principle concerning the hearing that is available in this type of case.

I have sought to incorporate all these changes, and to give a balanced account of the subject, which will be of equal use to those who are interested in the administrative system and those whose primary interest lies in judicial review. All chapters of the book have been revised to take account of the new developments, and several chapters have been substantially re-written. The format of the chapters has been modified by the inclusion of a section on central issues at the beginning of each chapter, which provides a structured overview of the principal points raised in each chapter.

I would like to thank Nicola Thurlow, Sally Rea and all those at Sweet & Maxwell who have provided great support in the production process with the book. I would also like to thank Anita and Ciaran for their help and understanding when work on the book impinged on family time.
