

Preface to the Second Edition

The object of this HANDBOOK is the provision of a series of study notes, progress tests and other material, designed for those who are studying trusts for the first time and for those who are planning an intensive revision scheme prior to their first professional examinations in the subject. The text is not intended in any way as a replacement for any one of the standard works (*see* Appendix I), a detailed study of which is essential for success in examinations; rather is it constructed as a guide and a supplement.

The subject has been approached through the vast literature of the cases; this accounts for the large number of references which, it is hoped, will guide the student to a close examination of the way in which judicial decisions have shaped the concept of the trust.

Those who intend to use the text as the basis of a planned study scheme are advised to consider the following plan, based on *three readings*.

The first reading should be designed to give an overall pattern of the terrain to be traversed. A *swift reading* is recommended so as to obtain a general picture of the subject-matter.

The second reading is the principal feature of this plan of work. Each chapter must be read slowly, very carefully and with *attention given to detail*. Case references and extracts from the reports are intended to illustrate the principles underlying the law and should be studied as such. Definitions should be analysed, principles and their supporting illustrations should be comprehended and committed to memory. Above all, the inter-relationship of principles should be observed. The progress tests at the end of each chapter should be attempted and the answers should be checked against the text.

The third reading should be in the nature of a *swift revision*, with attention focused on principles, cases and statutes. The three specimen test papers forming Appendix III should be attempted under examination conditions.

I have endeavoured in this second edition to state the law as it was on *January 1st, 1980*. Some additional material was added at proof-reading stage. The Table of Cases has been brought up to date and the bibliography has been expanded. The opening chapter of the text has been revised and material relating to the Variation of Trusts Act 1958 has been rewritten. The effect of recent decisions of the courts has been noted at appropriate points in the texts. Some other changes to the text have been made as the result of valuable and constructive criticisms by readers of the first edition.
