

# PREFACE

---

The writing of this book stems from a desire on my part to write a text based upon many years of experience teaching the law of contract at degree level. I do so fully conscious of the fact that there are already many excellent books on the topic, some of them being of great authority. But some of these works are, in my view, too detailed for the needs of the typical undergraduate or conversion course student who will be looking for a text that covers the fundamentals of the subject in a straightforward way, and which is not excessively technical or theoretical. At the same time, they will require a work that approaches the law in a critical manner with an eye to its future development.

I have placed some emphasis on a discussion of the case law in contract. Not only is this a rich source of learning on the subject but it enables the novice student to acquire a grasp of the case law method that is one of the basic tools of the lawyer. The statutory and regulatory law that is becoming increasingly prominent in contract is also analysed in depth. Given that readers are likely to be new to the law, whether law students or, for example, business students, I have included a glossary of some of the more commonly encountered technical (and not so technical) legal terms in contract. At the end of each chapter, I have indicated further reading which I hope readers may find beneficial and of interest.

With regard to the coverage of the book, I have tried to concentrate on those topics which are common to the majority of degree courses on contract and those which, from my own experience, I know students find challenging. The familiar contours of the subject have changed in recent years not only because of the growing significance of European Union law but also as a result of a number of important decisions of the Court of Appeal and House of Lords. I have attempted to give due prominence to these developments. In dealing with case law in this book, for the sake of consistency I use the term "claimant" to refer to the party bringing proceedings whether the case was decided before or after the introduction of the Civil Procedure Rules. As readers may be aware, the rules substituted the expression "claimant" for "plaintiff".

I would like to express my thanks to the many people who have helped me in one way or another in the preparation of this book, especially the publishing team at Sweet and Maxwell. Writing a book is a deeply anti-social activity and the greatest debt of gratitude is owed to my wife, Jenny, who has endured this (and other publishing ventures) with much greater tolerance and understanding than I have any right to expect! I would like to dedicate the book to my father, John M Duxbury, who was recently commended by the Solicitors' Regulation Authority for being admitted to the roll of solicitors for over 70 years.

# GLOSSARY

---

**Anticipatory breach** A breach of contract occurring before performance is due where one party indicates to the other that they do not intend to perform their obligations under the contract. In such circumstances the innocent party has the right to “accept” the breach and sue for damages immediately or await the date of performance and hold the other party to the contract.

**Appellant** A party who appeals to a superior court with jurisdiction to hear appeals such as the Court of Appeal or House of Lords.

**Bailment** The transfer of possession, but not ownership, of goods from the owner (the “bailor”) to another party (the “bailee”) for a specific purpose, such as in a contract of hire or where goods are delivered for repair. Bailment may be contractual (a “bailment for reward”) or purely gratuitous such as where goods are lent to a friend.

**Bill of exchange** A bill of exchange is a form of “negotiable instrument” (see below). Such bills are defined by the Bills of Exchange Act 1882, s.3 as “an unconditional order in writing, addressed by one person [the ‘drawer’] to another [the ‘drawee’], signed by the person giving it, requiring the person to whom it is addressed to pay on demand or at a fixed and determinable future time a sum certain in money to or to the order of a specified person [the ‘payee’], or to bearer.” Bills of exchange facilitate the transfer of an enforceable right to a sum of money from one person to another; they are also “negotiable” in that where the bill is transferred to a party who takes in good faith and for value (a “holder in due course”) they take free of any defect in title of the transferor. A cheque is a bill of exchange drawn on a bank.

**Bill of lading** A document effecting the transfer of title of goods shipped by sea, under which the master of the ship undertakes to deliver the goods of the shipper (“consignor”) to a party named in it (usually the “consignee”), on payment of freight. A bill of lading also embodies the terms of the contract of carriage and acts as a receipt for the goods from the master to the consignor. Although transferable by endorsement and delivery, a bill of lading is not a negotiable instrument, so that the transferee receives no better title than the transferor. The relevant law is contained in the Carriage of Goods by Sea Acts.

**Charterparty** A written contract for the hire of a ship by the hirer (the “charterer”) from the shipowner. The hiring may either be for a particular voyage (a “voyage charter”) or for a specified period of time (a “time charter”) and the usual purpose of the hire is for the carriage

of goods. Normally the shipowner retains possession and control of the ship subject to the charterer's instruction but in a "charterparty by way of demise" the contract operates as a lease with the charterer becoming for the time being shipowner.

**c.i.f.** ("Cost, insurance, freight") A type of contract for the sale of goods overseas where the seller takes responsibility for shipment by entering into a contract of carriage by sea. The seller must ensure delivery of the goods at the port of destination and insure the goods whilst in transit for the benefit of the buyer. The seller must deliver up an invoice, the bill of lading (see above) and the insurance policy. The buyer must accept the documents and pay the price on delivery. The goods are usually at the buyer's risk as from shipment. (Cf "f.o.b." below).

**Claimant, plaintiff** The party bringing civil proceedings, e.g. for breach of contract.

**Constructive notice** Knowledge that is imputed to a person even if they are ignorant of the actual facts, where the circumstances are such that a person of ordinary prudence would have discovered the facts.

**Contra proferentem** A rule of construction that any ambiguities in a document are construed narrowly against the drafter, commonly applied in the construction of exclusion and limitation clauses.

**Conversion** The tort of wrongfully dealing with another person's goods, i.e. in a manner inconsistent with the rights of the owner.

**Counterclaim** A claim in civil proceedings raised by a defendant against a claimant in response to that party's claim.

**Damages** A sum of money awarded by a court to compensate the claimant for loss or damage, e.g. as a result of a breach of contract. As a general rule, damages in contract are designed to put the innocent party in the position they would be in had the contract been properly performed.

**Defendant** The party against whom civil (or criminal) proceedings are brought.

**Del credere agent** An agent instructed to sell goods on behalf of a principal who guarantees that the principal will receive all moneys due from the buyer, usually in return for a higher commission.

**Demurrage** A liquidated sum payable to the charterer where a ship is detained in port beyond the number of days specified in the charterparty ("lay days").

**Estoppel** A rule of evidence that prevents a person from denying the truth of a statement they have made and upon which another has relied. It is usually a requirement that the person relying on the statement has altered their position on the faith of the statement.

**f.o.b** ("Free on board") A type of contract for the sale of goods overseas where, in the classic case, it is the seller's duty to see that the goods are on loaded on board ship, whereas it is the

buyer's responsibility to arrange for the shipping of the goods and to insure them. The risk normally passes to the buyer when the goods are loaded on board ship. (Cf "c.i.f. above).

**Injunction** An order of the court either prohibiting a party from doing an act (a "prohibitory" injunction) or ordering a party to carry out an act (a "mandatory" injunction). As an equitable remedy, an injunction will only be granted at the discretion of the court and will not be granted if damages would be an adequate remedy. An "interim" injunction is one granted temporarily in an emergency.

**Laches** Unreasonable delay or neglect in bringing proceedings to enforce a right. It may operate to debar a claim. Where there is a statutory limitation period, however, a claim can be brought at any time up to the expiry of that period.

**Licence** In relation to land, a permission to enter or occupy land but which, unlike a lease, does not usually confer any estate or interest in the land or any right of exclusive possession. A licence may be contractual or gratuitous.

**Lien** A right to retain possession of the property of another person as security for the performance of an obligation by that other person. Thus a repairer of goods may retain them until paid by the owner and, in some circumstances, an unpaid seller of goods has a lien over them.

**Negotiable instrument** A document containing an obligation to pay a sum of money which upon delivery to another person gives that person the right to sue upon it in their own name. Providing the transferee takes bona fide and for value, they receive a good title, free of any defects affecting the transferor's title. It is this quality that is referred to as "negotiability". Negotiable instruments include bills of exchange and promissory notes.

**Promissory note** A signed document containing an unconditional promise by one person to pay a sum of money to (or to the order of) a specified person or the bearer (Bills of Exchange Act 1882, s.83). The note is either payable on demand or at some fixed or determinable future time. Promissory notes are negotiable instruments (see above). A bank note is effectively a promissory note issued by a bank promising to pay the bearer the sum of money specified on the note.

**Quantum meruit** An action on a quantum meruit ("as much as he deserves") may be brought to recover reasonable remuneration for work done and materials provided.

**Repudiation** An indication by words or conduct that a party does not intend to be bound by a contract.

**Rescission** The setting aside of a contract either by the court (or by one of the parties) e.g. for misrepresentation. The aim of rescission is to put the parties back in the position they were in before the contract.

**Respondent** The party against whom an appeal is brought in an appellate court.

**Restitution** A legal process whereby money or property is restored to the person entitled to possession of it, with the aim of preventing unjust enrichment.

**Set-off** The right to deduct money already owed from a claim. Thus if A owes B £1,000 and B brings an action to recover that sum, A may “set-off” an existing debt whereby B owes A £500, so that B recovers only £500.

**Specific performance** An order of the court compelling the performance of a contract. The remedy is something of an exception and will not be ordered where damages are an adequate remedy; it is an equitable remedy and at the discretion of the court.

**Strict liability** Liability without fault. Contractual liability is said to be strict in the sense that contract-breaker is liable for breach even though there may be no fault or negligence on his part.

**Tort** A civil wrong entitling the victim to redress, e.g. damages or an injunction, other than a wrong that is purely a breach of contract. The most commonly encountered tort is negligence.

**Ultra vires** (“Beyond the powers”) An ultra vires act is one outside the powers conferred upon the body exercising it, and therefore invalid. An example is a contract entered into by a local authority in excess of its statutory powers.

**Vitiating factor** A factor affecting the validity of a contract, such as misrepresentation; mistake; duress and undue influence; and illegality.

**Void contract** A contract that is void has no legal effect at all, for example where it is entered into under an operative mistake. The transaction is null and void from the beginning (“ab initio”).

**Voidable contract** A voidable contract does have legal effect, but one party may have the right to avoid it, for example, where they are the victim of an actionable misrepresentation by the other party. Thus the contract is valid until avoided.
