PREFACE

The Materials in this book have been collected with the general principles of law syllabuses for ONC/OND, certain professional examinations and the G.C.E. "A" and "O" level courses in mind.

The book will probably be used in conjunction with a text book, and for such use, it has been specifically designed to act as a companion volume to the Concise College Text on general principles of law. It may, however, be used as an independent source book and revision aid.

The relevant courses and text books cover court structure and procedure. These subjects do not readily lend themselves to a "source-book approach" and therefore have not been included. Emphasis has been placed on those subjects which the syllabuses emphasise: hence the chapters on contract and tort are by far the longest.
