Undoubtedly it is meant for the use of Bench, Bar and all those concerned with law, but I also took the care that this publication comes to the use and service of those having only basic knowledge of law or those commoners in the subject but having the aptitude of depth study in the matters as cencerned. Recent events in the country have made the people particularly those concerned with such subjects to repeatedly scratch their heads to have better first hand knowledge in depth about the matters relating to foreigners and citizenship. The first chapter of this book contains statutory interpretations and meanings of words, put to be in consonance with the specific requirements of the Acts, Rules, Orders etc. given in all the subsequent Chapters of the book. This I felt necessary to be exhaustive in all definitiveness. I hope my this endeavour shall come to the usefulness of my patrons. The Second Chapter is limited to the Citizenship Act and Rules etc., with exhaustive commentary and references to various decisions of the High Courts and the Supreme Court. The Third Chapter, similarly, is concerned with the Baggage Rules under the Customs Act and fourth Chapter contains Foreigners Act, Orders, Rules etc. In Chapter five I felt necessary to give the Foreign Jurisdiction Act, Foreign Marriage Act and other allied and concerned Act, Orders and Rules. Once I though, I should avoid it but on the next breath I decided against. Whether or not I wisely acted depends on the usefulness The next Chapter six confines to the Passport Acts and of the works. Rules etc. which also has been put to the great deal of exhaustiveness, there being two Acts concerned with the Passports, one of the year 1920 and the other of the year 1967. The chapter seven is armed with the Constitutional requirements with the aspect of citizenship and foreigners only, as concerned to in this publication I thought, I would be failing in

my sincere endeavours, if I omit to deal with the Constitutional aspects, since as Justice Iyer once remarked, 'Social justice is the signature tune of our Constitution and the little man in peril of losing his liberty is the consumer of Social Justice'. I also quoted, in the said Chapter, provisions from various other Statutes including taxation. The last Chapter eight contains the latest Acts and Orders of 1983 viz., Forcigners (Proof of Identity) Order, 1983, Emigration Act, 1983 and the Illegal Migrants (Determination by Tribunals) Act, 1983.

The idea of elucidating the propositions of laws have been given priorarity with the real and honest attempt in the field in order to engulf the requirements of study as concerned.

And this is all I could afford to conceive.

Attempts have been made to make every thing uptodate subject to limitations however, as I do not believe in making wild and futile claims, except to the fact that the attempts made are within the forewall of legalistic earnesity circumscribed with the factum of reasonableness. All errors and omissions, when advised will be gratefully acknowledged.
