PUBLISHER'S NOTE

In this volume the important topic of Labour and Services has been completed. For facility of reference the complete synopsis of all the 786 sub-topics under this head covered in Volumes 8, 9 and 10 have been given at pages IX to XLIV *infra*. The complete "Topic and Statute Guide" to the topic of Labour and Services has been given at page 499. It may be noted that the "Topic and Statute Guide" is only meant to provide additional references. It is not an index to the entire topic and therefore the different sub-divisions and headings in any sub-topic will be found under the sub-topic itself. So also the synopses of the important sub-topics have not been repeated here and must be consulted under the sub-topic itself. This guide provides such additional references to those digest notes which incidentally touch upon that matter and are included under other sub-topics. This guide is particularly useful for finding references to different Statutory Rules and Orders which have been dealt with under common sub-topics such as Appointment, Departmental Enquiry, Seniority and Promotion etc. It is also useful in tracing references to those minute aspects of this branch of law which have not been considered sufficiently important to be made a sub-topic. Moreover, the possibility of there being many more conceivable headings under which one may search for any ruling, the guide provides a clue to the sub-topic under which such aspect has been included in this Digest. For this reason, the guide should be consulted after going through the concerned sub-topic itself which can be located through the synopsis. This is advised for the additional reason that the cross-references given in the beginning of many of the sub-topics have not been repeated.

An addenda to this topic of "Labour and Services" has also been included (pp. 445 to 498) bringing the case-law covered up to March, 1979. Docket numbers given in brackets in the "Topic and Statute Guide" refer to digest notes included in this addenda.

Next volume of this Digest is expected to be released soon.
